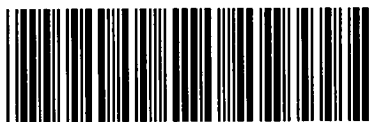

Respective responsibilities of Directors and auditors



1. ACCOUNTING POLICIES

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2015).

Turnover

Turnover represents the value of goods and services supplied during the year, excluding value added tax, which fall within the Company's ordinary activities.

Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

Deferred tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.

Foreign currencies

Assets and liabilities in foreign currencies are translated into sterling at the rates of exchange ruling at the balance sheet date. Transactions in foreign currencies are translated into sterling at the rate of exchange ruling at the date of transaction. Exchange differences are taken into account in arriving at the operating result.

Related party transactions

The results of the Company are included in the consolidated financial statements of Tappenden & Co Limited, which are available to the public from the Registrar of Companies, Companies House, Crown Way, Cardiff CFC 3UZ.

The Company has taken advantage of the exemptions conferred by the Financial Reporting Standards for Smaller Entities (effective January 2015). Transactions with other group companies which are eliminated in the consolidated financial statements of Tappenden & Co Limited are not disclosed for companies where the ultimate parent Company controls 100% of the voting rights.
