## TRUSTEES REPORT FOR THE YEAR 1st JULY 2012 - 30th JUNE 2013

I am pleased to present the Charity's Annual Report and Accounts.

Operations continue at a satisfactory level. The accounts show a deficit of £1,055 but this is wholly due to timings of creditor invoices at the year end. If the 2 years 2011-12 and 2012-13 are taken together, the Charity has more than broken even over the 2 years.

At the time of writing, the Charity's surplus for the current year is forecast to exceed £1000 and income levels are rising due to new counsellors taking up placements, together with an increased client caseload.

The Charity has a total of 11 counsellors practising at both the Hornsey and Twickenham Projects, together with a total caseload of 25 clients

I would, again, like to thank all counsellors and our clients for recognising and reacting positively to our needs.
