#### Tax

Following their appointment, the Joint Liquidators sought and received confirmation from HM Revenue and Customs ("HMRC") that the Companies had no outstanding corporation tax returns or liabilities, that HMRC would not raise enquiries into any pre of post liquidation periods and that it had no objection to the Joint Liquidators calling the final meetings of members to conclude the liquidations

HMRC have also confirmed that the Companies have no outstanding VAT liabilities

#### Creditors

The Companies had no known creditors. A notice to creditors to prove their claims in the liquidations was advertised in The London Gazette and The Times newspaper on 9 September 2014.

A claim for £404 was received from British Gas on CSM Limited although this was later withdrawn. The claim should not have been against CSM Limited and British Gas confirmed that they had made a mistake with the company name.

A potential claim for £217,000 was received from Lidolo Pty Limited c/o Keith Cleland on Hartley Computer UK Limited in respect of a loan account. Following correspondence with the Joint Liquidators, in which it was shown that the loan account appeared to have been settled at the time of the acquisition of Hartley International Limited by the Sage group, the deadline for claims expired and no formal claim was received from Lidolo Pty Limited

No other claims were received

#### Property

A search of the Index of Proprietors' Names at HM Land Registry (in both a Company spresent and former names) revealed no titles in any of the Companies' names
