PARTIES

(1) THE ANGEL FOUNDATION incorporated and registered in England and Wales with company number 03818138 and charity number 1079501 whose registered office is at 27 Burrington Way, Burrington Way, Plymouth, England PL5 3LR (Chargor);

- (2) MARY J. WILLETT of 3557 Kings Mill Road, North Branch, Michigan 48461; and
- (3) DON WILLETT of 3557 Kings Mill Road, North Branch, Michigan 48461;
 - ((2) and (3) collectively and jointly referred to as the Chargee).

BACKGROUND

- (A) On 8 April 2014 the Chargor entered into the Loan Agreement (as defined below) and the Existing Charge (as defined below) with the Chargee with such loan being secured against the property known as Drakes Hill Court, Burrington Way, Plymouth (the Property).
- (B) The Chargee now wishes to sell the Property but cannot repay the full monies due under the Loan Agreement.
- (C) The Chargee has agreed to release the Existing Charge in consideration of the taking of this charge to secure the remaining sums due under the Loan Agreement.

AGREED TERMS

1 Definitions and Interpretation

1.1 The following definitions apply in this charge:

favour of the Chargee in the form annexed in the Annex.

Charged Property the rights assigned in the Assignment and:

- (a) all Accruing Property save to the extent used to repay the Loan (in whole or in part);
- (b) all rights accruing or incidental to the Charged Property from time to time; and

(c) all interest and other income (not being Accruing Property);

arising out of, or accruing due in respect of, the Charged Property (and references to the Charged Property include references to all or any of the above property and rights).

Costs

all costs, charges, expenses and liabilities of any kind including, without limitation, costs and damages in connection with litigation, professional fees, disbursements and any value added tax charged on any such amount.

Encumbrance

any mortgage, charge (whether fixed or floating, legal or equitable), pledge, lien, assignment by way of security or other security interest securing any obligation of any person or any other agreement or arrangement having a similar effect.

Existing Charge

means the charge dated 8 April 2014 between the Chargor and the Chargee.

Loan

means the outstanding loan of \$ 1,095,706 advanced to the Chargor by the Chargee pursuant to the terms of the Loan Agreement.

Loan Agreement

the loan agreement dated 8 April 2014 between the Chargor and the Chargee.

Secured Liabilities

all present and future monies, obligations and liabilities owed by the Charger to the Chargee, whether actual or contingent and whether owed jointly or severally, as principal or surety and/or in any other capacity whatsoever, under or in connection with either or both of the Loan Agreement and this charge together with all interest accruing on such monies and liabilities.

Security Period

the period starting on the date of this charge and ending on the date on which all the Secured Liabilities have been unconditionally and irrevocably paid and discharged in full or waived in writing by the Chargee and no further Secured Liabilities are capable of being outstanding.

Warranties

the representations and warranties set out in Schedule 1.

- 1.2 The following rules of interpretation apply in this charge:
 - 1.2.1 Clause, schedule and paragraph headings shall not affect the interpretation of this charge.
 - 1.2.2 A reference to this charge (or any specified provision of it) shall be construed as a reference to this charge or that provision as amended, from time to time.

- 1.2.3 The schedules form part of this charge and shall have effect as if set out in it and any reference to this charge includes the schedules.
- 1.2.4 Words in the singular shall include the plural and vice versa.
- 1.2.5 A reference to a statute, statutory provision or subordinate legislation is a reference to it as it is in force for the time being, taking account of any amendment or extension, or re-enactment and includes any former statute, statutory provision or subordinate legislation which it amends or re-enacts.
- 1.2.6 A reference to writing or written includes faxes but not e-mail.
- 1.2.7 References to clauses and schedules are to the clauses and schedules of this charge; references to paragraphs are to paragraphs of the relevant schedule.

2 Covenant to Pay

The Chargor shall on demand pay to the Chargee and discharge the Secured Liabilities when they become due.

3 Grant of Security

As continuing security for the payment and discharge of the Secured Liabilities, the Chargor with full title guarantee charge to the Chargee, by way of first fixed legal charge, all present and future Charged Property.

4 Deposit of Title Documents

- 4.1 The Chargor shall:
 - 4.1.1 on the execution of this charge, deposit with the Chargee the executed Assignment relating to the Charged Property so that the Chargee may at any time after this charge has become enforceable without notice complete such; and
 - 4.1.2 on the accrual, or receipt of any Accruing Property or other rights accruing or incidental to any present or future Charged Property, deliver or pay or procure the delivery or payment to the Chargee in respect of such Accruing Property and other rights.
- 4.2 The Chargor shall not during the Security Period exercise any rights to nominate any person (other than the Chargee) to enjoy or exercise any rights relating to any of the Charged Property.
- 4.3 The Chargor shall, at the direction of the Chargee given at any time in accordance with this charge, forthwith execute and deliver to the Chargee all transfers and other documents, and do all such things, as may be necessary, desirable or requested by the Chargee:

4.3.1 to enable the Chargee, or any of its nominees, or any purchaser or transferee, to be registered (at Companies House or any other registrar) as the owner of, or

- otherwise obtain legal title to, or to perfect its security interest in all or any of the Charged Property; or
- 4.3.2 for creating, registering, perfecting, maintaining or protecting the security created by this charge; or
- 4.3.3 for creating a fixed charge over any of the Charged Property; or
- 4.3.4 to facilitate the realisation of all or any of the Charged Property after this charge has become enforceable or the exercise of any right, power or discretion vested in the Chargee or the Attorney in relation to any Charged Property or this charge.
- 4.4 By way of security the Chargor irrevocably appoints the Chargee to be his attorney (the Attorney) and in his name and on his behalf and as his act and deed:
 - 4.4.1 to execute any documents and do any acts and things which the Chargor is required to execute and do under this charge, including execute any document required by the Chargee under clause 4; and
 - 4.4.2 to execute any documents, and do any acts and things which the Attorney may deem proper or desirable in exercising any of the powers, authorities and discretions conferred by this charge or by law on the Chargee.
- 4.5 By this charge the Chargor ratifies and confirm and agrees to ratify and confirm anything, which the Attorney may do in the proper and lawful exercise or purported exercise of all or any of the powers, authorities and discretions referred to in this clause 4.

5 Liability of the Chargor

- 5.1 The liability of the Chargor under this charge in respect of any of the Secured Liabilities shall not be discharged, prejudiced or affected by:
 - 5.1.1 any Encumbrance, guarantee, indemnity, remedy or other right held by or available to the Chargee being or becoming wholly or partially illegal, void or unenforceable on any ground;
 - 5.1.2 the Chargee renewing, determining, varying or increasing any facility or other transaction in any manner or concurring in, accepting or varying any compromise, arrangement or settlement or omitting to claim or enforce payment from any other person; or
 - 5.1.3 any other act or omission which but for this provision might have discharged or otherwise prejudiced or affected the liability of the Chargor.
- 5.2 The Chargor waives any right he may have of requiring the Chargee to:
 - 5.2.1 enforce any security or other right; or
 - 5.2.2 claim any payment from or otherwise proceed against any other person;

before enforcing this charge against the Chargor.

6 Representations and Warrantles

The Warranties are made by the Chargor on the date of this charge and shall be deemed to be repeated on each day of the Security Period with reference to the facts and circumstances then existing.

7 Chargor's Covenants

The Chargor covenants with the Chargee during the continuance of the security constituted by this charge in the terms set out in Schedule 2.

8 Rights of the Chargee

- 8.1 The Chargee may at his discretion, in the name of the Charger or otherwise after this charge has become enforceable and without any consent or authority from the Chargor, exercise the following rights and powers in respect of the Charged Property:
 - 8.1.1 any voting rights and any powers or rights which may be exercised by a person in whose name the Charged Property are registered; and
 - 8.1.2 all the powers exercisable by a trustee in respect of securities or property subject to a trust.
- 8.2 After the security constituted by this charge has become enforceable:
 - 8.2.1 all dividends, interest and other distributions paid in respect of the Charged Property and received by or on behalf of the Chargor shall be held on trust for the Chargee and forthwith paid into an account designated by the Chargee or, if received by the Chargee, may be applied by the Chargee as though they were the proceeds of sale; and
 - 8.2.2 all voting and other rights and powers attaching to the Charged Property shall be exercised by, or at the direction of, the Chargee, and the Charger shall, and shall procure that its nominees shall, comply with any directions the Chargee may, in his absolute discretion, give concerning the exercise of those rights and powers.
- 8.3 The powers conferred on the Chargee by this charge are solely to protect their interests in the Charged Property and shall not impose any duty on the Chargee to exercise any of those powers.
- 8.4 The Chargee shall not, in respect of any of the Charged Property, have any duty or incur any liability for:
 - 8.4.1 ascertaining or taking action in respect of any calls, instalments, conversions, exchanges, maturities, tenders or other matters relating to any Charged Property or the nature or sufficiency of any payment whether or not the Chargee has or is deemed to have knowledge of such matters; or
 - 8.4.2 taking any necessary steps to preserve rights against prior parties or any other rights pertaining to any of the Charged Property.

8.5 The Chargee shall not be liable to account as a mortgagee in possession in respect of the Charged Property and shall not be liable in connection with the Charged Property for any loss on realisation of any nature whatsoever.

9 Powers of the Chargees

The Chargee shall have the powers set out in Schedule 3.

10 Enforcement

- 10.1 This charge shall be enforceable if any of the circumstances set out in paragraph 1 of Schedule 4 occur and on enforcement the further provisions of Schedule 4 shall apply.
- 10.2 At any time after this charge has become enforceable, the Chargee and any nominee of the Chargee may at his discretion (and without prejudice to any other right which the Chargee may have), without further notice to the Chargor:
 - 10.2.1 exercise the power to sell or otherwise dispose of the whole or any part of the Charged Property;
 - 10.2.2 complete the Assignment of some or all of the Charged Property.
- 10.3 Any sale or disposal under clause 10.2 may be made in such manner, on such terms and for such consideration (whether payable immediately or by instalments) as the Chargees shall in his absolute discretion think fit and without liability for loss.
- 10.4 The Chargee may (without prejudice to any right which it may have under any other provision of this charge) treat any part of the Charged Property consisting of money as if it were the proceeds of such a sale or other disposal.
- 10.5 Where the Chargee sells the whole or any part of the Charged Property the Chargee shall apply the proceeds (without prejudice to the right of the Chargee to recover any shortfall from the Charger) in or towards the satisfaction of the Secured Liabilities in such order as the Chargee in his absolute discretion may from time to time determine subject to the Chargee's rights under paragraph 5 of Schedule 4.

11 Costs and Indemnity

- 11.1 The Chargor shall pay to or reimburse the Chargee on demand, on a full indemnity basis, all Costs incurred by the Chargee in relation to:
 - 11.1.1 this charge or the Charged Property; or
 - 11.1.2 protecting, perfecting, preserving or enforcing (or attempting to do so) any of the Chargee's rights under this charge; or
 - 11.1.3 taking proceedings for, or recovering any of, the Secured Liabilities,

(including, without limitation, the Costs of any proceedings in relation to this charge, the Charged Property or the Secured Liabilities).

- 11.2 The Chargees and their employees and agents shall be indemnified on a full indemnity basis out of the Charged Property in respect of all actions, liabilities and Costs incurred or suffered in or as a result of:
 - 11.2.1 the exercise of any of the powers, authorities or discretions vested in him under this charge; and
 - any matter or thing done or omitted to be done in relation to the Charged Property under those powers.

12 Release

Subject to clause 13.3, upon the expiry of the Security Period (but not otherwise) the Chargee shall, at the request and cost of the Charger, take whatever action is necessary to release the Charged Property from the security constituted by this charge.

13 Further Provisions

- 13.1 This charge shall be in addition to, and independent of, every other Encumbrance or guarantee which the Chargee may at any time hold for any of the Secured Liabilities and no prior Encumbrance held by the Chargee over the whole or any part of the Charged Property shall merge in the security created by this charge.
- 13.2 This charge shall remain in full force and effect as a continuing security for the Secured Liabilities, notwithstanding any settlement of account or intermediate payment or other matter or thing whatsoever, unless and until the Chargee discharges this charge in writing.
- Any release, discharge or settlement between the Chargor and the Chargee shall be deemed conditional upon no payment or security received by the Chargee in respect of the Secured Liabilities being avoided or reduced or ordered to be refunded pursuant to any provision of any enactment relating to insolvency, bankruptcy, winding-up, administration or receivership and, notwithstanding any such release, discharge or settlement:
 - 13.3.1 the Chargee or his nominee shall be at liberty to retain this charge and the security created by this charge, including all certificates and documents relating to the whole or any part of the Charged Property, for such period as the Chargee shall deem necessary to provide the Chargee with security against any such avoidance or reduction or order for refund; and
 - 13.3.2 the Chargee shall be entitled to recover the value or amount of such security or payment from the Chargor subsequently as if such settlement, discharge or release had not occurred and the Chargor agrees with the Chargee accordingly and any liability under this clause 13.3 shall be secured by this charge.
- 13.4 A certificate or determination by the Chargee as to any amount for the time being due to it from the Chargor shall (in the absence of any manifest error) be conclusive evidence of the amount due.

- 13.5 The rights and powers of the Chargee conferred by this charge are cumulative, may be exercised as often as the Chargee considers appropriate and are in addition to its rights and powers under the general law.
- 13.6 Any waiver or variation of any right by the Chargee (whether arising under this charge or under the general law) is only effective if it is in writing and signed by the Chargee and applies only in the circumstances for which it was given and shall not prevent the Chargee from subsequently relying on the relevant provision.
- 13.7 No act or course of conduct or negotiation by or on behalf of the Chargee shall in any way preclude the Chargee from exercising any right or power under this charge or constitute a suspension or variation of any such right or power.
- 13.8 No delay or failure to exercise any right or power under this charge shall operate as a waiver.
- 13.9 No single or partial exercise of any right under this charge shall prevent any other or further exercise of that or any other such right.
- 13.10 The restriction on the right of consolidating mortgages contained in section 93 of the Law of Property Act 1925 shall not apply to this charge.
- 13.11 The invalidity, unenforceability or illegality of any provision (or part of a provision) of this charge under the laws of any jurisdiction shall not affect the validity, enforceability or legality of the other provisions.
- 13.12 This charge may be executed and delivered in any number of counterparts, each of which is an original and which together have the same effect as if each party had signed the same document.
- 13.13 A third party (being any person other than the Chargor and the Chargee and its permitted successors and assigns) has no right under the Contracts (Rights of Third Parties) Act 1999 to enforce, or to enjoy the benefit of, any term of this charge and no consent and no consent of any third party is required for any variation or termination of this charge.
- 13.14 The perpetuity period applicable to all trusts declared by this charge shall be 80 years.

- 14.4 Any notice or other communication given to the Chargee shall be deemed to have been received only on actual receipt by the Chargee.

15 Governing Law and Jurisdiction

- 15.1 This agreement and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by, and construed in accordance with, the law of England and Wales.
- 15.2 The parties to this agreement irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this agreement or its subject matter or formation (including non-contractual disputes or claims).

Representations and Warranties

- The Chargor is the sole legal and beneficial owner and registered holder of all the Charged Property free from any Encumbrance other than this charge.
- This charge does not and will not conflict with or result in any breach or constitute a default under any agreement, instrument or obligation to which the Chargor is a party or by which it is bound.
- 3 This charge constitutes and will continue to constitute the legal valid binding and enforceable obligations of the Chargor and is and will continue to be effective security over all and every part of the Charged Property in accordance with its terms.
- The Chargor has the necessary capacity, power and authority to enter into and perform his obligations under this charge.
- The Chargor is the sole legal and beneficial owner of the rights assigned in the Assignment and the makers of Charged Property were at all material times employed by the Chargor, and created the Charged Property in the course of their employment with the Chargor or were engaged by the Chargor to create the Charged Property (or part of it) and in each case, have assigned the rights in the Charged Property to the Chargor;
- the rights assigned in the Assignment qualifies for copyright or other protection under the Copyright, Designs and Patents Act 1988;
- all the intellectual property rights in the Charged Property are subsisting and enforceable and nothing has been done to make them invalid;
- 8 the Chargor has not assigned or licensed any of the Charged Property;
- 9 all rights in the Charged Property are free from any security interest, option, mortgage, charge or lien;
- the Chargor is unaware of any infringement, or likely infringement, of any of the rights in the Charged Property;
- as far as it is aware, the exploitation of the rights assigned in the Assignment will not infringe the intellectual property rights of any third party;
- 12 the Charged Property does not contain anything that is defamatory or indecent.

Covenants

1 Disposals

The Chargor has not sold, transferred, granted options over, disposed of, assigned, created an Encumbrance over or encumbered in any manner and during the continuance of the security created by this charge, will not and will not agree or attempt to sell, transfer, grant options over, dispose of, assign, create an Encumbrance over or encumber in any manner all, any or any part of the Charged Property or any of its title, rights or interests in them.

2 Additional Registration Obligations

The Chargor grants and agrees to procure as necessary, all consents, waivers, approvals and permissions which are necessary, under the articles of association of the Chargor or otherwise, for the transfer of the Charged Property to the Chargees or their nominee or to a purchaser upon enforcement of this charge.

3 No Adverse Actions or Variations

The Chargor shall not cause or permit to be done anything which may adversely affect the security created by this charge or which is a variation or abrogation of the rights attaching to or conferred on all or any part of the Charged Property by this charge, without the prior written consent of the Chargee.

Powers of the Chargee

1 Power to Remedy

The Chargee shall be entitled (but shall not be bound) to remedy a breach at any time by the Chargor of any of his obligations contained in this charge and the Chargor irrevocably authorises the Chargee and his agents to do all such things as are necessary or desirable for that purpose.

2 Exercise of Rights

The rights of the Chargee under paragraph 1 of this Schedule 3 are without prejudice to any other rights of the Chargee under this charge and the exercise of those rights shall not make the Chargee liable to account as a mortgagee in possession.

3 Indulgence

The Chargee may at his discretion grant time or other indulgence or make any other arrangement, variation or release with any person or persons not being a party to this charge (whether or not such person or persons are jointly liable with the Chargor) in respect of any of the Secured Liabilities or of any other Encumbrance for them without prejudice either to this charge or to the liability of the Chargor for the Secured Liabilities.

Enforcement

1 Enforcement Events

This charge shall be enforceable if:

- 1.1 any of the Secured Liabilities are not paid or discharged when the same ought to be paid or discharged by the Chargors (whether on demand or at scheduled maturity or by acceleration or otherwise, as the case may be); or
- 1.2 the Chargor is in breach of any of his obligations under this charge or the Loan Agreement and that breach (if capable of remedy) has not been remedied to the satisfaction of the Chargee within 10 Business Days of notice by the Chargee to the Chargor to remedy the breach; or
- 1.3 any representation or statement made by the Chargor in or under this Charge is or proves to have been incorrect or misleading when made; or
- 1.4 an Event of Default (as defined in the Loan Agreement) occurs,

and in any such event (whether or not the event is continuing) the Chargee or any nominee of the Chargee may without further notice, without regard to the restrictions contained in section 103 of the Law of Property Act 1925 and without prejudice to any of Chargee's other rights, immediately exercise all the powers conferred on mortgagees by the Law of Property Act 1925 as varied or extended by this charge without any restrictions.

2 Power of Sale

Notwithstanding that as between the Chargee and a purchaser from the Chargee, the power of sale arises on and is exercisable at any time after the execution of this charge, the Chargee shall not exercise that power of sale until an event (as specified in the paragraph 1 of this Schedule 4) entitling the Chargee to enforce their security has occurred.

3 Protection of Third Parties

No purchaser, mortgagee or other person dealing with the Chargee or its nominee shall be concerned to:

- 3.1 enquire whether any of the Secured Liabilities have become due or payable or remain unpaid or not discharged, or whether the power the Chargee is purporting to exercise has become exercisable; or
- 3.2 see to the application of any money paid to the Chargee or his nominee.

4 Appropriation

Neither the Chargee nor any nominee of the Chargee shall be bound (whether by virtue of section 109(8) of the Law of Property Act 1925, which is varied accordingly, or otherwise) to pay or appropriate any receipt or payment first towards interest rather than principal or otherwise in any particular order as between any of the Secured Liabilities.

5 Statutory Protection

All the protection to purchasers contained in sections 104 and 107 of the Law of Property Act 1925, section 42(3) of the Insolvency Act 1986 or in any other appropriate legislation shall apply to any person purchasing from the Chargee or any nominee of the Chargee as a result of the Chargee exercising or purporting to exercise their power of sale under this charge.

ASSIGNMENT AGREEMENT relating to the "GOD TV" Library of Back Episodes



THIS AGREEMENT is dated

PARTIES

- (1) THE ANGEL FOUNDATION incorporated and registered in England and Wales with company number 03818138 and charity number 1079501 whose registered office is at 27 Burrington Way, Burrington Way, Plymouth, England PL5 3LR (Assignor);
- (2) MARY J. WILLETT of 3557 Kings Mill Road, North Branch, Michigan 48461; and
- (3) **DON WILLETT** of 3557 Kings Mill Road, North Branch, Michigan 48461;
 - ((2) and (3) collectively and jointly referred to as the Assignee).

BACKGROUND

- (A) The Assignor owns the copyright, database rights and any other Intellectual Property Rights (as defined below) in the Library of Back Episodes (as defined below).
- (B) Pursuant to the Legal Charge (as defined below), the Assignor has agreed to assign to the Assignee all copyright, database rights and any other Intellectual Property Rights in the Library of Back Episodes on the terms set out in this agreement.

AGREED TERMS

1 Interpretation

1.1 The definitions and rules of interpretation in this clause apply in this agreement and in any other agreement between the parties.

Business Day

a day other than a Saturday, Sunday or public holiday in England

when banks in London are open for business.

Assignee Material

any material incorporated into the Library of Back Episodes on or

after the Completion Date.

Completion Date

the date of the Legal Charge.

Confidential Information

all confidential information (however recorded or preserved) disclosed by a party or its employees, officers, representatives, advisers or subcontractors who need to know the confidential information in question for the Permitted Purpose (Representatives) to the other party and that party's Representatives in connection with this agreement, which is either labelled as such or else which should reasonably be considered as confidential because of its nature and the manner of its disclosure.

Data

the data or information, in whatever form including images, still and moving, and sound recordings.

Delivery Material

the recording discs, data carriers or any other recording media or apparatus, the specifications of which are agreed by the parties in advance, by which the Library of Back Episodes is to be delivered in physical form.

Intellectual Property **Rights**

patents, utility models, rights to inventions, copyright and neighbouring and related rights, moral rights, trade marks and service marks, business names and domain names, rights in getup and trade dress, goodwill and the right to sue for passing off or unfair competition, rights in designs, rights in computer software, database rights, rights to use, and protect the confidentiality of, confidential information (including know-how and trade secrets) and all other intellectual property rights, in each case whether registered or unregistered and including all applications and rights to apply for and be granted, renewals or extensions of, and rights to claim priority from, such rights and all similar or equivalent rights or forms of protection which subsist or will subsist now or in the future in any part of the world.

Legal Charge

the legal charge entered into between the parties whereby the Assignee has taken a charge over the Library of Back Episodes.

Library of Back Episodes the library of all the Assignor's back episodes of audio-visual programmes, including without limitation the programmes described in the Schedule, and including any Data contained in it.

Normal Business Hours

8.30 am to 6.00 pm GMT on a Business Day.

Permitted Purpose

the purpose of exercising the rights or performing the obligations under this agreement by the relevant party.

Relevant Data

all Data comprised in the Library of Back Episodes.

Security Breach

any security breach relating to any Relevant Data reasonably determined by the Assignee to give rise to a material risk of litigation by third parties affected by the breach.

- 1.2 Clause, Schedule and paragraph headings shall not affect the interpretation of this agreement.
- 1.3 A person includes a natural person, corporate or unincorporated body (whether or not having separate legal personality).
- 1.4 The Schedules form part of this agreement and shall have effect as if set out in full in the body of this agreement. Any reference to this agreement includes the schedules.
- 1.5 A reference to a **company** shall include any company, corporation or other body corporate, wherever and however incorporated or established.

- 1.6 Unless the context otherwise requires, words in the singular shall include the plural and in the plural shall include the singular.
- 1.7 Unless the context otherwise requires, a reference to one gender shall include a reference to the other genders.
- 1.8 A reference to a statute or statutory provision is a reference to it as amended, extended or reenacted from time to time.
- 1.9 A reference to a statute or statutory provision shall include all subordinate legislation made from time to time under that statute or statutory provision.
- 1.10 A reference to writing or written includes faxes but not e-mail.
- 1.11 References to clauses and Schedules are to the clauses and Schedules of this agreement and references to paragraphs are to paragraphs of the relevant Schedule.
- 1.12 Any words following the terms **including**, **include**, **in particular**, **for example** or any similar expression shall be construed as illustrative and shall not limit the sense of the words, description, definition, phrase or term preceding those terms.
- 1.13 In the case of conflict or ambiguity between:
 - 1.13.1 any provision contained in the body of this agreement and any provision contained in the Schedules or appendices, the provision in the body of this agreement shall take precedence
 - the terms of any accompanying invoice or other documents annexed to this agreement and any provision contained in the Schedules or appendices, the provision contained in the Schedules or appendices shall take precedence; and
 - 1.13.3 any of the provisions of this agreement and any correspondence or document between the parties prior to the date of this agreement, the provisions of this agreement shall prevail.

2 Assignment of the Library of Back Episodes

- 2.1 The Assignor hereby assigns to the Assignee absolutely with full title guarantee all Intellectual Property Rights in the Library of Back Episodes of whatever nature throughout the world.
- 2.2 The Intellectual Property Rights assigned under clause 2.1 are Intellectual Property Rights whether now known or created in the future, to which the Assignor is now, or at any time after the Completion Date may be, entitled by virtue of the laws in force in any other part of the world in the Library of Back Episodes, in each case for the whole term including any renewals, reversions, revivals and extensions and together with all related rights and powers arising or accrued, including the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of any of these assigned rights, whether occurring before, on, or after the Completion Date.

3 Delivery

- 3.1 On the Completion Date or any other date agreed in advance by the parties but in any case no more than 60 Business Days of the Completion Date, the Assignor shall deliver the Delivery Material to the Assignee to an address agreed by the parties at a reasonably advance date of such delivery (Location).
- 3.2 The Delivery Material shall be deemed delivered:
 - 3.2.1 if delivered by the Assignor at the Location; or
 - 3.2.2 if delivered by a carrier, on delivery of the Delivery Material by the Assignor to the carrier; or
 - 3.2.3 if collected by the Assignee, when the Assignor makes the Delivery Material available for collection at the Location.
- 3.3 If the Assignee fails to accept delivery of the Delivery Material, the Assignor shall store and continue to insure the Delivery Material pending delivery, and the Assignor shall bear such reasonable storage and insurance charges.

4 Further assurance

- 4.1 The Assignor shall, at its own cost, perform (or procure the performance of) all further acts and things, and execute and deliver (or procure the execution or delivery of) all further documents, required by law or which the Assignee requests to vest in the Assignee the full benefit of the right, title and interest assigned to the Assignee under this agreement, including assisting the Assignee in obtaining, defending and enforcing any Intellectual Property Rights, and assisting with any other proceedings that may be brought by the Assignee against any third party or brought by any third party against the Assignee, relating to the rights assigned by this agreement.
- 4.2 The Assignor hereby appoints the Assignee to be its attorney to execute and do any such instrument or thing, and generally to use its name, for the purpose of giving the Assignee the benefit of this agreement.
- 4.3 This power of attorney is irrevocable as long as any of the Assignor's obligations under this agreement remain undischarged.
- 4.4 Without prejudice to clause 4.2, the attorney may, in any way it thinks fit and in the name and on behalf of the Assignor:
 - 4.4.1 take any action that this agreement requires the Assignor to take;
 - 4.4.2 exercise any rights that this agreement gives to the Assignor; and
 - 4.4.3 appoint and remove one or more substitute attorneys with full power as the Assignor's attorney on terms that the attorney thinks fit.
- 4.5 The Assignor must ratify and confirm everything that the attorney and any substitute attorney does or arranges using the powers granted under this clause.

5 Confidentiality

- 5.1 The parties acknowledge that, with effect from the Completion Date, the Assignee's Confidential Information includes the Library of Back Episodes, but before that date it will form part of the Assignor's Confidential Information.
- 5.2 The term Confidential Information does not include any information that:
 - 5.2.1 is or becomes generally available to the public (other than as a result of its disclosure by the receiving party or its Representatives in breach of this clause 5);
 - 5.2.2 was available to the receiving party on a non-confidential basis before disclosure by the disclosing party;
 - 5.2.3 was, is, or becomes available to the receiving party on a non-confidential basis from a person who, to the receiving party's knowledge, is not bound by a confidentiality agreement with the disclosing party or otherwise prohibited from disclosing the information to the receiving party;
 - 5.2.4 was known to the receiving party before the information was disclosed to it by the disclosing party; or
 - 5.2.5 the parties agree in writing is not confidential or may be disclosed.
- 5.3 Each party shall keep the other party's Confidential Information confidential and shall not:
 - 5.3.1 use any Confidential Information except for the Permitted Purpose; or
 - 5.3.2 disclose any Confidential Information in whole or in part to any third party, except as expressly permitted by this clause 5.
- A party may disclose the other party's Confidential Information to those of its Representatives who need to know that Confidential Information for the Permitted Purpose, provided that:
 - 5.4.1 it informs those Representatives of the confidential nature of the Confidential Information before disclosure; and
 - 5.4.2 at all times, it is responsible for the Representatives' compliance with the confidentiality obligations set out in this clause 5.
- A party may disclose Confidential Information to the extent such Confidential Information is required to be disclosed by law, by any governmental or other regulatory authority (including by a court or other authority of competent jurisdiction provided that, to the extent it is legally permitted to do so, it gives the other party as much notice of such disclosure as possible and, where notice of disclosure is not prohibited and is given in accordance with this clause 5.5, it takes into account the reasonable requests of the other party in relation to the content of such disclosure.
- 5.6 Each party reserves all rights in its Confidential Information. No rights or obligations in respect of a party's Confidential Information, other than those expressly stated in this agreement, are granted to the other party, or are to be implied from this agreement.

5.7 The provisions of this clause 5 shall continue to apply after termination of this agreement.

6 Announcements

No party shall make, or permit any person to make, any public announcement concerning this agreement without the prior written consent of the other parties (such consent not to be unreasonably withheld or delayed), except as required by law, any governmental or regulatory authority (including any relevant securities exchange), any court or other authority of competent jurisdiction.

7 Intellectual property rights indemnity

- 7.1 The Assignor undertakes to indemnify the Assignee from and against any claim or action that the ownership, possession, use and/or exploitation of the Library of Back Episodes (wholly or in part) infringes any Intellectual Property Right of a third party (IPR Claim) and shall be responsible for any losses, damages, costs (including all legal fees) and expenses incurred by or awarded against the Assignee as a result of, or in connection with, any such IPR Claim.
- 7.2 If any third party makes an IPR Claim, or notifies an intention to make an IPR Claim against the Assignee, the Assignee shall:
 - 7.2.1 give written notice of the IPR Claim to the Assignor as soon as reasonably practicable;
 - 7.2.2 not make any admission of liability in relation to the IPR Claim without the prior written consent of the Assignor;
 - 7.2.3 at the Assignor's request and expense, allow the Assignor to conduct the defence of the IPR Claim including settlement; and
 - 7.2.4 at the Assignor's expense, co-operate and assist to a reasonable extent with the Assignor's defence of the IPR Claim.
- 7.3 Clause 7.1 shall not apply where the IPR Claim in question is attributable to possession, exploitation, use, development, modification or retention of any Assignee Material (wholly or in part);
- 7.4 If any IPR Claim is made, or in the Assignor's reasonable opinion is likely to be made, against the Assignee, the Assignor may at its sole option and expense:
 - 7.4.1 procure for the Assignee the right to continue exploiting, using, developing, modifying or retaining the Library of Back Episodes (wholly or in part) in accordance with this agreement;
 - 7.4.2 modify the Library of Back Episodes or the Relevant Data (wholly or in part) so that it ceases to be infringing; or
 - 7.4.3 replace the Library of Back Episodes or the Relevant Data (wholly or in part) with non-infringing items.

8 Assignor's warranties

- 8.1 The Assignor warrants in respect of the Library of Back Episodes that, as at the Completion Date:
 - 8.1.1 each programme in the Library of Back Episodes is an original work and has not been copied wholly or substantially from any other source;
 - 8.1.2 the Assignor is the sole legal and beneficial owner of the Intellectual Property Rights in the Library of Back Episodes and the makers of each programme in the Library of Back Episodes were at all material times employed by the Assignor, and created the programmes in the course of their employment with the Assignor or were engaged by the Assignor to create the programmes (or part of it) and in each case, have assigned the Intellectual Property Rights in the programmes to the Assignor;
 - 8.1.3 the Library of Back Episodes qualifies for copyright or other protection under the Copyright, Designs and Patents Act 1988;
 - 8.1.4 all the Intellectual Property Rights in the Library of Back Episodes are subsisting and enforceable and nothing has been done to make them invalid;
 - 8.1.5 the Assignor has not assigned or licensed any of the Intellectual Property Rights in the Library of Back Episodes;
 - 8.1.6 the Intellectual Property Rights in the Library of Back Episodes are free from any security interest, option, mortgage, charge or lien;
 - 8.1.7 the Assignor is unaware of any infringement, or likely infringement, of any of the Intellectual Property Rights in any of the programmes in the Library of Back Episodes;
 - 8.1.8 as far as it is aware, the exploitation of the rights assigned by this agreement will not infringe the Intellectual Property Rights of any third party;
 - 8.1.9 none of the programmes in the Library of Back Episodes contain anything that is defamatory or indecent;
 - 8.1.10 the Assignor has no notice of any Security Breach or any related claims or complaints;
 - 8.1.11 the Assignor is not aware of any circumstances likely to give rise to any Security Breach in the future;
 - 8.1.12 it has in place written agreements with any third party that it has authorised to have access to the Relevant Data, including processors, to ensure that the third party respects and maintains the confidentiality and security of the Relevant Data.
- 8.2 Except as expressly stated in this agreement, all warranties, conditions and terms, whether express or implied by statute, common law or otherwise are hereby excluded to the extent permitted by law.

9 Limitation of liability

- 9.1 Neither party excludes or limits liability to the other party for:
 - 9.1.1 fraud or fraudulent misrepresentation;
 - 9.1.2 death or personal injury caused by negligence;
 - 9.1.3 a breach of any obligations implied by section 12 of the Sale of Goods Act 1979 or section 2 of the Supply of Goods and Services Act 1982; or
 - 9.1.4 any matter in respect of which it would be unlawful for the parties to exclude liability.
- 9.2 Subject to clause 9.1, the Assignor shall not in any circumstances be liable whether in contract, tort (including for negligence and breach of statutory duty howsoever arising), misrepresentation (whether innocent or negligent), restitution or otherwise, for:
 - 9.2.1 any loss (whether direct or indirect) of profits, business, business opportunities, revenue, turnover, reputation or goodwill;
 - 9.2.2 loss (whether direct or indirect) of anticipated savings or wasted expenditure (including management time); or
 - 9.2.3 any loss or liability (whether direct or indirect) under or in relation to any other contract.
- 9.3 clause 9.2 shall not prevent claims for:
 - 9.3.1 direct financial loss that is not excluded under any of the categories set out in clause 9.2; or
 - 9.3.2 tangible property or physical damage.

10 Waiver

No failure or delay by a party to exercise any right or remedy provided under this agreement or by law shall constitute a waiver of that or any other right or remedy, nor shall it preclude or restrict the further exercise of that or any other right or remedy. No single or partial exercise of any right or remedy shall preclude or restrict the further exercise of that or any other right or remedy.

11 Notice

11.1 Any notice or other communication given to a party under or in connection with this agreement shall be in writing and shall be:

- 11.1.1 delivered by hand or by pre-paid first-class post or other next working day delivery service at its registered office; or
- 11.1.2 sent by fax to its main fax number.

- 11.2 Any notice or communication shall be deemed to have been received:
 - 11.2.1 if delivered by hand, on signature of a delivery receipt or at the time the notice is left at the proper address;
 - 11.2.2 if sent by pre-paid first-class post or other next working day delivery service, at 9.00 am on the second Business Day after posting or at the time recorded by the delivery service;
 - 11.2.3 if sent by fax, at 9.00 am on the next Business Day after transmission.
- 11.3 This clause 11 does not apply to the service of any proceedings or other documents in any legal action or, where applicable, any arbitration or other method of dispute resolution.

12 Entire agreement

- 12.1 This agreement constitutes the entire agreement between the parties and supersedes all previous discussions, correspondence, negotiations, arrangements, understandings and agreements between them relating to its subject matter.
- 12.2 Each party acknowledges that in entering into this agreement it does not rely on, and shall have no remedies for, any representation or warranty (whether made innocently or negligently) that is not set out in this agreement.
- 12.3 No party shall have any claim for innocent or negligent misrepresentation or negligent misstatement based on any statement in this agreement.

13 Variation

No variation of this agreement shall be effective unless it is in writing and signed by the parties (or their authorised representatives).

14 Severance

- 14.1 If any provision or part-provision of this agreement is or becomes invalid, illegal or unenforceable, it shall be deemed modified to the minimum extent necessary to make it valid, legal and enforceable. If such modification is not possible, the relevant provision or part-provision shall be deemed deleted. Any modification to or deletion of a provision or part-provision under this clause shall not affect the validity and enforceability of the rest of this agreement.
- 14.2 If any provision or part-provision of this agreement is invalid, illegal or unenforceable, the parties shall negotiate in good faith to amend such provision so that, as amended, it is legal, valid and enforceable, and, to the greatest extent possible, achieves the intended commercial result of the original provision.

15 Rights and remedies

Except as expressly provided in this agreement, the rights and remedies provided under this agreement are in addition to, and not exclusive of, any rights or remedies provided by law.

16 Third-party rights

No one other than a party to this agreement shall have any right to enforce any of its terms.

17 Assignment and other dealings

This agreement is personal to the parties and neither party shall assign, transfer, mortgage, charge, subcontract, declare a trust over or deal in any other manner with any of its rights and obligations under this agreement.

18 Governing law

This agreement and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of England and Wales.

19 Jurisdiction

Each party irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this agreement or its subject matter or formation (including non-contractual disputes or claims).
