The company continued its objective of drawing attention to the dangers of low level radioactive discharges by participating in various stakeholder dialogues, by maintaining a web site and by supporting independent research and analysis No editions of the Campaign's journal *Radioactive Times* were published No individual grant larger than £2400 was obtained

**Financial Results**

The Company is not trading for profit

The accounts have been delivered in accordance with the provisions applicable to companies subject to the small companies regime

At 1 September 2011 the Campaign held funds of £2413 Income for the year was less than expenditure by a sum of £ 1080, leaving a surplus at 31 August 2012 of £1333
