Report of the Directors for the Year ended 31st August 2014

**Activities**

The company continued its objective of drawing attention to the dangers of low level radioactive discharges by participating in various stakeholder dialogues, by maintaining a web site, by supporting independent research and analysis and by supporting British nuclear weapons test veterans in their appeals against refusal of Service Pensions. No editions of the Campaign's journal *Radioactive Times* were published. No individual grant larger than £2400 was obtained.

**Financial Results**

The Company is not trading for profit.

The accounts have been delivered in accordance with the provisions applicable to companies subject to the small companies regime.

The results of the year are set out in the Income and Expenditure and the Balance Sheet attached hereto.

At 1 September 2013 the Campaign held funds of £15298. Expenditure for the year was greater than income by a sum of £ 7143, leaving a surplus at 31 August 2014 of £8155.

The directors will continue to operate the company within the cash resources available to them.

**Directors**

Mrs Heather Mary Curry, Dr. Christopher Charles Busby and Mrs. Sarah Bramhall were serving as Directors at the beginning of the year. At the Annual General Meeting on 29th September 2014 Dr. Busby retired as a Director as required by Article 35 and was reappointed.

**Audit**

Under section 477 of the Companies Act 2006, the company is not required to have the accounts audited.
