Report of the Directors for the Year ended 31st August 2021

**Activities**

The company continued its objective of drawing attention to the dangers of low level radioactive discharges by maintaining a web site, by supporting independent research and analysis, by participating in online meetings of the stakeholder Forum of the Department of Business, Energy and Industrial Strategy and by participating in a campaign against proposals to dump mud contaminated with radioactive particles in the Severn Estuary. No editions of the Campaign's journal *Radioactive Times* were published.

**Financial Results**

The Company is not trading for profit.

The accounts have been delivered in accordance with the provisions applicable to companies subject to the small companies regime.

The results of the year are set out in the Income and Expenditure and the Balance Sheet attached hereto.

At 1 September 2020 the Campaign held funds of £ 17823. Income for the year was greater than expenditure by a sum of £ 13393, leaving a surplus at 31 August 2021 of £ 25717.

The directors will continue to operate the company within the cash resources available to them.

**Directors**

Mrs Heather Mary Curry, Dr. Christopher Charles Busby and Mrs. Sarah Christine Bramhall were serving as Directors at the beginning of the year. At the Annual General Meeting on 12<sup>th</sup> February 2022 Mrs. Curry retired as a Director as required by Article 35 and was reappointed.
