There has been no significant event affecting the Company since the year end.


Qualifying third party indemnity provisions


For the year ended 31 March 2023 the Company was entitled to exemption from audit under section 480 of the Companies Act 2006.

1. General information

Prock Licence (NTRLRSL) Limited (the "Company") is incorporated and domiciled in the United Kingdom, and is limited by shares. The Company is registered in England and Wales.

These financial statements are presented in pound sterling (£), which is the Company's functional and presentational currency. All amounts have been rounded to the nearest thousand unless otherwise indicated.
