# 1 Receipts and Payments

1.1 There have been no receipts or payments during the Administration of each of the companies. As such, there are no accounts of receipts and payments enclosed.

### 2 Tootsies Restaurants Limited

- 2.1 The companies are all part of the wider "Tootsies" Group The Group's main trading company, Tootsies Restaurants Limited ("TRL"), remains in Administration Reports regarding the progress of the Administration of TRL will be sent to its creditors in due course
- As per the directors' statement of affairs, Urban Dining Limited ("UDL") has a unsecured claim in the Administration of TRL totalling £10,902, relating to an intercompany balance due from TRL.
- Based on current information, unsecured creditors of TRL should receive a dividend of approximately 0 4p/£ under the Prescribed Part provision. As such, UDL's claim in the Administration of TRL is only likely to realise approximately £53. The costs of processing such a claim and keeping the Administration of UDL ongoing would be disproportionate to the level of realisations, therefore I do not intend to pursue this claim.

UDL is the sole shareholder of TRL, but as there will be no return to the shareholder in the Administration of TRL, there is no value in UDL's investment.

### 3 Other assets

TD Scotland Limited had the benefit of a pipeline lease in Braehead The companies' agent confirmed that there was no value in this lease, and it has subsequently been surrendered to the landlord

# 4 Future of the Companies

It is my proposal that the companies now move from Administration to Dissolution in accordance with my initial proposals, deemed to be approved on 21 December 2009 in the absence of a meeting of creditors of the companies

# 5 Prospects for Creditors

- Under Section 176A of the Insolvency Act 1986, where after 15 September 2003 the company has granted to a creditor a floating charge, a proportion of the net property of the company must be made available purely for the unsecured creditors. TD Scotland Limited has not granted a floating charge after 15 September 2003, however both Tootsies Holdings Limited and Urban Dining Limited have
- No assets have been realised in the Administrations and as a result there will be no distribution to any class of creditor, or under the Prescribed Part provision.

### 6 Statutory Information.

- 6.1 The Joint Administrators are Shay Bannon and Antony David Nygate of BDO LLP, 55 Baker Street, London, W1U 7EU and they were appointed in respect of the companies on 12 October 2009 Under the provisions of Paragraph 100(2) of Schedule B1 of the Insolvency Act 1986, the Joint Administrators carry out their functions jointly and severally and neither Joint Administrator has exclusive power to exercise any function
- The Joint Administrators were appointed by Mr Paul Campbell being a director of each of the companies, pursuant to Paragraph 22 of Schedule B1 of the Insolvency Act 1986 The Administration proceedings are dealt with in the High Court of Justice and the Court case numbers are summarised at Section 6 4 below
