IT IS ORDERED THAT:

- 1. Prior service of the Part 8 Claim Form is dispensed with.

- 3. For the avoidance of doubt the Court affirms that the Second and Third Defendants' respective appointments as a director of the Company continues pursuant to the Companies Act 2006, s.1032, as if the Company had not been struck off the Register.
- 4. There shall be a return date on this matter on 19 January 2018 ("the Return Date"), to be listed in the applications list, for the purpose of, amongst other things, agreeing the terms of any undertakings to be given by the Claimants and/or by the directors and/or shareholders of the Company.
- 5. Until the Return Date, the Company shall not take any steps other than (a) instructing Norton Rose Fulbright LLP to act for it; (b) agreeing in writing to extend the standstill period, contained in the standstill agreement dated 7 July 2017 between *inter alia* the Company, the Fifth to Sixth Defendants and the Claimants, to 7 July 2018; or (c) taking such steps as are necessary to do the above or ancillary to the above.
- 6. Liberty to apply.
- 7. Costs reserved.
