It has delegated sole management and control of its underwriting through each Syndicate to the Managing Agent of that Syndicate and it looks to the Managing Agents to implement appropriate policies, procedures and internal controls to manage each Syndicate's exposures to insurance risk, credit risk, market risk, liquidity risk and operational risk. The Company is also directly exposed to these risks, but they are not considered material for the assessment of the assets, liabilities, financial position and profit or loss of the Company.

Hedge accounting is not used by the Company.

In preparing these Financial Statements, the Directors are required to:

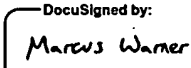
- select suitable accounting policies and then apply them consistently;

1. Accounting policies**General information**

The Company is a private company limited by shares and incorporated in the United Kingdom. The Company's registration number is 3846783. The registered office of the Company is 5th Floor, 70 Gracechurch Street, London, EC3V 0XL.

The Financial Statements have been presented in pounds sterling ("sterling") as this is the Company's functional currency, being the primary economic environment in which the Company is incorporated.

Basis of preparation

These Financial Statements have been prepared in accordance with FRS 102 *The Financial Reporting Standard Applicable in the UK and Republic of Ireland* ("FRS 102"), and applicable legislation, as set out in the Companies Act 2006 and The Large and Medium-sized Companies and Groups (Accounts and Reports) Regulations 2008 ("SI 2008/410"). These Financial Statements have been prepared under the historical cost convention as modified for certain financial instruments held at fair value.

Going concern

The Directors do not consider the Company to be a going concern on the basis that it has ceased to underwrite and all syndicates on which it participated have been closed by reinsurance. The Directors do not intend to recommence trading and therefore have prepared the financial statements on a break up basis.

2. Profit/(Loss) on Ordinary Activities before Taxation

The Company has not traded during the year and there is neither a profit nor a loss.

The Company has no employees and no staff costs are met by the Company.
