1. ACCOUNTING POLICIES**Accounting convention**

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

Turnover

Turnover represents net invoiced sales of goods, services provided and equipment rental/hire, excluding value added tax.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Plant & Equipment	- 25% on reducing balance
Computer equipment	- 33% on reducing balance

Deferred tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.

Hire purchase and leasing commitments

Rentals paid under operating leases are charged to the profit and loss account on a straight line basis over the period of the lease.

4. RELATED PARTY DISCLOSURES

The ultimate controlling parties are D J Owen and G N Thomas by virtue of their shareholdings.

During the year, the company hired and purchased plant & equipment totalling £520,000 (2013: £602,500) from Ascot Event Hire Limited, a company which G N Thomas controls.

There was an amount outstanding at 31 October 2014 of £120,000 (2013: £nil).

There is also a loan to Ascot Event Hire Limited totalling £122,458 (2013: £115,755) in connection with re-charged costs which Ascot Events Limited paid on behalf of the Associated Company.

Included in Other Creditors is a loan from G N Thomas totalling £23,084 (2013: £100,652).

During the year, the company rented its property from R.C. & G.T. Limited, a company in which G N Thomas is a director and shareholder. During the period, accommodation costs payable by Ascot Events Limited to R.C. & G.T. Limited amounted to £29,620 (2013: £30,483). There were no amounts outstanding as at the year end.

All transactions were undertaken at market value on normal commercial terms.
