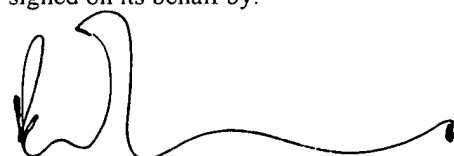
For the year ended 31 December 2014 the Company was entitled to an exemption from the requirement to obtain an audit under section 480 of the Companies Act 2006.
