1 Accounting policies

Basis of preparation

The full financial statements, from which these abbreviated accounts have been extracted, have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (Effective January 2015).

Turnover

Turnover represents the amounts excluding value added tax receivable during the year for products and services supplied. Turnover derives from administrative, secretarial and introductory services.
