## 1. SUMMARY OF EVENTS

<b>Important Notice re: Liquidators' Contacts Details</b>	<ul style="list-style-type: none"> <li>On 29 May 2021 the UK Restructuring Practice of Deloitte LLP was sold to Teneo Restructuring Limited (the "Transaction"). The majority of live insolvency appointments, including this solvent liquidation appointment, were transferred to Teneo Restructuring Limited ("Teneo"), with their respective officeholders and case teams, as part of the Transaction. Our Teneo contact details are provided on the bottom left hand of the cover page.</li> </ul>
<b>Progress of the liquidation during the report period</b>	<ul style="list-style-type: none"> <li>The matters completed during the report period include mandatory liquidation tasks such as statutory advertising, filings at Companies House, notifications of the liquidation and obtaining clearances/searches from HM Land Registry and the Pension Tracing Service. In addition, a six-monthly case review has also been carried out.</li> <li>The Liquidators also liaised with the Company and its tax advisors with regard to the submission of outstanding tax returns and the resolution of outstanding tax matters.</li> <li>Corporation tax clearance was received on 18 March 2021. The Liquidators were subsequently informed that the Company has an outstanding corporation tax return for the period ending 17 November 2020 and that clearance was issued in error.</li> <li>There have been no receipts or payments during the period.</li> <li>No creditors' claims were notified to the Liquidators.</li> </ul>
<b>Costs</b>	<ul style="list-style-type: none"> <li>Our remuneration was fixed by the member on a time-cost basis. As there were no funds in the estate, our remuneration and costs are being met by CSC Computer Sciences Limited ("CSC") and are being billed as part of a wider managed exit project by agreement with CSC.</li> </ul>
<b>Outstanding matters</b>	<ul style="list-style-type: none"> <li>Outstanding tax clearances will be sought from HM Revenue &amp; Customs ("HMRC").</li> <li>Statutory closing procedures.</li> </ul>
<b>Distributions made during the period</b>	<ul style="list-style-type: none"> <li>No distributions were made to the member during the report period.</li> </ul>
<b>Future distributions and closure</b>	<ul style="list-style-type: none"> <li>We anticipate that a first and final distribution of circa £1 will be made during the next 12 months.</li> <li>It is anticipated that the liquidation will be closed within the next 12 months assuming that the outstanding matters can be resolved.</li> </ul>
