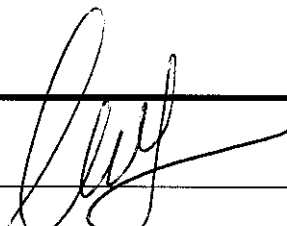
2 By way of fixed charge:-
