ARTICLE 11. ARTICLES OF ASSOCIATION THE PROVISIONS OF THIS ARTICLE ARE SUBJECT TO THE PROVISIONS OF SECTION 18 OF THE COMMONWEALTH DEVELOPMENT CORPORATION ACT 1999. (A) THE SPECIAL SHARE MAY ONLY BE ISSUED TO, HELD BY AND TRANSFERRED TO ONE OR MORE OF HER MAJESTY'S SECRETARIES OF STATE, ANOTHER MINISTER OF THE CROWN, THE TREASURY SOLICITOR OR ANY OTHER PERSON ACTING ON BEHALF OF THE CROWN. (B) THE AMENDMENT OR REMOVAL OF, OR ALTERATION OF THE EFFECT OF, CERTAIN PROVISIONS OF THESE ARTICLES SHALL REQUIRE THE WRITTEN CONSENT OF THE SPECIAL SHAREHOLDER. THIS IS SO EVEN IF THESE ARTICLES SUGGEST OTHERWISE. IF AN ATTEMPT IS MADE TO CHANGE ANY OF THESE PROVISIONS BY SPECIAL RESOLUTION, THE SPECIAL SHAREHOLDER SHALL HAVE NO LESS THAN ONE MORE VOTE THAN 25 PER CENT. OF THE TOTAL VOTES CAST. (C) THE WRITTEN CONSENT OF THE SPECIAL SHAREHOLDER IS ALSO REQUIRED BEFORE CERTAIN EVENTS CAN TAKE PLACE. THIS IS SO EVEN IF THESE ARTICLES SUGGEST OTHERWISE. THIS RESTRICTION APPLIES TO THE FOLLOWING EVENTS: (I) CDC CREATING, ISSUING, PURCHASING, REDEEMING OR REPAYING ANY OF ITS SHARES OR REDUCING OR REORGANISING ITS SHARE CAPITAL OR ANY RIGHTS TO IT IN ANY WAY; (II) CDC ALTERING THE VOTING RIGHTS OF ANY OF ITS SHARES; (III) CDC ENTERING INTO A TRANSACTION WITH A RELATED PARTY. IN THIS ARTICLE, A TRANSACTION IS A TRANSACTION WITH A RELATED PARTY IF IT FALLS WITHIN THE DEFINITION OF THIS EXPRESSION IN THE LISTING RULES OF THE LONDON STOCK EXCHANGE IN FORCE ON THE REGISTRATION DATE, WITH ONE EXCEPTION. A TRANSACTION WITH THE CROWN WILL NOT BE CAUGHT BY THIS PROVISION; (IV) CDC ALTERING CLAUSE 6 OF ITS MEMORANDUM OF ASSOCIATION; AND (IV) THE REMOVAL OF ANY DIRECTOR APPOINTED BY THE SECRETARY OF STATE. IF AN ATTEMPT IS MADE TO APPROVE ANY OF THESE EVENTS OR TO PASS A RESOLUTION TO WIND UP CDC AT A GENERAL MEETING, ON AN ORDINARY RESOLUTION THE SPECIAL SHAREHOLDER WILL HAVE NO LESS THAN ONE VOTE MORE THAN THE TOTAL NUMBER OF ALL OTHER VOTES CAST AND, ON A SPECIAL RESOLUTION, HE SHALL HAVE NO LESS THAN ONE MORE VOTE THAN 25 PER CENT. OF THE TOTAL VOTES CAST. (D) THE SPECIAL SHAREHOLDER'S ONLY RIGHTS REGARDING MEETINGS ARE SET OUT IN THIS ARTICLE 11. THE SPECIAL SHAREHOLDER MUST RECEIVE NOTICE OF ANY GENERAL MEETING AND ANY CLASS MEETING. HE MAY ATTEND AND SPEAK AT ANY SUCH MEETING, BUT, SUBJECT TO ARTICLES 11(B) AND 11(C), THE SPECIAL SHARE CARRIES NO VOTING RIGHTS.
