Structure, governance and management

Governing document

The Performing Right Society Foundation (the Foundation) is a company limited by guarantee, being governed by its memorandum and articles of association and has no share capital (company no 3901665). The PRS Foundation is a registered charity, number 1080837.

The Foundation was re-branded as PRS for Music Foundation in 2010. This name highlights the Foundation's connection with its major donor, the Performing Right Society Limited, which was also re-branded in 2010 as PRS for Music.

Governance

For the purposes of the Companies Act 2006, the Trustees of the Foundation are deemed to be Directors. The Trustees who served during the year 2011 are

The Foundation has provision for eleven Trustees of which no more than half shall be nominated by the Board of the Performing Right Society Limited (PRS). Other Trustees shall be independent individuals with relevant experience relating to the role of the Foundation. Nigel Elderton, Mick Leeson, Estelle Morris and Simon Platz were previously nominated by PRS. In 2011, Simon Darlow was nominated by the Board of PRS and was appointed in April 2011. Edward Gregson was re-appointed as a PRS Director on a casual basis in December 2011.

Trustees are deemed to be re-elected if they stand for re-election and their re-appointment is approved by the majority of members eligible to vote. If a vacancy arises amongst those Trustees nominated by PRS, PRS shall be invited to nominate a new Trustee who shall then be approved by a majority of members eligible to vote. If a vacancy arises amongst any of the independent Trustees, the full Board of Trustees will identify and invite a suitable candidate and give proper notice of their intention to appoint a new Trustee.

All Trustees are offered training in order to develop their role. New Trustees receive full information and induction from the Chairman and staff in order to understand fully their remit, role and responsibilities.

Risk management

The Trustees identify potential risks by carrying out regular detailed reviews of the activities and an annual risk assessment which is approved by the Board via the Finance and Personnel Committee meetings and as part of the business planning process

The following specific measures are in place to mitigate against potential risks

- a wide and appropriate level of professional skills and experience within the Board of Trustees,
- the employment of professionally qualified staff and the engagement of professional services for legal, financial and human resource requirements,
- the employment of an increasingly broad range of independent advisors who help to assess the Foundation's applications
- comprehensive and adequate insurances
- good internal communications and controls

Risk management focuses on health and safety of staff, financial controls, IT and database security, postdisaster personnel procedures, equipment and communications. No significant risks were identified during this year's reviews

Despite being an independent registered charity, the Foundation subscribes to health and safety requirements set down and monitored by PRS in whose offices the Foundation is housed

During 2011, Charlotte Ray and Fiona Harvey undertook the Company Secretary Role

All decisions regarding grant-making and strategic initiatives are made by the Trustees, following recommendations and advice from the Management team and the Advisory Council. The Advisory Council consists of 140 music advisors, who give expert advice and assistance to the Trustees in whom the discretion to grant awards is vested. The Foundation pays a fee for specific services as a member of the Advisory Council, which will be set out in a letter or email confirming these services when required

Premises and associated services

PRS supports the Foundation through a generous annual donation, and through in-kind support for office accommodation (£43,318), financial accounting (£12,873) and printing and postage (£4,400) This in-kind support, for which the Foundation is very grateful to PRS, amounts to £60,591 in total

Objectives and activities for the public benefit

The principal objectives of PRS for Music Foundation are to support, sustain and further the creation and performance of new music in the UK and increase the public's appreciation of and education in new music

With partnership at the heart of everything we do, we push artistic boundaries, lead initiatives which respond to sector needs and raise the profile of new music

The Foundation actively seeks to support all genres of new music through a range of funding schemes and via strategic partnership with other organisations

The activities employed in 2011 to achieve this are

- grant-giving schemes to provide core support for new music organisations
- project grants for commissions to stimulate the creation and performance of new music
- partnership programmes with other organisations to develop long-term support for new music and stimulate significant change e.g. via professional development, international showcasing and collaboration
- preparation of a UK wide Cultural Olympiad commissioning programme, New Music 20x12

The Foundation supports music creators, performers and promoters who are involved in creatively adventurous or pioneering musical activity. In particular, support is focused on music creators (composers / song-writers / producers) who live and work in the UK and on not-for-profit performers, festivals and promoters who are based in the UK. The Foundation supports a huge range of new music activity - from unsigned band showcases to residencies for composers and performers, from ground breaking commissions to the training of music producers and audience development initiatives.

The Foundation accepts applications for funding from all sectors of the public throughout the UK. All details of the Foundation's activities are easily available on www.prsformusicfoundation.com, including grant-making policies, priorities for each funding programme and application forms. All applications and partnerships are considered carefully by the Management, Advisors and Trustees before funding is offered. Our emphasis on transparency in the application process, and the ability of the Foundation team to give expert advice to potential applicants, is a crucial part of the grant-making process.



All recipients are required to take part in an evaluation process so that the Foundation can monitor the impact of its support. Recipients are also encouraged to give feedback on their grant and their needs as part of the new music community through the evaluation process. This information is retained, reviewed and discussed by Trustees and staff, so that Foundation strategies and practices are kept current. In addition, the members of the Advisory Council, all well-respected music professionals, regularly provide advice to inform current practices and future developments.

The Trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Foundation's aims and objectives and in planning future activities and setting the grant making policy for the year. Public benefit is implicit in the Foundation's vision which is to enable high quality new music in any genre to be enjoyed by audiences of all kinds. In particular, the Trustees ensure that the Foundation is open to applications from all geographical areas of the UK, that steps are taken to ensure a clear and transparent decision-making process and that we work in partnership with other organisations to extend our reach and impact, particularly in relation to any music genres, individuals and organisations which are under-represented in our funding portfolio.

Achievements and performance

2011 built on the success of our 10th anniversary in 2010 and marked Year 2 of our current three year agreement with PRS. A significant landmark in 2011 was the Board's decision to review our longstanding open grant schemes and to support Management's delivery of new grants programmes which will be launched in 2012. Ambitious and groundbreaking partnerships were also initiated in 2011, including a major commissioning programme for the Cultural Olympiad, a new series of musician residencies in China and a new fund for women music creators.

We also reviewed our £50,000 New Music Award prize and decided, in view of its limited reach, not to continue with this initiative. Our testing of alternative approaches to this one-off prize enabled us to identify more effective ways in which we could raise the profile of new music and its creators, such as via commissioning initiatives like New Music 20x12, via international residencies and via special funding calls which respond to industry needs

Alongside these innovations, the Foundation continued to consolidate and celebrate its reputation as the UK's only independent, specialist funder of new music across all genres by supporting grant schemes which stimulate the creation of new work alongside partnership programmes which stimulate professional development and creative collaboration. All of these activities have been planned in the framework of a 3 year Business Plan (2010-12) which facilitates new programmes alongside longstanding initiatives.

Financial support for all genres of new music

The Foundation provided a significant level of direct financial support for new music in 2011 (over £1 6m) Grant-making for the support of new music is at the heart of the Foundation's activities and is recognised by the sector as indispensable, flexible funding. Through this support we

- stimulate a growing market and infrastructure for live music across all genres, through festivals, promoters, organisations and performance groups
- encourage employment of composers & musicians, build audiences, promote the development of artists of all ages, create copyright material, and kick-start collaborations & partnerships

This year PRS for Music Foundation has pledged support to new live British music by awarding £1,101,011 to grants and partnership programmes and £501,113 to initiatives which depend on restricted income from funding partners who share our objectives

82% of our grants budget supported new work and infrastructure across all genres
18% was awarded to partnership programmes which support professional development for emerging talent
(e.g. British Music Abroad, Composer in the House, Take Five, scholarships and bursaries) and collaboration
(e.g. Beyond Borders, international creative exchanges)

Our support is awarded to composers and organisations from across the whole of the UK, with 9% of the Foundation's funding going to Scotland, 5% to Wales, 4% to Northern Ireland and 82% to England including organisations with a UK wide remit. This aligns with the 2001 population census. As we believe that the diversity of UK music is critical to the vibrancy of live music in the UK, our funding is awarded to an enormous cross-section of composers and writers, including those working in and across classical, electronic, experimental, folk, jazz, pop, sound art and urban music.



Partnerships, income raised and additional funds leveraged

The Foundation's partnerships with other organisations are central to our work. With like-minded organisations we combine resources to enhance our impact and initiate pioneering programmes which enable the sector to develop and grow.

- In 2011, we raised £282,697 from sources other than PRS of which £269,443 was pledged direct to the Foundation as restricted income and £13,254 as unrestricted. Distribution of this restricted income was managed by the Foundation in consultation with partners, external advisors and with approval from Trustees.
- In addition to this income generated by the Foundation, £498,042 of matched funding was levered for the music sector as a result of our leadership and partnership programmes which incentivise others to invest in new music. These levered funds included in-kind support for large-scale Foundation programmes such as New Music 20x12, match funding for International programmes like our Musicians in Residence in China, funds raised for European projects we helped to initiate and awards made direct to grantees by partners who share our charitable objectives
- In addition to these levered funds, our Grantees tell us that our funding helps them to secure over £1m per year from other sources

Examples of strategic partnership programmes which were initiated by the Foundation in 2011 and stimulated additional investment into the sector are

- **Musicians in Residence in China** to enable UK musicians UK musicians to spend time in China, writing new music and building new, international relationships
- New Music Plus. .UK to support the creative and professional development of music event producers and arts organisations throughout the UK building on our regional pilots in London and the North West
- Take Five Europe to enable participants of the longstanding jazz development programme run by Serious, to significantly develop their international careers, showcase and expand their professional networks

Examples of longer standing partnerships which we continued to deliver in 2011

- New Music 20x12 to support the commissioning of 20 new works each lasting 12 minutes in collaboration with BBC Radio 3, NMC Recordings and London 2012. This was initiated by private patrons, David Cohen and Jillian Barker and will culminate with performances UK wide throughout 2012.
- British Music Abroad supports emerging, high quality UK artists to attend international industry
 facing showcases. It is funded by the Foundation, Arts Council England (via British Underground),
 UKTI and Arts Council Wales/Wales Arts International. The fifth year saw a greater number of artists
 supported to attend a broader range of showcases than ever before. Tangible outcomes include.
 - 54 acts supported to attend nine international industry events including SXSW, Jazzahead, Womex,CMJ, Sauti Za Busara
 - 86% returning with tangible immediate results, e.g. signings, live performances, distinctive press coverage
 - Artists that have gone on to achieve significant international success include James Blake, Everything Everything, Dry The River and Soweto Kinch
- Beyond Borders: to support cross border commissioning in the UK with support from Arts Council
 of Wales, Creative Scotland, Arts Council of Northern Ireland and Colwinston Trust
- **New Music Incubator** to support 10 musicians from the UK and Sweden to participate in a residential exchange, with support from the Swedish Music Information Centre and Musikalliansen

Ongoing partnerships also took place with Jerwood Charitable Foundation, Royal Philharmonic Society, Bliss Trust and Alan Hawkshaw



Reputation

The Foundation is positioned as a crucial organisation within the new music community, the arts funding system and the music industry. The Foundation is recognised for its knowledge, specialist networks and efficient grant-making systems which offer a channel through which other funders can reach a wide range of creators and support bespoke programmes which respond to need.

The Foundation collaborates with UK Music 2009 Ltd, BASCA, and other music industry organisations based at our Berners Street offices and exchanges information with other Trusts and Foundations which support the arts in the UK via the informal arts funder network set up by Paul Hamlyn Foundation

Measuring success

By its very nature, much of the impact of the Foundation's work is felt several years later. However, the Trustees monitor the effect of the Foundation's activities through

- annual evaluation of the key grant-making schemes and projects
- · regular discussions with key stakeholders and partners
- · regular review of income streams
- · regular risk assessment

Financial Performance

A renewed charitable donation of £1 5m per annum from the Board of the Performing Right Society Limited to the Foundation was confirmed in September 2009 for 2010, 2011 and 2012. This has enhanced the support the Foundation can offer to the music sector and has provided stability for the Foundation's strategic planning, activity and partnerships with other organisations. The Foundation is extremely grateful for the generosity and support of the Membership and the Board of PRS and their commitment to creating a future for music in the UK.

On 4 July 2012 the PRS Board agreed to a commitment of an annual donation to the Foundation of £1 5 million as a rolling 3 year agreement to be reviewed each December, with an 18 months' notice period Based on this and the Foundation's business plan projections, the Trustees believe that it is appropriate for the Foundation to continue to adopt the going concern basis in preparing the annual report and financial statements

By using PRS's donation as an incentive, the Foundation stimulated investment of an estimated £2,315,739 into the sector (£282,697 of direct income, £498,042 of funds levered via PRSF's partnership programmes and an estimated £1,530,000 levered by the Grantees we support) This indicates the additional value the Foundation is creating thanks to PRS's core support

Reserves policy

The Trustees intend that the operational reserves will cover the administration costs of the charity for the first quarter of the following year. The operational reserves at 31 December 2011 stand at £207,403 for unrestricted funds.

Administrative costs

As a result of rigorous financial management, administrative costs are kept between 10-12% of the total funds raised and levered for its charitable objectives

Restricted fund projects

New Music Plus , British Music Abroad, Beyond Borders, New Music 20x12, New Music Incubator, the Alan Hawkshaw/PRSF Scholarships, and Musicians in Residence China are administered by the Foundation with restricted funds from other sources. All of these are ongoing projects. Any deficit at the beginning or end of the financial year is due to timing differences on payments from partners.

Grant-making process

When allocating grants to organisations, applications have to meet criteria set out in the Application guidelines. Once the criteria have been met, the application is first assessed by the Foundation staff, then by an Advisory panel, and then taken to the Foundation Board of Trustees for final approval. The grant pledges are recognised in the Board minutes and will be recognised in the statutory accounts in the same year that the Board has approved the application. Following approval of an application, all grantees are sent an offer letter which may or may not contain certain conditions that need to be fulfilled in order for them to receive the funding. Organisations that are awarded multi-year grants are required to submit a report every year so that Foundation funding is re-confirmed by the Board on an annual basis.



Plans for 2012

Our current Business Plan (2010-2012) provides a blue-print for our ambitions during this period. In year 3 of our business plan we remain committed to these ambitions, which are to

- Lead transformational programmes which exploit our specialist knowledge
- Champion new British music at home & overseas
- Increase resources by building coalitions that make a significant difference
- Sustain broad, flexible and indispensable support of new music in any genre
- Learn and communicate more effectively to increase relevance and impact
- Work with PRS to maximise the mutual benefit of our partnership.

Our priorities in 2012 are

- Implementation and ongoing monitoring of our new grants schemes for individuals and organisations
- Successful delivery of our Cultural Olympiad programme, New Music 20x12, in partnership with BBC Radio 3, NMC Recordings, Southbank Centre and London 2012
- Launching a UK wide version of our New Music Plus development programme for music producers
- Sustaining our new fund for Women Music Creators
- Building on legacy of our music creator residencies in China
- Securing our next 3 year donation from PRS (2013-15)

In view of the current economic climate, we will continue to champion partnership programmes which promote the importance of sharing resources and have the potential to grow audiences for new music. We also aim to diversify our range of funding partners to include private sponsors for some of our music industry programmes.

1. Accounting Policies

a) Accounting Conventions

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (Effective April 2008) and the Companies Act 2006 and follow the recommendations in 'Accounting and Reporting by Charities Statement of Recommended Practice' (SORP 2005) issued in March 2005

The Trustees believe that the Foundation should continue to adopt the going concern basis in preparing the annual report and financial statements as they have a guarantee to fund for 3 years from PRS until 2012. On 4 July 2012 the PRS Board agreed to a commitment of an annual donation to the Foundation of £1.5 million as a rolling 3 year agreement to be reviewed each December, with an 18 months' notice period. Based on this and the Foundation's business plan projections, the Trustees believe that it is appropriate for the Foundation to continue to adopt the going concern basis in preparing the annual report and financial statements.

b) Fund Accounting

The funds consist of restricted and unrestricted funds, of which the unrestricted are available for use at the discretion of the Trustees in furtherance of the general objectives of the charity. The restricted funds are funds that can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes. There have been the following movements from the unrestricted fund to the restricted funds £30,000 to British Music Abroad, £30,000 to Beyond Borders, £5,000 to NFTS scholarships and £5,000 to Composer in the House. There have also been movements to the unrestricted funds from restricted funds £13,600 from New Music Plus North West and £351 from New Music Incubator. This represents the Foundation's financial investment in these projects.

c) Incoming Resources

Voluntary income including donations and grants are recognised where there is entitlement, certainty of receipt and the amount can be measured with sufficient reliability. Such income is only deferred when

- the donor specifies that the grant or donation must only be used in future accounting periods, or
- the donor has imposed conditions which must be met before the charity has unconditional entitlement

Investment income is recognised on a receivable basis

d) Donated Services and Facilities

Where services are provided to the Foundation as a donation that would normally be purchased from suppliers, this contribution is included in the financial statements at an estimate based on the value of the contribution to the Foundation. Donated services and facilities are discussed in note 10.

1. Accounting Policies (continued)

e) Resources Expended

Grants pledged in furtherance of the charity's objectives, comprise those grants allocated during the financial period. Grant obligations are recognised on an accruals basis once a valid expectation of receipt of the grant has been established.

Management and administration costs are all other costs actually incurred by the Foundation, which are not grants. During the period, no direct fundraising costs were incurred. Governance costs include those incurred in the governance of the charity and its assets are primarily associated with constitutional and statutory requirements.

f) Cash flow Statement

The charity has taken advantage of the exemption in FRS1 from the requirement to produce a cash flow statement because it is a small company

g) Value Added Tax

The company is not registered for value added tax and all irrecoverable VAT is allocated to the related expense

h) Pensions

Contributions to personal pension schemes are charged to the profit and loss account as they become payable in accordance with the rules of the individual schemes

i) Fixed Assets and Depreciation

Fixed assets are initially recorded at cost. Depreciation is provided at rates calculated to write off the cost less residual value of each tangible fixed asset over its expected useful life as follows.

Computer equipment – 20% per annum straight line

The carrying values of tangible fixed assets are reviewed for impairment in periods if events or changes in circumstances indicate the carrying value may not be recoverable

2. Legal Status of the Charity

The charity is a company limited by guarantee and has no share capital. The members of the Company are Performing Right Society Limited and the Trustees. The liability of each member in the event of winding up is limited to £10.

Beyond Borders, managed by the Foundation with funds also from Scottish Arts Council, Arts Council Wales, Arts Council Northern Ireland and Colwinston Trust, supports collaboration and co-commissioning between organisations throughout the UK

British Music Abroad, managed by the Foundation with funds from Arts Council England and UK Trade and Investment, provides travel and accommodation costs for bands selected to perform at international showcases

China – Musicians in Residence China is a partnership programme which the Foundation initiated in collaboration with British Council which is managing this project. A travel, R&D grant was awarded in 2011 to support Foundation staff to set up the residency hosts in China.

Composer in the House, administered by the Foundation with matching funds from the Royal Philharmonic Society offers a 2 year residency to a British composer to work with a leading orchestra. The hosting orchestra is also expected to match some of this funding through in kind support and a commitment to commissioning new work.

New Music Incubator is an international residential course for performers, improvisers and composers run in partnership with the Swedish Composer Society, Swedish Embassy sponsored the launch of this programme in London in 2011

New Music Plus UK (NMP UK) is a live event producer development programme which was initiated by the Foundation in collaboration with the hub. In the North West, NMP was supported by Arts Council England, Paul Hamlyn Foundation and Sound and Music - administration of this programme will be completed in early 2012. NMP—UK was devised in consultation with a range of host organisations and funders from across the UK who confirmed the need for this programme to be made available beyond it's pilot regions. Creative Scotland and Arts Council of Wales confirmed their support in 2011.

New Music 20x12 is supported with funds from a wide range of private patrons, trusts, foundations and Arts Councils across the UK. It supports the commissioning of new works delivered by 20 arts organisations from across the UK and is run in partnership with BBC Radio 3 and London 2012. Each organisation raises additional funds to realise their projects in their entirety.

The NFTS scholarships is an ongoing joint funding scheme between the Foundation and private donor, Alan Hawkshaw to support composers at The National Film and Television School
