## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 SEPTEMBER 2017

### 1. General information

Endeavour Training Services Limited is a private company limited by shares, incorporated in England and Wales. Its registered office is Endeavour Centre, Earl Marsh Road, Sheffield, South Yorkshire, S4 8FB and its registered number is 03902149. The principal activity of the Company throughout the year is that of educational support services.

# 2. Accounting policies

### 2.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention unless otherwise specified within these accounting policies and in accordance with Section 1A of Financial Reporting Standard 102, the Financial Reporting Standard applicable in the UK and the Republic of Ireland and the Companies Act 2006.
