1 Accounting policies

1.1 Accounting convention

The financial statements are prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2015).

The company went into administrative receivership on 4 August 2011. The period of administrative receivership came to an end on 10 February 2014 after which control of the company was handed back to the director. As the director has not been able to gain access to the records maintained by the administrative receivers, these accounts have been prepared based on information available to the director, which includes the use of estimates where necessary. Given the insolvent position of the company and the fact that the company is currently not trading, the director does not feel it is appropriate to prepare the accounts on a going concern basis. As such the accounts have been prepared on a break-up basis.
