It is now six months since our appointment in respect of the Group. In accordance with Rule 2.47 of the Insolvency Rules 1986, we are now reporting the progress made in implementing the approved proposals and achieving the statutory purpose of the Administrations.

- 1 Statutory Information
- **BDO** LLP ("BDO"), Administrators Shay Bannon of 1 1 The Joint are Dermot Power and Tracey Pye of 55 Baker Street, London, W1U 7EU, BDO, 3 Hardman Street, Manchester, M3 3AT and they were appointed in respect of Under the provisions of paragraph 100(2) of the Group on 4 August 2009 schedule B1 of the Insolvency Act 1986 the Joint Administrators carry out their functions nointly and severally and none of the Joint Administrators has exclusive power to exercise any function
- On 4 August 2009, an application for the appointment of Joint Administrators was made by Wayne Arthur, being a Director of the Group, pursuant to Paragraph 22 of Schedule B1 of the Insolvency Act 1986 The Administration proceedings are dealt with in the Chancery Division of the High Court of Justice, Royal Courts of Justice, The Strand, London. A schedule of the individual companies within the Group including their company registration number and Court reference number is attached at Appendix A.
- 1.3 The Group's registered office is situated at 3 Hardman Street, Manchester, M3 3AT.
- 1.4 We enclose at Appendix B, for your information, a summary of the Joint Administrators' receipts and payments from the sale of the Group's assets showing balances in hand totalling £2,427,877 and a summary of receipts and payments from trading and other assets showing a balance in hand of £2,827,322 In total, therefore, we are holding £5,255,199.

2 Trading

2.1 As previously reported, following our appointment the Group continued to trade for a total of 19 weeks. The business and assets of the Group were sold to PBR Leisure Limited ("PBR"), a subsidiary of The Orchid Group Limited on 15 December 2009.

2.2 Employees.

Approximately 1,700 employees remained in employment across 45 establishments during the Joint Administrators' trading period. As mentioned at section 3 below, we were successful in saving 1,600 jobs but, regrettably, it was necessary to make a number of redundancies in respect of staff at premises where we were unable to achieve a sale.

2 3 Purchase Order System:

Immediately following our appointment, with the assistance of our agents, we implemented control measures to manage ongoing purchasing and expenditure at head office. In particular, new accounts and payment terms were negotiated with key suppliers and letters of undertaking were provided to the majority of the suppliers to ensure continuation of supply. The new purchase order system facilitated the authorisation of approximately 300 orders per day, throughout the Joint Administrators' trading period

2 4 Financial Control and Monitoring

Management accounts were prepared on a regular basis to ensure that projected gross margins were being maintained and that overheads were in line with forecasts for the trading period.

2.5 Landlords

Negotiations were entered into with the landlords of the establishments for the continuation of trade and for the payment of rents to be made on a monthly basis, in relation to the sites which continued to trade during Administration

2.6 Stock-takes

Regular stock-takes were undertaken by an external third party to ensure that the stock held at each establishment was in line with the Group's stock system and that gross margins were being maintained.

3 Sale of Business and Assets

On 15 December 2009, the majority of the Group's business and assets were sold to PBR for a consideration of £55,780,258.

This amount was paid in full with no deferred consideration. The sale agreement provides for an adjusted asset provision and a refunded price will be due to the purchaser in respect of any other realisations which would have been due to the secured creditor under either the floating or the fixed charges.

The sale to PBR followed extensive marketing of the business.

The Living Room, Birmingham, The Living Room, Islington; Potthouse, Belfast; and Prohibition, Bishopsgate did not form part of the sale and ceased trading on 15 December 2009. In addition to these sites, please note that the following establishments were also not included within the sale to PBR, Advocate, Belfast; Sea Glasgow and Rewind



Newcastle which all closed immediately upon our appointment and Luckies, Newcastle which closed on 29 September 2009. The sale of the business and assets to PBR resulted in approximately 1,600 employees transferring to the purchaser.

3.1 Secured Creditors:

From the sales consideration we have made payments to the secured creditors, The Royal Bank of Scotland Plc ("RBS") and Allied Irish Bank ("AIB") ("Secured Creditors") of £29,654,976 53 and £23,427,467.16 respectively

4 Receipts

4.1 Sales:

Sales of approximately £20 million plus VAT were achieved during the Joint Administrators' trading period.

4.2 Other Receipts.

In total, we have realised £536,814 from the assets not included within the sale agreement

5 Payments

The most significant costs during the trading period were stock purchases, labour and property costs.

5.2 Purchases:

As explained above, the Group traded for 19 weeks under the supervision of the Joint Administrators and payments to date totalling £5.5 million have been made in relation to stock purchases.

5 3 Labour:

During the trading period, it was necessary for the Joint Administrators to continue to employ staff at the 45 trading establishments and at head office in order to achieve a sale of the Group. Therefore, a total of £4.4 million (including expenses and employee benefits of approximately £74,000 and £16,000 respectively) has been incurred in relation to these staff. These payments are net of the Group's PAYE/NIC liabilities, which amount to approximately £1.3 million.

5.4 Property Costs.

The total costs paid to date in relation to rent, rates and utilities amount to approximately £2 5 million.

5.5 Managing Agent's fees:

To date, a total of approximately £440,000 plus VAT has been paid to managing agents who assisted with the trading of 45 establishments for the duration of the trading period.

5.6 Other Trading Costs

Other trading costs total £3.5 million predominantly relating to insurance of approximately £271,000; professional fees of £206,000, repairs and maintenance of £239,000; streamline charges (the cost of accepting payments by credit cards) of



£351,000, waste management and cleaning costs of £736,000, advertising of £364,000, relating to marketing, PR and advertising costs; performers costs of £337,000 relating to DJ costs; sales commission of £157,000; and security costs of £533,000

6 Future of the Administration

- 6.1 The statutory purpose the Administrations consists of three objectives, and we now address the progress that has been made in this respect.
 - Rescuing the trading entities as a going concern; or
 - Achieving a better result for the Group's creditors as a whole than would be likely if the Group was wound up (without first being in Administration), or
 - Realising property in order to make a distribution to one or more secured or preferential creditors
- 6 2 It was not possible to achieve the first objective of rescuing the Group as a going concern, given the previous attempts of the Directors to sell the business and the closure of three establishments immediately upon our appointment.
- 6.3 The Joint Administrators, therefore, focused on achieving the second objective of maximising the asset realisations. This objective has been achieved in relation to the non-dormant Group Companies as the sale of the majority of the business and assets to PBR has resulted in a better realisation than would have been achieved in Liquidation. The Joint Administrators continue to pursue this objective and details of outstanding matters can be found below.
- 6 4 The third objective has also been achieved as a distribution has been made to the secured creditors as discussed above.

7 Outstanding Matters in Relation to Trading

Further to the sale of the Group and the controls that were implemented at the beginning of the Administration, in particular, new accounts being negotiated and letters of undertaking being issued to the majority of the suppliers, the Joint Administrators have retained a limited number of key Group and temporary staff to assist with winding down the trading period and ensuring that all suppliers, including utility companies have been paid.

8 Outstanding Matters Following the Sale of the Business and Assets

8.1 Surrender of Leases:

In relation to the closed establishments, three leases have been surrendered back to the landlords and our solicitors continue to deal with the other respective landlords in relation to the four remaining leases.

8 2 Licence to Occupy:

We continue to monitor licence payments and to pay rent and associated costs to the relevant landlords pursuant to an agreement with PBR.

8 3 Trading and Other Costs:

We are currently settling all of the remaining costs incurred whilst trading which will, of course, reduce the level of funds in the estate



9 Exit Route

- 9.1 We can confirm that a meeting of creditors was not called pursuant to Paragraph 51(1) of the Insolvency Act 1986 or requisitioned by the creditors. On this basis the proposals have been deemed to be approved by the creditors pursuant to Rule 2.33(5) of the Insolvency Rules 1986.
- 9.2 It is agreed, therefore, that once all matters are concluded, should realisations be insufficient to enable a dividend to be paid to unsecured creditors, that the Joint Administrators shall arrange for the Group to exit the Administration by way of dissolution under Paragraph 84 of Schedule B1 of the Insolvency Act 1986, subject to the Joint Administrators being successful in assigning/surrendering the property leases during the course of the Administration
- 9.3 However, should realisations be sufficient to enable a dividend to be paid to unsecured creditors, the individual companies should move from Administration to Creditors' Voluntary Liquidation ("CVL"). Should the individual trading companies move to CVL it is proposed that the Joint Administrators be appointed as Joint Liquidators. As discussed above, the dormant/non trading companies within the Group will, in any event, exit Administration via dissolution on the basis of there being no dividend prospects for unsecured creditors.

10 Prospects for Creditors

10.1 Secured Creditors

At the date of appointment, RBS held fixed charges over the goodwill and properties of the Group and floating charges over the remaining assets of the Group. RBS acts as security trustee in relation to the liabilities due to AIB. There will be no further payments made to the secured creditors in respect of their outstanding debts.

10 2 Preferential Creditors:

Employees' claims are estimated at approximately £14,000 in respect of pre-Administration arrears of wages and holiday pay owing to the redundant employees. At this stage, we are uncertain of whether there will be funds available to enable a distribution to be made to the preferential creditors.

10.3 Unsecured Creditors and the Prescribed Part:

Under the provisions of Section 176A of the Insolvency Act 1986 the Joint Administrators must state the amount of funds available to unsecured creditors in respect of the Prescribed Part. This Provision only applies where a company has granted a floating charge to a creditor after 15 September 2003. The Group has granted floating charges to the secured creditors after this date in relation to the following subsidiary companies and, therefore, the provisions of the Prescribed Part will apply to these companies (excludes dormant/non trading companies where there are insufficient assets to enable a dividend to be paid under the prescribed part):

- Pimco 2374 Limited
- Prohibition Bars Limited
- Pimco 2393 Limited
- Bel and the Dragon (Cookham) Limited
- BDR Restaurants Limited
- Buildsense Limited



- The Living Room Group Limited
- 10.4 At this stage, we are uncertain of whether there will be sufficient floating charge realisations (after costs of the Administration) to enable a distribution to the unsecured creditors of these companies from the Prescribed Part.
- 11. Joint Administrators' Remuneration
- 11.1 As previously advised we did not call an initial meeting of creditors on the basis that the Group appeared to have insufficient property to enable a dividend to be paid to unsecured creditors. In cases where there will be no dividend to unsecured creditors we are obliged to seek authorisation of our fees from the secured and preferential creditors.
- 11.2 The Joint Administrators' proposals include a provision that their remuneration be approved on a time cost basis, subject to the approval of the secured creditors. We shall request the secured creditors to approve the Joint Administrators' remuneration on a time costs basis. Attached at Appendix D are schedules that summarise the time that has been spent in dealing with the Administration of the Group to the date of this report. This shows that a total of approximately 7,696 hours has been spent at an average charge out rate of £233 per hour, resulting in time costs to date of £1,796,825.
