Supervisors Final Report to Creditors Pursuant to Rule 1.29(2) of The Insolvency Rules 1986

1. Proposal

Under the terms of the five year arrangement the company was obliged to make contributions at the rate of £2,300 per month

2. Compliance

To date the company has made payments totalling only £3,500 and is therefore considerably in arrears with the monthly contributions

On 10 September 2009 I wrote to creditors to inform you that the company was in arrears with its contributions. I confirmed that I had instructed solicitors to petition for the winding up of the company but due to the costs involved, I canvassed creditors' views as to whether you would fund the balance of the costs to continue the petition. No response was received and the petition was therefore withdrawn.

In the circumstances the arrangement has clearly failed

3. Secured Creditors

I have not received any claims from creditors who hold security for their debts whom I have assumed are content to rely upon their security

4. Preferential Creditors

There are no creditors whose claims are preferential

5. Unsecured Creditors

Claims received from unsecured creditors which were lodged in accordance with the terms of the arrangement amounted to £190,500

6 Receipts and Payments Account

A final Receipts and Payments Account is attached to this report

7. Supervisors Remuneration

Under the terms of the proposal, I am entitled to take remuneration at the lower of my time costs or DTI Scale Rates. My time costs to 19 February 2010 amount to £3,237 which represents 22.40 hours at an average rate of £144.51 per hour, there are no funds to enable even a payment on account to be taken.


