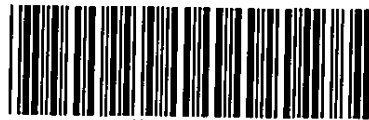

- have been prepared in accordance with the requirements of the Companies Act 2006.


### *Opinion on other matters prescribed by the Companies Act 2006*



### 1 Basis of Preparation

The financial statements have been prepared in accordance with applicable accounting standards and under the historical cost accounting rules
