(b) sell, discount, factor, transfer, lease, lend or otherwise dispose of, whether by means of one or a number of transactions related or not and whether at one time or over a period of time, the whole or, save in the ordinary course of business, any part of its undertaking or assets save as permitted under the Loan Agreement

Terms used in this MR04 form and not defined herein shall have the meanings given to them in the Assignment

Aircraft means the Cessna Citation Bravo aircraft msn C550-1018 registered with registration mark G-JBLZ, (including the Airframe, Engines and all appurtenant equipment together with all parts, replacements, additions and renewals thereof made in accordance with the Loan Agreement) and the Technical Records as set out in Schedule 1 to the Loan Agreement

Assigned Contracts means

- (a) the Maintenance Service Programme, and
- (b) any agreement entered into in respect of the Engines as a replacement to the Maintenance Service Programme

Loan Agreement means the loan agreement dated 5 November 2009 between the Assignor and the Assignee

Maintenance Service Programme means the Pro-Parts Power Advantage Agreement Number CJ-B-1018 dated 28 October 2009 between the Maintenance Service Provider and the Assignor in respect of the Aircraft
