

#### 1. INTRODUCTION

Simon Harris and Ben Woodthorpe were appointed as Joint Liquidators of Former IRO (the Company) on 14 September 2018.

On 29 November 2018, Simon Harris was removed as Joint Liquidator by Court Order following his resignation from ReSolve Advisory Limited (ReSolve) and was replaced on the same day by Mark Supperstone of ReSolve. This has no impact on the Liquidation.

This is the Liquidators' final account to the members as all matters have now been concluded and the Liquidation can now be finalised. This report covers the Liquidation period from 14 September 2018 to 14 May 2019 (the Reporting Period).

The Company's statutory information is detailed at Appendix I.

#### 2. LIQUIDATORS' ACTIONS SINCE APPOINTMENT

The following actions have been undertaken since the Liquidators' appointment:

- Upon appointment arranged for the formal notices to be issued to the relevant parties
- Liaised with solicitors, Moore Blatch LLP (MBL) regarding drafting of a deed of assignment in respect of the Company's intercompany balance
- Completed an in specie distribution to Institution of Railway Operators Limited (IROL) as per the deed of assignment dated 25 September 2018
- Dealt with HM Revenue & Customs (HMRC) for pre-appointment taxation clearances
- Prepared the Liquidators' draft and this final account to the members, and
- Finalised the Liquidation.

The matters undertaken during the course of the solvent liquidation process have been statutory in nature and whilst there is no direct benefit to the members, the work has been completed under a fixed fee agreement.

#### 3. RECEIPTS AND PAYMENTS

Attached at Appendix II is the receipts and payments account for the Reporting Period.

There were no estate funds and therefore no bank account was held.

### 4. ASSETS

The only asset listed on the Declaration of Solvency (DOS) was the intercompany debtor of £246,635 as per the accounts as at 30 June 2017. This asset was distributed in specie as detailed in section six below.

No other assets have been identified during the Reporting Period and no further asset realisations are expected.

#### 5. LIABILITIES

There were no liabilities listed on the DOS.

No liabilities have been identified during the course of the Liquidation. HMRC has issued clearance and confirmed it has a nil claim allowing for the Liquidation to be finalised.

# 6. DISTRIBUTIONS

On 25 September 2018, £246,635 in respect of an intercompany debtor balance was distributed in specie to IROL. The distribution is in accordance with a deed of assignment dated 25 September 2018 between the Company and IROL.

There will be no further distributions to the members.

### 7. LIQUIDATORS' REMUNERATION AND EXPENSES

Written resolutions of the members dated 14 September 2018 resolved that the Liquidators' remuneration should be fixed at £5,000 plus VAT for assisting with the preparation of the DOS and the winding up of the Company. The payment of the same has been received directly from IROL.

The following disbursements have been incurred and paid:
