The accounts have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities effective April 2008.

The company's balance sheet at 31 March 2013 disclosed a deficit on shareholders' funds of £3,125. The company is dependent for its working capital on the continued support of its director. The director intends to support the company for a period of twelve months from the date of approval of these accounts. Accordingly, the director believes that it is appropriate to prepare these accounts on a going concern basis and no adjustments have been made which would require to be made were this basis to be inappropriate.
