- 1 Oliver Vaughan resigned as a non-executive director of Jetlodge Limited (formerly The Complete Picture Limited) in September 1995. The company was the subject of a creditors' voluntary winding-up which was commenced in January 1996 and completed in June 1997.
- Oliver Vaughan resigned as non-executive director of eBop Media Plc in September 1999 and from eBop Limited in August 1999. Both companies went into liquidation on 19 December 2000 with estimated deficiencies to creditors of £209,336 and £2,038,958 respectively.
- 3 Oliver Vaughan resigned as a non-executive director of AB428 Limited (formerly known as Marine Force Limited) in August 2002. The company went into administrative receivership on 26 September 2002. The receivers are currently closing their administration and it does not appear that there will be any surplus funds to transfer to a liquidator.
- 4 Oliver Vaughan resigned as a director of Databeat Digital Music Systems Limitred in December 1991. This company was the subject of a creditors' voluntary winding-up which was commenced in February 1992 and completed in October 1994.
- 5 Ballynatray Holdings Plc, a company of which Oliver Vaughan was a director and from which he resigned on 19th May 1997 was placed in members voluntary liquidation on 19th May 1997 following its takeover by Internet Technology Group Plc and was solvent when this occurred.
