## **Replacement of Liquidator**

On 10 June 2022, an order was made in the High Court appointing Howard Smith as Joint Liquidator of the Company in place of Steve Absolom, following his resignation. In accordance with the order, members were given notice of the replacement of Steve Absolom as Joint Liquidator by advertisement in the London Gazette.

The declaration of solvency, sworn by the directors prior to the commencement of the liquidation, showed neither assets nor liabilities.

## **Creditors**

The Company had no known creditors.

A notice to creditors to prove their claims in the liquidation was advertised in the London Gazette on 20 January 2022. No creditors were forthcoming as a result of this advertisement.

## **Tax**

The Company's tax advisors advised that the Company had dormant tax status. Following their appointment, the Joint Liquidators sought and received confirmation

from HM Revenue and Customs ('HMRC') that the Company had no outstanding corporation tax returns or liabilities, that it would not raise enquiries into any pre or post liquidation periods and that it had no objection to the Joint Liquidators proceeding to finalise the liquidation.

A similar assurance was sought and received from HMRC in respect of PAYE and VAT matters.

### **Distributions**

There were no assets available for distribution to shareholders.

### **Joint Liquidators' remuneration and expenses**

A written resolution was passed on 10 January 2022 that the remuneration of the Joint Liquidators be fixed in accordance with the Interpath Ltd engagement letter dated 21 June 2021.

During the liquidation, the Joint Liquidators' remuneration (including the period prior to liquidation) and expenses totalling £4,679.69 have been paid by another group company, BFS Group Limited.
