- (a) securities and investments of any kind (including shares, stock, debentures, units, depositary receipts, bonds, notes, commercial paper and certificates of deposit);
- (b) warrants, options or other rights to subscribe for, purchase or otherwise acquire securities and investments;
- (c) all rights relating to securities and investments which are deposited with, or registered in the name of, any depositary, custodian, nominee, clearing house or system, investment manager, charges or other similar person or their nominee, in each case whether or not on a fungible basis (including rights against any such person); and

- (d) all other rights attaching or relating to securities or investments and all cash or other securities or investments in the future deriving from investments or such rights,

in each case now or in the future owned by it or (to the extent of its interest) in which it now or in the future has an interest.

"Liabilities" of a Chargor means all present and future moneys, debts and liabilities due, owing or incurred by it to any Finance Party under or in connection with any Finance Document (in each case, whether alone or jointly, or jointly and severally, with any other person, whether actually or contingently and whether as principal, surety or otherwise)

"LPA" means the Law of Property Act 1925.

"Party" means a party to this Deed

"Real Property" means freehold and leasehold property in England and Wales and other real property anywhere in the world (in each case including any estate or interest therein, all rights from time to time attached or relating thereto and all fixtures from time to time therein or thereon).

"Receiver" means a receiver and manager or other receiver appointed in respect of the Charged Assets and shall, if allowed by law, include an administrative receiver.

"Senior Facilities Agreement" means the senior facilities agreement dated 23 March 2007 as amended and restated on 5 April 2007, as further amended and restated on 29 May 2007, as further amended and restated on 20 June 2011 and as further amended and restated by an amendment and restatement agreement dated on or about the date of this Deed, between, amongst others, Trader Media Corporation (2003) Limited, Trader Media Corporation Limited, J.P. Morgan plc (now known as J.P. Morgan Limited) and BNP Paribas (now known as BNP Paribas Fortis S.A./N.V.) as Arranger, the Lenders named in that agreement and J.P. Morgan Europe Limited as Facility Agent.

"Shares" means

- (a) all present and future shares held by the Chargors, including the shares issued and outstanding at the date of this Deed described in Schedule 4 (*Investments*),
- (b) all warrants, options or other rights to subscribe for, purchase or otherwise acquire those shares, and
- (c) all rights relating to any of those shares which are deposited with, or registered in the name of, any depositary, custodian, nominee, clearing house or system, investment manager, chargee or other similar person or their nominee, in each case whether or not on a fungible basis (including rights against any such person)

"TPL Acquisition" means the acquisition by Trader Publishing Limited of legal title to the following properties:

- (i) Autotrader House, Cutbush Lane, Lower Earley, Reading, Berkshire, RG4 6UT, with title number BK262998;

(ii) Units 14-16 Phoenix Park, Avenue Road, Aston, Birmingham, with title number WM507972, and

(iii) Unit 10 Phoenix Park, Avenue Road, Aston, Birmingham, with title number WM499719.

1.2 Construction

Any reference in this Deed to a "Finance Document" or any other agreement or instrument is a reference to that Finance Document or other agreement or instrument as amended, novated, supplemented, extended, restated (however fundamentally and whether or not more onerous) or replaced and includes any change in the purpose of, any extension of or any increase in any facility or the addition of any new facility under that Finance Document or other agreement or instrument

The other provisions in clause 1.2 (*Construction*) of the Senior Facilities Agreement apply to this Deed with all necessary changes

In the event of any inconsistency between

(a) this Deed and the Senior Facilities Agreement then (to the extent permitted by law) the provisions of the Senior Facilities Agreement (as applicable) shall prevail;

(b) this Deed and the Intercreditor Agreement, then (to the extent permitted by law and notwithstanding the terms of the Senior Facilities Agreement) the Intercreditor Agreement shall prevail, and

(c) this Deed and any Transaction Security Document then this Deed shall prevail.

1.3 Third Party Rights

A person who is not a Party has no right under the Contracts (Rights of Third Parties) Act 1999 to enforce or to enjoy the benefit of any term of this Deed.

2. UNDERTAKING TO PAY

2.1 Payment of Liabilities

Each Chargor shall pay each of its Liabilities when due in accordance with its terms or, if they do not specify a time for payment, immediately on demand by the Security Agent

2.2 Proportionate payment

Each sum appropriated by the Security Agent in accordance with the Finance Documents in or towards payment of a particular part of the Liabilities shall to the extent of that appropriation discharge each Chargor's obligations in respect of that part of the Liabilities both to any Finance Party to which the same is owed, and to the Security Agent.

3. ASSIGNMENT

Each Chargor, with full title guarantee and as security for the payment of all Liabilities, assigns, subject to a proviso for reassignment on redemption, absolutely to the Security Agent all its present and future right, title and interest in and to

- (i) the Assigned Contracts, including all monies payable to the Chargor, and any claims, awards or judgements in favour of that Chargor, under or in connection with the Assigned Contracts; and
- (ii) all Insurances and all proceeds in respect of Insurances and all benefits of Insurances (including all claims relating to, and all returns of premium in respect of Insurances).

4. FIXED CHARGES

Each Chargor, with full title guarantee and as security for the payment of all Liabilities (whether of that or any other Chargor), charges in favour of the Security Agent (as trustee for the Finance Parties):

- (a) by way of first legal mortgage, the Real Property in England and Wales described in Schedule 3 (*Real Property*) now belonging to it;
- (b) by way of first fixed equitable charge, all other Real Property now belonging to it and all Real Property acquired by it in the future provided that any landlord or other third party consent has been obtained; and
- (c) by way of first fixed charge, all its present and future
 - (i) Book Debts;
 - (ii) Bank Accounts;
 - (iii) Investments (including the shares described in Schedule 4 (*Investments*)),
 - (iv) uncalled capital and goodwill;
 - (v) Intellectual Property (including that described in Schedule 5 (*Intellectual Property*));
 - (vi) beneficial interest in any pension fund; and
 - (vii) plant and machinery (except that mortgaged or charged by paragraph (a) or (b) of this Clause 4 but including that described in Schedule 6 (*Plant and machinery*)).

5. FLOATING CHARGE

5.1 Creation

Each Chargor, with full title guarantee and as security for the payment of all Liabilities (whether of that or any other Chargor), charges in favour of the Security Agent (as trustee for the Finance Parties) by way of first floating charge its undertaking and all its assets, both present and future (including assets expressed to be charged by Clause 4 (*Fixed charges*)).

5.2 Qualifying Floating Charge

- (a) The floating Charge created by each Chargor pursuant to Clause 5.1 above (*Creation*) is a "qualifying floating charge" for the purposes of paragraph 14.2(a) of Schedule B1 to the Insolvency Act

- (b) Paragraph 14 of Schedule B1 to the Insolvency Act shall apply to this Deed and the Security Agent may appoint an Administrator of any Chargor pursuant to that paragraph.

5.3 Ranking

The floating Charge created by each Chargor ranks:

- (a) behind all the fixed Charges created by that Chargor, but
- (b) in priority to any other Security over the Charged Assets of that Chargor except for any Security ranking in priority in accordance with paragraph (f) of Schedule 2 (*Rights of Receivers*).

5.4 Conversion by notice

The Security Agent may convert the floating Charge over all or any of the Charged Assets into a fixed Charge by notice to the relevant Chargor specifying the relevant Charged Assets (either generally or specifically) if it is necessary to do so in order to protect or preserve the Charges over those Charged Assets and/or the priority of those Charges by reason of any creditor taking any formal step to effect expropriation, attachment, sequestration, distress or execution against any of those Charged Assets.

5.5 Automatic conversion

If

- (a) any Chargor takes any step which is likely to result in breach of Clause 8.1 (*Security*) over any of the Charged Assets not subject to a fixed Charge; or
- (b) while an Enforcement Event has occurred and is continuing,

the floating Charge over the relevant Charged Assets shall automatically and immediately be converted into a fixed Charge.

The floating charge created under this Deed may not be converted into a fixed charge solely by reason of:

- (a) the obtaining of a moratorium; or
- (b) anything done with a view to obtaining a moratorium,

under Section 1A to the Insolvency Act 1986.

6 EXISTING FIXED AND FLOATING SECURITY AGREEMENTS

Each assignment, fixed charge and floating charge granted in or pursuant to this Agreement is granted expressly subject to each assignment, fixed charge and floating charge granted in or pursuant to the Existing Fixed and Floating Security Agreements until such time as the Existing Fixed and Floating Security Agreements cease to have effect.

7. ASSIGNED CONTRACTS

7.1 Documents

Any Chargor shall on or about the date of this Deed deliver (unless already held by the Security Agent pursuant to the Existing Fixed and Floating Security Agreements) to the Security Agent

copies of executed originals of all Assigned Contracts as now in effect, and shall promptly execute and/or deliver such other documents relating to the Assigned Contracts as the Security Agent reasonably requires.

7.2 Notice of assignment

Any Chargor shall following the occurrence of an Enforcement Event give notice of the assignments in Clause 3 (*Assignment*) substantially in the form set out in Schedule 7 (*Form of Notice of Assignment*) and shall use its reasonable endeavours to ensure that each recipient of any notice promptly signs and returns the form of acknowledgement requested in that notice

7.3 Chargor still liable

Each Chargor shall remain liable to perform all its obligations under the Assigned Contracts. Neither the Security Agent nor any Receiver or Delegate shall be under any obligation or liability to any Chargor or any other person under or in respect of any Assigned Contract.

7.4 Breach

Each Chargor shall notify the Security Agent of

- (a) any material breach of or default under an Assigned Contract by it or any other party;
- (b) any right of it or any other party arising to rescind, cancel or terminate an Assigned Contract, and
- (c) any claim made or to be made by it or any other party under or in connection with an Assigned Contract,

promptly on becoming aware of the same. Each Chargor shall provide the Security Agent with reasonable details of any such claim and its progress and notify the Security Agent as soon as practicable upon that claim being resolved

7.5 Performance of obligations

Each Chargor shall perform all its material obligations under each Assigned Contract

7.6 Exercise of rights

Each Chargor shall exercise all its material rights, powers and discretions under each Assigned Contract in accordance with the instructions of the Security Agent or otherwise in accordance with the terms of the Senior Facilities Agreement

8. RESTRICTIONS AND FURTHER ASSURANCE

8.1 Security

No Chargor shall create or permit to subsist any Security over any Charged Asset other than as permitted by the Finance Documents.

For the avoidance of doubt, this Deed shall not operate so as to prevent or require additional consents or authorisations in relation to transactions permitted under the Senior Facilities Agreement.

8.2 Disposal

No Chargor shall (nor shall any Chargor agree to) enter into a single transaction or a series of transactions (whether related or not and whether voluntary or involuntary) to sell, lease, license,

sub-license, transfer or otherwise dispose of any Charged Asset other than as permitted by the Finance Documents

For the avoidance of doubt, this Deed shall not operate so as to prevent or require additional consents or authorisations in relation to transactions permitted under the Senior Facilities Agreement.

8.3 Further assurance

Each Chargor shall promptly do whatever the Security Agent requires (acting reasonably in accordance with the Agreed Security Principles):

- (a) to perfect or protect the Charges or the priority of the Charges; or
- (b) to facilitate the realisation of the Charged Assets or the exercise of any rights vested in the Security Agent or any Receiver,

including executing any transfer, conveyance, charge, assignment or assurance of the Charged Assets (whether to the Security Agent or its nominees or otherwise), making any registration and giving any notice, order or direction (to the extent not inconsistent with any other provisions of this Deed).

9. REAL PROPERTY

9.1 Acquisition

Each Chargor shall promptly notify the Security Agent of its acquisition of, or agreement to acquire, any Real Property (such notice having been given in respect of the TPL Acquisition).

9.2 Documents

Each Chargor shall (unless already held by the Security Agent pursuant to the Existing Fixed and Floating Security Agreements) deposit with the Security Agent, and the Security Agent shall be entitled to hold, all title deeds and documents relating to that Chargor's present and future Real Property, such title deeds and documents in respect of the TPL Acquisition shall be deposited as soon as reasonably practicable

9.3 Existing Real Property

In the case of a Chargor's existing Real Property in England and Wales, that Chargor shall:

- (a) promptly apply to H.M. Land Registry for first registration of that Real Property (where that Real Property is not already registered at H.M. Land Registry) and registration of that Chargor as proprietor of that Real Property;
- (b) promptly apply to H.M. Land Registry to register the first legal mortgage created by paragraph (a) of Clause 4 (*Fixed Charges*) (subject to the first legal mortgage created by the Existing Fixed and Floating Security Agreements) and all other Charges;
- (c) promptly submit to H.M. Land Registry the duly completed Form RX1 requesting a restriction in the form specified by the Security Agent to be entered on the register of the title to that Real Property in respect of the Charge created by paragraph (a) of Clause 4 (*Fixed Charges*); and
- (d) promptly pay all appropriate registration fees,

or, if the Security Agent gives notice to that Chargor that the Security Agent will submit the relevant forms to H.M. Land Registry, that Chargor shall promptly provide the Security Agent with all duly completed forms reasonably requested by the Security Agent and all appropriate registration fees.

9.4 Future Real Property

In the case of a Chargor's future Real Property in England and Wales, that Chargor shall:

- (a) promptly apply to H.M. Land Registry for first registration of that Real Property (where that Real Property is not already registered at H.M. Land Registry) and registration of that Chargor as proprietor of that Real Property;
- (b) promptly apply to H.M. Land Registry to register the first fixed equitable charge created by paragraph (b) of Clause 4 (*Fixed Charges*) (subject to the first legal mortgage created by the Existing Fixed and Floating Security Agreements);
- (c) promptly apply to H.M. Land Registry requesting a restriction in the form specified by the Security Agent to be entered on the register of the title to that Real Property in respect of the Charge created by paragraph (b) of Clause 4 (*Fixed Charges*); and
- (d) promptly pay all appropriate registration fees,

or, if the Security Agent gives notice to that Chargor that the Security Agent will submit the relevant forms to H.M. Land Registry, that Chargor shall promptly provide the Security Agent with all duly completed forms reasonably requested by the Security Agent and all appropriate registration fees.

9.5 Unregistered Real Property

In the case of a Chargor's Real Property in England and Wales, both present and future, which is not registered at H.M. Land Registry and is not required to be so registered, that Chargor will promptly apply to register this Deed and the Charges at the Land Charges Registry if the title deeds and documents are not deposited with the Security Agent.

9.6 Legal charge

As security for the Liabilities, each Chargor shall promptly execute and deliver to the Security Agent such legal charge of such of its Real Property from time to time in England and/or Wales as the Security Agent reasonably requires acting in accordance with the Agreed Security Principles. The relevant Chargor shall promptly apply to H.M. Land Registry for registration of any such legal charge in the same way as set out in paragraphs (a) - (d) of Clause 9.3 (*Existing Real Property*), unless the Security Agent gives notice to that Chargor in relation to registration of such legal charge in the same way as set out in Clause 9.3 (*Existing Real Property*).

9.7 Title Information Document

On completion of the registration of any Charge pursuant to this Clause 9, the relevant Chargor shall promptly supply to the Security Agent a certified copy of the relevant Title Information Document issued by H.M. Land Registry.

9.8 Consents

Save to the extent mortgaged, charged or assigned under the Existing Fixed and Floating Security Agreements, each Chargor shall use its reasonable endeavours to obtain third party consents necessary to mortgage, charge or assign any Charged Assets in accordance with this Deed.

10. BOOK DEBTS

10.1 Collection

Upon the occurrence of an Enforcement Event, each Chargor shall collect all Book Debts when due in the ordinary course of business and shall hold the proceeds of collection on trust for the Finance Parties.

10.2 Payment into designated Bank Account(s)

Each Chargor shall promptly pay all proceeds of collection of Book Debts into a Bank Account.

10.3 Restrictions on dealing with Book Debts

Without prejudice and in addition to Clauses 8.1 (*Security*), 8.2 (*Disposal*) and 8.3 (*Further assurance*).

- (a) except for the Charges, no Chargor shall create or permit to subsist any Security over, all or any part of any of its Book Debts other than as permitted by the Finance Documents; and
- (b) except as required by Clause 8.3 (*Further assurance*), no Chargor shall enter into a single transaction or a series of transactions (whether related or not and whether voluntary or involuntary) to sell, factor, transfer or otherwise dispose of all or any part of any of its Book Debts other than as permitted by the Finance Documents.

11. BANK ACCOUNTS

11.1 Restriction on Bank accounts

Each Chargor undertakes not to establish or maintain any bank accounts with any banks or financial institution unless that Chargor grants Security over such bank account in favour of the Security Agent pursuant to the same or equivalent terms as the Charges (subject to the Agreed Security Principles). Upon the opening of any bank account after the date of this Deed, each Chargor undertakes to notify the Security Agent promptly of such bank account.

11.2 Notification of Bank Accounts

Each Chargor shall.

- (a) within 5 Business Days of the date of this Deed (and if any changes occur thereafter, within 10 Business Days of the date thereof) deliver to the Security Agent (unless already held by the Security Agent pursuant to the Existing Fixed and Floating Security Agreements) details of each Bank Account maintained by it with any bank or financial institution; and
- (b) prior to an Enforcement Event, deliver to the relevant bank holding the Bank Accounts, notification of the charges over the Bank Accounts.

11.3 Restrictions on dealing with Bank Accounts

Without prejudice and in addition to Clauses 8.1 (*Security*), 8.2 (*Disposal*) and 8.3 (*Further assurance*):

- (a) except for the Charges or as permitted by the Finance Documents, no Chargor shall create or have outstanding any Security over all or any part of any of its Bank Accounts; and
- (b) except as required by Clause 8.3 (*Further assurance*) or as permitted by the Finance Documents, no Chargor shall enter into a single transaction or a series of transactions (whether related or not and whether voluntary or involuntary) to transfer, assign or otherwise dispose of all or any part of any of its Bank Accounts

12. INVESTMENTS

12.1 Documents

Each Chargor shall

- (a) except to the extent the Security Agent notifies that Chargor from time to time to the contrary, deposit with the Security Agent (unless already held by the Security Agent pursuant to the Existing Fixed and Floating Security Agreements), or as it directs, all certificates representing:
 - (i) Shares; and
 - (ii) all other Investments having an aggregate value of at least £5,000,000; and
- (b) execute and/or deliver to the Security Agent (unless already held by the Security Agent pursuant to the Existing Fixed and Floating Security Agreements) such other documents relating to:
 - (i) Shares; and
 - (ii) all other Investments having an aggregate value of at least £5,000,000, including transfers of Investments executed in blank, as the Security Agent requires.

and for the avoidance of doubt this Clause 12.1 shall not apply to shares held in non-Obligor Members of the Group.

12.2 Voting before the Acceleration Date

Subject to Clause 12.3 (*Voting after the Acceleration Date*), each Chargor shall be entitled to retain and exercise the voting and other rights attached to any Investment as it sees fit provided that:

- (a) it does so for a purpose not inconsistent with any Finance Document; and
- (b) the exercise of or failure to exercise those rights would not have an adverse effect on the validity or enforceability of the Security created under this Deed or cause an Event of Default to occur,

and for the avoidance of doubt, the Chargors shall be permitted to pay dividends upstream on the Investments to the extent permitted under the Senior Facilities Agreement.

12.3 Voting after the Acceleration Date

Following the occurrence of the Acceleration Date:

- (a) the Security Agent or the Receiver shall be entitled to exercise or direct the exercise of the voting and other rights attached to any Investment in such manner as it or he sees fit, and
- (b) each Chargor shall comply or procure the compliance with any directions of the Security Agent or the Receiver in respect of the exercise of those rights and shall promptly execute and/or deliver to the Security Agent or the Receiver such forms of proxy as it or he requires with a view to enabling such person as it or he selects to exercise those rights.

13. INTELLECTUAL PROPERTY

13.1 Acquisition

Each Chargor shall promptly notify the Security Agent of its becoming the legal and/or beneficial owner of or of its acquisition of, or agreement to acquire, (by licence or otherwise) any Intellectual Property that is material to its business, and any application by it or on its behalf to register any Intellectual Property.

13.2 Grant

Without prejudice to Clause 8.2 (*Disposal*), no Chargor shall grant any exclusive registered user agreement or exclusive licence in relation to any of its present or future Intellectual Property except as permitted by the Finance Documents.

14. INSURANCE

14.1 Documents

Each Chargor shall promptly execute and/or deliver to the Security Agent (unless already held by the Security Agent pursuant to the Existing Fixed and Floating Security Agreements) a copy of such insurance policies effected by it and the related premium receipts, and of such other documents relating to the Insurances, as the Security Agent reasonably requires.

14.2 Lender may insure

If any Chargor fails on demand to produce copies of insurance policies, premium receipts and such other evidence as the Security Agent requires, the Security Agent may (at that Chargor's expense and after giving written notice to the Chargor and allowing the Chargor a reasonable time to remedy such failure) arrange such insurances of the assets of that Chargor or any of them as it thinks fit.

15. ENFORCEMENT

15.1 When enforceable

As between the Chargors and the Security Agent the Charges shall be enforceable while an Enforcement Event is continuing.

15.2 Power of sale

The statutory power of sale, of appointing a Receiver and the other statutory powers conferred on mortgagees by Section 101 of the LPA as varied and extended by this Deed shall arise on the date of this Deed (and shall be exercisable after this Deed has become enforceable).

15.3 Section 103 LPA

Section 103 of the LPA shall not apply to this Deed.

16. APPOINTMENT AND RIGHTS OF RECEIVERS

16.1 Appointment of receivers

If:

- (a) requested by any Chargor; or
- (b) any other Enforcement Event has occurred and is continuing (whether or not the Security Agent has taken possession of the Charged Assets),

without any notice or further notice, the Security Agent may, by deed, or otherwise in writing signed by any officer or manager of the Security Agent or any person authorised for this purpose by the Security Agent, appoint one or more persons to be a Receiver. The Security Agent may similarly remove any Receiver and appoint any person instead of any Receiver. If the Security Agent appoints more than one person as Receiver, the Security Agent may give those persons power to act either jointly or severally

16.2 Scope of appointment

Any Receiver may be appointed Receiver of all of the Charged Assets or Receiver of a part of the Charged Assets specified in the appointment. In the latter case, the rights conferred on a Receiver as set out in Schedule 2 (*Rights of Receivers*) shall have effect as though every reference in that Schedule to any Charged Assets were a reference to the part of those assets so specified or any part of those assets.

16.3 Rights of Receivers

Any Receiver appointed pursuant to this Clause 15 shall have the rights, powers, privileges and immunities conferred by the Insolvency Act on administrative or other receivers duly appointed under the Insolvency Act, and shall also have the rights set out in Schedule 2 (*Rights of Receivers*)

16.4 Agent of Chargor

Any Receiver shall be the agent of the relevant Chargor for all purposes. That Chargor alone shall be responsible for the Receiver's contracts, engagements, acts, omissions, defaults and losses and for liabilities incurred by the Receiver.

16.5 Remuneration

The Security Agent may determine the remuneration of any Receiver and direct payment of that remuneration out of moneys he receives as Receiver. The relevant Chargor alone shall be liable for the remuneration and all other costs, losses, liabilities and expenses of the Receiver.

17 SECURITY AGENT'S RIGHTS

17.1 Same rights as Receiver

Any rights conferred by any Finance Document upon a Receiver may be exercised by the Security Agent, or to the extent permitted by law, an Administrator after the Charges become enforceable, whether or not the Security Agent shall have taken possession or appointed a Receiver of the Charged Assets.

17.2 Delegation

The Security Agent may delegate in any manner to any person any rights exercisable by the Security Agent under any Finance Document. Any such delegation may be made upon such terms and conditions (including power to sub-delegate) as the Security Agent thinks fit.

17.3 Financial collateral arrangement

To the extent that this Deed constitutes a "financial collateral arrangement" (as defined in the Financial Collateral Arrangements (No. 2) Regulations 2003 (the "Regulations")) the Security Agent shall have the right

- (a) to use and dispose of any Charged Asset which constitutes "financial collateral" (as defined in the Regulations ("Financial Collateral")), in which case the Security Agent shall comply with the requirements of the Regulations as to obtaining "equivalent financial collateral" (as defined in the Regulations); and
- (b) (at any time after the Charges become enforceable) to appropriate any Charged Asset which constitutes Financial Collateral in or towards satisfaction of the Liabilities in accordance with the Regulations.

18. ORDER OF DISTRIBUTIONS

18.1 Application of proceeds

All amounts received or recovered by the Security Agent or any Receiver or Delegate in exercise of their rights under this Deed shall, subject to the rights of any creditors having priority, be applied in the order provided in Clause 18.2 (*Order of distributions*).

18.2 Order of distributions

All amounts received or recovered by the Security Agent or any Delegate in the exercise of their rights under this Deed shall be applied in accordance with the Intercreditor Agreement

19. LIABILITY OF SECURITY AGENT, RECEIVERS AND DELEGATES

19.1 Possession

If the Security Agent, any Receiver or any Delegate takes possession of the Charged Assets, it or he may at any time relinquish possession. Without prejudice to Clause 19.2 (*Security Agent's liability*), the Security Agent shall not be liable as a mortgagee in possession by reason of viewing or repairing any of the present or future assets of any Chargor

19.2 Security Agent's liability

Neither the Security Agent nor any Receiver or Delegate shall (either by reason of taking possession of the Charged Assets or for any other reason and whether as mortgagee in

possession or otherwise) be liable to any Chargor, any Finance Party or any other person for any costs, losses, liabilities or expenses relating to the realisation of any Charged Assets or from any act, default, omission or misconduct of the Security Agent, any Receiver, any Delegate or their respective officers, employees or agents in relation to the Charged Assets or in connection with the Finance Documents except to the extent caused by its or his own gross negligence or wilful misconduct

20. POWER OF ATTORNEY

20.1 Appointment

Each Chargor by way of security irrevocably appoints the Security Agent, every Receiver and every Delegate severally its attorney (with full power of substitution), on its behalf and in its name or otherwise, at such time and in such manner as the attorney thinks fit.

- (a) to do anything which that Chargor is obliged to do (but has not done) under any Finance Document in connection with the Security created under this Deed to which it is party (including to execute charges over, transfers, conveyances, assignments and assurances of, and other instruments, notices, orders and directions relating to, the Charged Assets), and
- (b) to exercise any of the rights conferred on the Security Agent, any Receiver or any Delegate in relation to the Charged Assets or under any Finance Document, the LPA or the Insolvency Act.

In each case (other than in relation to any initial registration of the Security created under this Deed) following the occurrence of an Enforcement Event which is continuing or a material failure by an Obligor to comply with a written request to fulfil a further assurance or perfection obligation

20.2 Ratification

Each Chargor ratifies and confirms and agrees to ratify and confirm whatever any such attorney shall do in the exercise or purported exercise of the power of attorney granted by it in Clause 20.1 (*Appointment*)

21. PROTECTION OF THIRD PARTIES

21.1 No duty to enquire

No person dealing with the Security Agent, any other Finance Party, any Receiver or any Delegate shall be concerned to enquire

- (a) whether the rights conferred by or pursuant to any Finance Document are exercisable,
- (b) whether any consents, regulations, restrictions or directions relating to such rights have been obtained or complied with;
- (c) otherwise as to the propriety or regularity of acts purporting or intended to be in exercise of any such rights, or
- (d) as to the application of any money borrowed or raised.

21.2 Protection to purchasers

All the protection to purchasers contained in Sections 104 and 107 of the LPA, Section 42(3) of the Insolvency Act or in any other applicable legislation shall apply to any person purchasing from or dealing with the Security Agent, any other Finance Party, any Receiver or any Delegate.

22 SAVING PROVISIONS

22.1 Continuing Security

Subject to Clause 23 (*Discharge of Security*), the Charges are continuing Security and will extend to the ultimate balance of the Liabilities, regardless of any intermediate payment or discharge in whole or in part.

22.2 Reinstatement

If any payment by a Chargor or any discharge given by a Finance Party (whether in respect of the obligations of a Chargor or any security for those obligations or otherwise) is avoided or reduced as a result of insolvency or any similar event

- (a) the liability of each Chargor and the Charges shall continue as if the payment, discharge, avoidance or reduction had not occurred, and
- (b) each Finance Party shall be entitled to recover the value or amount of that security or payment from each Chargor, as if the payment, discharge, avoidance or reduction had not occurred.

22.3 Waiver of defences

Neither the obligations of each Chargor under this Deed nor the Charges will be affected by an act, omission, matter or thing which, but for this Clause, would reduce, release or prejudice any of its obligations under any Finance Document of any of the Charges (without limitation and whether or not known to it or any Finance Party) including:

- (a) any time, waiver or consent granted to, or composition with, a Chargor or other person;
- (b) the release of any other Obligor or any other person under the terms of any composition or arrangement with any creditor of any member of the Group;
- (c) the taking, variation, compromise, exchange, renewal or release of, or refusal or neglect to perfect, take up or enforce any rights against, or security over assets of, a Chargor or other person or any non-presentation or non-observance of any formality or other requirement in respect of any instrument or any failure to realise the full value of any security;
- (d) any incapacity or lack of power, authority or legal personality of or dissolution or change in the members or status of a Chargor or any other person;
- (e) any amendment (however fundamental) or replacement of a Finance Document or any other document or security,
- (f) any unenforceability, illegality or invalidity of any obligation of any person under any Finance Document or any other document or security, or
- (g) any insolvency or similar proceedings

22.4 Immediate recourse

Each Chargor waives any right it may have of first requiring any Finance Party (or any trustee or agent on its behalf) to proceed against or enforce any other rights or security or claim payment from any person before claiming from that Chargor under this Deed. This waiver applies irrespective of any law or any provision of a Finance Document to the contrary.

22.5 Appropriations

Until all the Liabilities have been irrevocably paid in full and all facilities which might give rise to Liabilities have terminated, each Finance Party (or any trustee or agent on its behalf) may

- (a) refrain from applying or enforcing any other moneys, security or rights held or received by that Finance Party (or any trustee or agent on its behalf) in respect of those amounts, or apply and enforce the same in such manner and order as it sees fit (whether against those amounts or otherwise) and no Chargor shall be entitled to the benefit of the same; and
- (b) hold in an interest-bearing suspense account any moneys received from any Chargor or on account of any Chargor's liability under this Deed

22.6 Deferral of Chargors' rights

Until all the Liabilities have been irrevocably paid in full and all facilities which might give rise to Liabilities have terminated and unless the Security Agent otherwise directs, no Chargor will exercise any rights which it may have by reason of performance by it of its obligations under the Finance Documents

- (a) to be indemnified by an Obligor, and/or
- (b) to claim any contribution from any other Chargor or any other guarantor of any Obligor's obligations under the Finance Documents; and/or
- (c) to take the benefit (in whole or in part and whether by way of subrogation or otherwise) of any rights of the Finance Parties under the Finance Documents or of any guarantee or other security taken pursuant to, or in connection with, the Finance Documents by any Finance Party.

22.7 Additional Security

The Charges are in addition to and are not in any way prejudiced by any other guarantees or security now or subsequently held by any Finance Party.

22.8 Tacking

Each Finance Party shall comply with its obligations under the Finance Documents (including any obligation to make further advances).

23. DISCHARGE OF SECURITY

23.1 Final redemption

Subject to Clause 23.2 (*Retention of Security*), the Security Agent shall at the request and cost of the Chargors release, reassign or discharge (as appropriate) the Charged Assets from the Charges (i) in accordance with clauses 27.4 (*Release of Guarantors*) and 27.8 (*Release of*

Security) of the Senior Facilities Agreement or pursuant to a consent or waiver granted pursuant to paragraph (c) of clause 37.2 (*Exceptions*) of the Senior Facilities Agreement, (ii) If the Security Agent is satisfied that all the Liabilities have been irrevocably paid in full and that all facilities which might give rise to Liabilities have terminated; or (iii) in accordance with the provisions of the Intercreditor Agreement

23.2 Retention of security

If the Security Agent considers that any amount paid or credited to any Finance Party under any Finance Document is capable of being avoided or otherwise set aside, that amount shall not be considered to have been paid for the purposes of determining whether all the Liabilities have been irrevocably paid

23.3 Consolidation

Section 93 of the LPA shall not apply to the Charges.

24 ENFORCEMENT EXPENSES

24.1 Expenses

Each Chargor shall, within five Business Days of demand, pay (or procure payment) to each Finance Party the amount of all costs and expenses (including legal fees and notarial costs) incurred by any Receiver or any Delegate in connection with the enforcement of or the preservation of any rights, powers and remedies under any Finance Document and the Transaction Security.

24.2 Value Added Tax

Clause 16.6 (*Value Added Tax*) of the Senior Facilities Agreement (with any necessary consequential amendments) shall apply also to any amount payable under any Finance Document to any Receiver or Delegate.

25 PAYMENTS

25.1 Demands

Any demand for payment made by any Finance Party shall be valid and effective even if it contains an inaccurate or incomplete statement of the relevant Liabilities.

25.2 Payments

All payments by any Chargor under this Deed (including damages for its breach) shall be made in the Currency of Account and to such account, with such financial institution and in such other manner as the Security Agent may direct.

25.3 Continuation of accounts

At any time after

- (a) the receipt by any Finance Party of notice (either actual or otherwise) of any subsequent Security affecting the Charged Assets of any Chargor; or
- (b) the presentation of a petition or the passing of a resolution in relation to the winding-up of any Chargor.

any Finance Party may open a new account in the name of that Chargor with that Finance Party (whether or not it permits any existing account to continue). If that Finance Party does not open such a new account, it shall nevertheless be treated as if it had done so when the relevant event occurred. No moneys paid into any account, whether new or continuing, after that event shall discharge or reduce the amount recoverable pursuant to any Finance Document to which that Chargor is party

25.4 Joint and several liability

The liability of each Chargor under this Deed shall be joint and several. Each agreement and undertaking of any Chargor shall be construed accordingly.

26. LIMITATIONS

In respect of a Chargor incorporated under the laws of England and Wales, this Deed does not apply to any liability to the extent that it would result in this Deed constituting unlawful financial assistance within the meaning of section 151 of the Companies Act 1985.

27. RIGHTS, WAIVERS AND DETERMINATIONS

27.1 Ambiguity

Where there is any ambiguity or conflict between the rights conferred by law and those conferred by or pursuant to any Finance Document, the terms of that Finance Document shall prevail.

27.2 Exercise of rights

No failure to exercise, nor any delay in exercising, on the part of any Finance Party, Receiver or Delegate, any right or remedy under any Finance Document shall operate as a waiver, nor shall any single or partial exercise of any right or remedy prevent any further or other exercise or the exercise of any other right or remedy. The rights and remedies provided in the Finance Documents are cumulative and not exclusive of any rights or remedies provided by law, including the right to appoint an Administrator under the Insolvency Act.

27.3 Determinations

Any certification or determination by any Finance Party or any Receiver or Delegate under any Finance Document is, in the absence of manifest error, conclusive evidence of the matters to which it relates.

28. SEPARATE AND INDEPENDENT OBLIGATIONS

The Security created by each Chargor by or in connection with any Finance Document is separate from and independent of the Security created or intended to be created by any other Chargor by or in connection with any Finance Document.

29. COUNTERPARTS

This Deed may be executed in any number of counterparts, and this has the same effect as if the signatures on the counterparts were on a single copy of this Deed.

30. GOVERNING LAW

This Deed and any non-contractual obligations arising out of or in connection with it are governed by English law

In witness whereof this Deed has been duly delivered on the date stated at the beginning of this Deed.

SCHEDULE 2
RIGHTS OF RECEIVERS

Any Receiver appointed pursuant to Clause 16 (*Appointment and rights of Receivers*) shall have the right, either in his own name or in the name of the relevant Chargor or otherwise and in such manner and upon such terms and conditions as the Receiver thinks fit, and either alone or jointly with any other person.

(a) Enter Into possession

to take possession of, get in and collect the Charged Assets, and to require payment to him or to any Finance Party of any Book Debts or credit balance on any Bank Account;

(b) Carry on business

to manage and carry on any business of that Chargor;

(c) Contracts

to enter into any contract or arrangement and to perform, repudiate, rescind or vary any contract or arrangement to which that Chargor is a party;

(d) Deal with Charged Assets

to sell, transfer, assign, exchange, hire out, lend or otherwise dispose of or realise the Charged Assets (including any Fixtures, which may be sold separately from the related Real Property) to any person (including a new company formed pursuant to paragraph (e) (*Hive down*)) either by public offer or auction, tender or private contract and for a consideration of any kind (which may be payable or delivered in one amount or by instalments spread over a period or deferred),

(e) Hive down

to form a new company and to subscribe for or acquire (for cash or otherwise) any investment in or of the new company and to sell, transfer, assign, exchange and otherwise dispose of or realise any such investments or part thereof or any rights attaching thereto,

(f) Borrow money

to borrow or raise money either unsecured or on the security of the Charged Assets (either in priority to the Charges or otherwise),

(g) Covenants and guarantees

to enter into bonds, covenants, guarantees, indemnities and other commitments and to make all payments needed to effect, maintain or satisfy them;

(h) Dealings with tenants

to grant leases, tenancies, licences and rights of user, grant renewals and accept surrenders of leases, tenancies, licences or rights of user, and otherwise to reach agreements and make arrangements with, and to make allowances to, any lessees, tenants or other persons (including a new company formed pursuant to paragraph (e) (*Hive down*)) from whom any rents and profits may be receivable (including those relating to the grant of any licences, the review of rent in

accordance with the terms of, and the variation of, the provisions of any leases, tenancies, licences or rights of user affecting the Charged Assets);

(i) Rights of ownership

to manage and use the Charged Assets and to exercise and do (or permit that Chargor or any nominee of it to exercise and do) all such rights and things as the Receiver would be capable of exercising or doing if he were the absolute beneficial owner of the Charged Assets;

(j) Insurance, repairs, improvements etc.

to insure the Charged Assets, to carry out decorations, repairs, alterations, improvements and additions to the Charged Assets (including the development or redevelopment of any Real Property) and to purchase or otherwise acquire or do anything in connection with the Charged Assets;

(k) Claims

to settle, adjust, refer to arbitration, compromise and arrange any claims, accounts, disputes, questions and demands with or by any person who is or claims to be a creditor of that Chargor or relating to the Charged Assets,

(l) Legal actions

to bring, prosecute, enforce, defend and abandon actions, suits and proceedings in relation to the Charged Assets or any business of that Chargor,

(m) Redemption of Security

to redeem any Security (whether or not having priority to the Charges) over the Charged Assets and to settle the accounts of any person with an interest in the Charged Assets;

(n) Employees etc.

to appoint, hire and employ officers, employees, contractors, agents, advisors and others and to discharge any such persons and any such persons appointed, hired or employed by that Chargor;

(o) Insolvency Act

to exercise all powers set out in Schedule 1, Schedule B1 or (in the case of a Scottish Receiver) Schedule 2 to the Insolvency Act as now in force (whether or not in force at the date of exercise and whether or not the Receiver is an administrative receiver) and any powers added to Schedule 1 or Schedule 2, as the case may be, after the date of this Deed, and

(p) Other powers

to do anything else he may think fit for the realisation of the Charged Assets or incidental to the exercise of any of the rights conferred on the Receiver under or by virtue of any Finance Document to which the relevant Chargor is party, the LPA or the Insolvency Act.

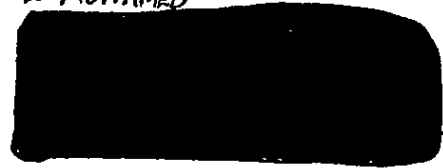

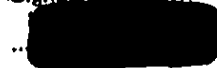
