Introduction

Rural Arts is a registered charity that delivers inspiring and inclusive creative opportunities that enrich lives and connect communities. Working across 3,500 square miles of England's largest county, our vision is creativity in every community in North Yorkshire.

At The Courthouse – Rural Arts' HQ and North Yorkshire's only professionally-run, cross-discipline arts centre – we provide over 400 events and activities each year for local residents and visitors alike. Alongside a public programme of exhibitions, performances, screenings and workshops, we offer a range of participatory programmes and balance our financial sustainability with a café, gallery shop and venue hire (operated by trading subsidiary, Rural Arts Trading Ltd.)

Through ON Tour – our rural touring scheme, servicing North Yorkshire, East Cleveland and the Tees Valley – we programme 70 professional performances per year in rural venues. We work with dedicated volunteers in local communities across the county to ensure that living rurally does not isolate communities from culture and creativity, be that music, dance, theatre or family shows.

With our participatory programmes – which also stretch across all of North Yorkshire – we reach some of the most rurally isolated and vulnerable people within the region. Our work has a strong focus on arts as a conduit for improving health and wellbeing, reducing loneliness and developing life and employability skills. By working closely with partners across the third and public sector, as well as statutory and Trust and Foundation funders, we enrich individual's lives and build community cohesion across North Yorkshire.

Rural Arts was founded in 1993 and is an Arts Council England National Portfolio Organisation.

In February 2019, founder-director Angela Hall retired, making 2019-20 the first financial year under the leadership of Max May.

Our Mission

2019 saw an exciting revisioning process for Rural Arts that helped set the course and reaffirm our ambitions for the organisation's future under new leadership.

The process involved all staff and Trustees and a strong consensus was found for our new mission, vision and values, which re-emphasised rather than redirected our existing understanding.

Our vision is "creativity in every community in North Yorkshire"

Our mission is "enriching lives and connecting communities through inspiring and inclusive creative opportunities".

Our values are to be inclusive, passionate, enriching, innovative and ambitious.

Our aims were updated to reflect our new mission, vision and values:

- 7. Champion diversity in all of its forms

Headline Achievements

2019/20 was both an incredibly challenging and incredibly successful year. Due to historic financial difficulties, March 2019 saw significant restructuring and the cessation of some activities. Throughout the year, the staff have worked tirelessly to rebalance our financial operations and revitalise our offer to North Yorkshire. The Trustees wish to thank them all for their hard work, dedication and sacrifices throughout the year. The staff themselves are Rural Arts' headline achievement for the year 2019/20. Others include:

Outreach Programmes

Heart and Craft: creative workshops for older people

Our two-year action research project Art on Your Doorstep, funded by Arts Council England and The Baring Foundation, concluded in February 2019, having reached over 1200 people. We secured funding from the National Lottery Community Fund to develop the project in eight rural locations, including The Courthouse in Thirsk. Over 2019/20, we led 100 workshops receiving 1283 engagements from 174 individuals. Many of the groups have put on additional workshops for their communities, including half-term intergenerational workshops. The project was an immediate success, and has provided vital social interaction, community development and even end-of-life support for people between 55 and 100 in North Yorkshire.

Monday Makers: creative business skills for unemployed people

We received funding for a new programme to support the development of creative business skills for unemployed people across North Yorkshire through the ESF Community Grants programme. We have developed a new ten-week structure to the course that has proved highly successful and will be replicated in future.

Action Towards Inclusion: creative wellbeing interventions for those furthest from education, employment or training

We continued to develop our delivery on Action Towards Inclusion and towards the end of the year secured a further three year contract to expand our delivery across a further two districts.

ArtBeat: An art doctor for North Yorkshire

At the very end of the year, funding was secured for a flagship new programme that will be transformational for the health and wellbeing of people living in care homes and those housebound across North Yorkshire. The innovative new scheme will see the employment of a full time 'art doctor' who will provide both group and one-on-one interventions in care homes and individuals' houses across the county. Unfortunately the March 2020 COVID-19 outbreak has postponed the launch of the programme until at least Spring 2021.

ON Tour

During the year 19/20, ON Tour reached 3,602 people through 71 performances in 70 venues, engaging 60 performers. Due to the cessation of Create Tour, a three-year funded ON Tour project, our overall reach through the programme has reduced however the scheme itself continues to go from strength to strength, particularly in our developing relationships with other rural touring schemes, regional producers and presenters and international partners.

The Courthouse

The year 19/20 saw an important shift for The Courthouse, rebalancing our funding streams so that some strands of deliveries – e.g. visual arts workshops – returned a surplus to the organisation, from which the wider charity and its outreach work across the county could be supported.

Visual arts workshops at Rural Arts had their most successful year ever, with 214 workshops reaching 1273 and generating an overall surplus to subsidise other activities. The re-introduction of screenings was also a success, with 11 titles reaching 416 audience members. In total, we worked with 234 artists at The Courthouse over the year, and welcomed an additional 19,170 visitors, and received 125 room hires.

During the year, capital investment for redevelopment of The Courthouse was secured from Arts Council England and the Peter Sowerby Foundation. We look forward to bringing this project to fruition over the upcoming financial year.

Financial Review

In 2019/20 Rural Arts turnover increased to £353,072, funded by diverse income streams including multi-year grants, one-off project grants, earned income and donations from individuals, companies and our Trading Subsidiary. A total surplus of £70,369 is recorded, £64,000 of which can be contributed to Rural Arts' unrestricted reserves. Following a number of challenging years, this is a significant achievement. Unfortunately, the Coronavirus pandemic forced the suspension of all Rural Arts' activities two weeks before the end of the financial year, so this contribution to reserves is likely to be put into immediate use. Whilst this safeguards the future of the charity, it may not do so in as long-term a manner as had been hoped.

Arts Council England continue to be a major funder, both through core funding and strategic project grants. A total of £84,490.90 was received in the year 2019/20, comprising £75,509 of National Portfolio Organisation funding and £10,495 from the Strategic Touring fund.

ON Tour had a total income of £58,186.82, £23,755.00 of which was designated internally from Arts Council England National Portfolio funding, £3,000 from Craven District Council and £5,145.42 from small grants and other sources, including the National Rural Touring Forum, the Rural Touring Dance Initiative and £1,000 of sponsorship. The remaining £26,286.40 (41%) was income generated by ticket sales and performance fees, represents a healthy balance for the organisation's overall financial sustainability.

Visual arts workshops at The Courthouse generated income of £46,220.49, whilst performances and other activity generated £8,463.66. The sale of workshops outside The Courthouse generated income of £7322.50.

For other Outreach projects, £27,236 was received from North Yorkshire County Council for the delivery of Community Learning, and £25,000 for ArtBeat.

From Your Consortium we received £9778.80 for our delivery of Action Towards Inclusion and £6,900 from Community Grants 5 to deliver Monday Makers.

£43,530.16 was received from the National Lottery Community Fund for Heart and Craft.

FUSE had a total income of £29,844.60. £15,770 was received from Your Consortium, £9,680 from the Awards for All programme at the National Lottery Community Fund, and £2,012 from The LOCAL Fund as administered by the Two Ridings Community Foundation. The remaining income constituted £1,035 of donations and £1,347.60 of voluntary participant contributions.

A further £698 was raised in donations and fundraising events, alongside £422 from the sale of Gift Vouchers and £5.32 in bank interest.

 \pounds 13,891 was donated by our trading subsidiary, Rural Arts Trading Ltd, as surplus from the café, gallery shop and room hire activity.

Rural Arts has a strict system of financial controls in place, which includes two-person authorisation of all payments, monthly meetings with the Finance Committee and monthly management accounts. We have a policy to increase our reserves until we realise our reserves target (see note on reserves).

Organisational Development

Finance and Fundraising

During the year 19/20, Rural Arts invested heavily in the sustainability of the organisation, reviewing and renewing our business model as well as increasing fundraising substantially. This focus on finance and fundraising will continue throughout 2020-21 and beyond.

Policies and Procedures

We review all policies and procedures annually to ensure compliance with law and, where possible, the delivery of best practice inclusive support for the communities we work with.

We have an ongoing commitment to equality and diversity, as evidenced by our Single Equality Action Plan, and recognise our role in combatting the climate emergency through our Environmental Action Plan and Green Touring policies for promoters and performers alike. We have actively reviewed policies around data management, safeguarding, whistleblowing, personnel and more.

Structure, Governance and Management

Rural Arts was established under a Memorandum and Articles of Association on 10th March 1993 (Charity number: 1018523). A new set of Articles were adopted on the 16th March 2000, resulting in the creation of a new organisation (Charity number 1081007) on 2nd June 2000. The assets of the former charity were transferred to the current charity on 25th October 2000. On 10th December 2003 a Special Resolution was passed to change the objects to extend the areas on which rural Arts can operate from 'North Yorkshire' to 'the United Kingdom and primarily North Yorkshire'.

As set out in the Articles, the Chair and new Trustees are nominated and elected by members of the Charity. The Chair must stand down for re-election after every three-year term and, set on rotation according to election dates, a third of Trustees must stand down for re-election each year. New Trustees meet with the Chair of the Board and receive an induction pack that outlines their legal obligations under charity law. They are also updated on the current situation of the Charity's finances and activities. They are invited to observe at least one meeting before formal election.

During the year, M Shakespeare, A Dalton, B Jopking and D Pollard resigned from the Board, and Gaye Kirby and Laura Turner joined the Board. The Trustees designate day-to-day responsibility of the running of the charity to the Chief Executive Officer, Max May.

TRUSTEES' REPORT

The Trustees (who are also directors of the charity for the purposes of the Companies Act) present their annual report together with the financial statements of Rural Arts North Yorkshire (the company) for the year ended 31 March 2020. The Trustees confirm that the annual report and financial statements of the company comply with the current statutory requirements of the company's governing document and the provisions of the Statement of Recommended Practice (SORP), applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015).

Since the company qualifies as small under section 383, the strategic report required of medium and large companies under The Companies Act 2006 (Strategic Report and Director's Report) Regulations 2013 is not required.

OBJECTIVES AND ACTIVITIES

Objectives and aims

The principal aims of the charity are as follows:-

(a) The promotion of rural arts in all their forms in the United Kingdom and primarily in the area of North Yorkshire.

In setting objectives and planning for activities, the Trustees have given careful consideration to the general guidance published by the Charity Commission relating to public benefit.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

Rural Arts North Yorkshire is a company limited by guarantee governed by its Memorandum and Articles of Association dated 16th March 2000 and amended to allow the company to work outside the boundaries of North Yorkshire on 10th December 2003. It is registered as a charity with the Charity Commission.

STRUCTURE, GOVERNANCE AND MANAGEMENT - continued

Structure

The Board of Trustees administers the charity through the Council of Management. The board meets regularly throughout the year.

A Director and CEO is appointed by the Trustees to manage the day-to-day operations of the charity. To facilitate effective operations, the director has delegated authority, within terms of delegation approved by the Trustees, for operational matters including finance, employment and artistic programme related activity.

Brenda Thiede continues as Patron for her long standing contribution to the organisation.

Appointment, induction and training of new trustees

Trustees are appointed by invitation of the members of the Council of Management.

New Trustees undergo an orientation day to brief them on their legal obligations under charity and company law, the content of the Memorandum an Articles of Association, the Committee and decision-making processes, the business plan and the recent financial performance of the Charity. During the induction day the new Trustees meet key employees and other Trustees. Trustees are encouraged to attend appropriate external training events where these will support their role as a trustee.

Risk Management

The Council of Management has conducted it's own review of the major risks to which the Charity is exposed during the annual review of the business plan. A reliance on external grant funding has been identified and additional revenue streams are being pursued to mitigate the risk if the organisation's major funders were to reduce funding.

Internal risks are minimised by the close involvement of the Council of Management. Undertaking of quality standards such as Matrix ensure best practices are used to help the efficient running of the organisation.

The Trustees have recognised the need to manage cash flow carefully and endaevour to increase free reserves in the future.

FINANCIAL REVIEW

Financial Review

Income for the year was £353,072 (2019: £311,418) and expenditure for the year was £282,703 (2019: £357,675), resulting in a Surplus for the year of £70,369 (2019: £-46,257).

Net assets at the year end were £431,605 (2019: £361,236) of which £376,036 (2019: £339,276) were unrestricted funds and £55,569 (2019: £21,960) were restricted funds.

Going Concern

The Trustees have prepared these financial statements on the basis that the organisation is a going concern.

Reserves policy

The Council of Management has established the policy whereby unrestricted funds which have not been designated for a specific use should be maintained at a value of three to six months expenditure. This level of general reserves would finance operations in the event of short term funding gaps and finance immediate obligations should Rural Arts lose its funding, or alternatively in the event that the organisation should need to close.

During the year to 31 March 2020, the general free reserves stand at £64,775 and it is the Trustees' aims to build on general reserves in future years by further developing income generating activities to support our grant dependency and to ensure a high level of astute financial management is maintained. The trading subsidiary company Rural Arts Trading Limited will allow Rural Arts to expand its trading capacity and bring additional income into the charity to increase the free reserves.

TRUSTEES' RESPONSIBILITIES STATEMENT

The Trustees (who are also directors of Rural Arts North Yorkshire for the purposes of company law) are responsible for preparing the Trustees' report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Company law requires the Trustees to prepare financial statements for each financial year. Under company law the Trustees must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the charitable company and of the incoming resources and application of resources, including the income and expenditure, of the charitable company for that period. In preparing these financial statements, the Trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles of the Charities SORP;
- make judgements and accounting estimates that are reasonable and prudent;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charitable company will continue in operation.

The Trustees are responsible for keeping adequate accounting records that are sufficient to show and explain the charitable company's transactions and disclose with reasonable accuracy at any time the financial position of the charitable company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

In preparing this report, the Trustees have taken advantage of the small companies exemptions provided by section 415A of the Companies Act 2006.

NOTES TO THE FINANCIAL STATEMENTS for the year ended 31 March 2020

1 Accounting policies (a) General information and basis of preparation of financial statements

The charity is a company limited by guarantee. The members of the company are the Trustees named on page 1. In the event of the charity being wound up, the liability in respect of the guarantee is limited to £1 per member of the charity. The address of the registered office is given in the charity information on page 1 of these financial statements. The nature of the charity's operations and principal activities are on page 7 of these financial statements.

The charity constitutes a public benefit entity as defined by FRS 102. The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issues on 16 July 2014, the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102), the Charities Act 2011, the Companies Act 2006 and UK Generally Accepted Practice as it applies from 1 January 2015.

The financial statements are prepared on a going concern basis under the historical cost convention, modified to include certain items at fair value. The financial statements are prepared in sterling which is the functional currency of the charity.

The significant accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented unless otherwise stated.

The financial statements do not include a statement of cash flows because the charitable company, as a small reporting entity, is exempt from the requirement to prepare such a statement under SORP (FRS 102).

(b) Funds

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the charity and which have not been designated for other purposes.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the charity for particular purposes. The costs of raising and administering such funds are charged against the specific fund. The aim and use of each restricted fund is set out in the notes to the financial statements.

NOTES TO THE FINANCIAL STATEMENTS (continued) for the year ended 31 March 2020

1 Accounting policies (continued)

(c) Income recognition

All incoming resources are included in the Statement of Financial Activities (SoFA) when the charity is legally entitled to the income after any performance conditions have been met, the amount can be measured reliably and it is probable that the income will be received.

For donations to be recognised the charity will have been notified of the amounts and the settlement date in writing. If there are conditions attached to the donation and this requires a level of performance before entitlement can be obtained, then income is deferred until those conditions are fully met or the fulfilment of those conditions is within the control of the charity and it is probable that they will be fulfilled.

Investment income is earned through holding assets for investment purposes such as shares. It includes dividends and interest. Where it is not practicable to identify investment management costs incurred within a scheme with reasonable accuracy the investment income is reported net of these costs. It is included when the amount can be measured reliably. Interest income is recognised using the effective interest method and dividend income is recognised as the charity's right to receive payment is established.

Other income includes income such as gains on disposals of tangible fixed assets.

(d) Expenditure recognition

All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category. Expenditure is recognised where there is a legal or constructive obligation to make payments to third parties, it is probable that the settlement will be required and the amount of the obligation can be measured reliably.

Irrecoverable VAT is charged as an expense against the activity for which expenditure arose.

(e) Support costs allocation

Support costs are those that assist the work of the charity but do not directly represent charitable activities and include office costs, governance costs, administrative and payroll costs. They are incurred directly in support of expenditure on the objects of the charity. Where support costs cannot be directly attributed to particular headings they have been allocated to expenditure on charitable activities on a basis consistent with use of the resources.

The analysis of these costs is included in note 8.

NOTES TO THE FINANCIAL STATEMENTS (continued) for the year ended 31 March 2020

1 Accounting policies (continued)

(f) Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less accumulated depreciation. Costs includes costs directly attributable to making the asset capable of operating as intended. Assets costing less than £200 are not capitalised.

Depreciation is provided on all tangible fixed assets, at rates calculated to write off the cost, less their estimated residual value, of each asset on a systematic basis over its expected useful lives as follows:

(g) Investments

Investments are recognised initially at fair value which is normally the transaction price excluding transactions costs. Subsequently, they are measured at fair value with changes recognised in 'net gains/(losses) on investment' in the SoFA if the shares are publicly traded or their fair value can otherwise be measured reliably.

(h) Debtors and creditors receivable / payable within one year

Debtors and creditors with no stated interest rate and receivable or payable within one year are recorded at transaction price. Any losses arising from impairment are recognised in expenditure.

(i) Tax

The charity is an exempt charity within the meaning of schedule 3 of the Charities Act 2011 and is considered to pass the tests set out in Paragraph 1 Schedule 6 Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes.
