#### IT IS ORDERED that:-

1. Ian Christopher Oakley-Smith, Steven Anthony Pearson and Stephen Mark Oldfield, (the "Outgoing Office-Holders") each be removed from office as liquidator, as applicable, of the companies listed in Schedule 2 to this Order, to take effect on the fourteenth day after the date of this Order.
