
**Dividends**

**REPORT OF THE AUDITORS TO THE SHAREHOLDERS OF

We have audited the financial statements of The Business Sales Partnership PLC for the year ended 30 September 2004 set out on pages 5 to 10 which have been prepared under the historical cost convention and the accounting policies set out on page 8.

**Basis of opinion**
