STRATEGIC REPORT

The directors present their Strategic report for the year ended 30 April 2019.

Principal activities, review of business and future developments

The Company's principal activity is to act as a holding company. There has been no change in the activity during the year. The result for the financial year was a loss of £687,000 (FY2018: loss of £2,546,000). The Company has net assets of £107,344,000 (30 April 2018: £108,031,000). The directors do not anticipate any significant change in the principal activities of the business in the foreseeable future.

Results and dividends

The Company's loss for the financial year of £687,000 (FY2018: loss of £2,546,000) was transferred to reserves. The directors do not recommend the payment a dividend for the year (FY2018: £nil).

Principal risks and uncertainties

The management of the business and the execution of the Company's strategy are subject to a number of risks and uncertainties. These have been described for the Consort Medical plc Group, including the Company, within Consort Medical plc's annual report and financial statements, which does not form part of this report.

Brexit

On June 23, 2016, the United Kingdom (U.K.) held a referendum in which voters approved an exit from the E.U., commonly referred to as "Brexit". As a result of the referendum, it is expected that the British government will begin negotiating the terms of the U.K.'s future relationship with the E.U. Although it is unknown what those terms will be, it is possible that there will be greater restrictions on imports and exports between the U.K. and E.U. countries and increased regulatory complexities. It is unknown at this time if Brexit will have a material impact on our business

Key performance indicators

The financial key performance indicators ("KPIs") of the Consort Medical plc Group include sustained revenue and earnings growth. These have been discussed on a group-wide basis, including the Company, in the section "Key performance indicators" of the Strategic Report within the Consort Medical plc annual report, which does not form part of this report.

The Company is subject to foreign exchange risk on Group balances payable. The Company does not have liquid assets and is dependent upon its parent company for financing requirements.

Qualifying third-party indemnity arrangements are in place for the benefit of directors in a form and scope which comply with the requirements of the Companies Act 2006. The indemnity was in force throughout the financial year and up to the date of approval of the financial statements. Insurance cover is in force in respect of personal liabilities which may be incurred by directors and officers in the course of their service with the Consort Medical plc Group.

Disclosure of information to auditor

In the case of each director, so far as each is aware, there is no relevant audit information of which the Company's auditor is unaware. Each director has taken all the steps he or she needs to have taken as a director in order to make himself or herself aware of any relevant audit information and to establish that the Company's auditor is aware of that information.

Independent Auditor

Pursuant to Section 487 of the Companies Act 2006, the auditor will be deemed to be reappointed and KPMG LLP will therefore continue in office.

Going concern

At the year end the company has net current liabilities of £40,205,000 (30 April 2018: net current assets of £8,140,000) and net assets of £107,344,000 (30 April 2018: £108,031,000) and reported a loss for the year of £687,000 (FY2018: loss of £2,546,000). The company requires financial support from its, parent undertaking, Consort Medical plc, to enable it to meet its liabilities as they fall due. Consort Medical plc has confirmed that it will provide the necessary financial support to the Company for the foreseeable future, being at least 12 months from the date of approval of these financial statements. The directors consider that this will enable the Company to continue in operational existence for the foreseeable future. The directors of the company have made appropriate enquiries of the directors of Consort Medical plc to confirm that they are satisfied that the financial support will be available and accordingly continue to prepare the financial statements on a going concern basis. As with any company placing reliance on other group companies for financial support, the directors acknowledge that there can be no certainty that this support will continue, although at the date of approval of these financial statements, they have no reason to believe that it will not do so.

INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF BESPAK HOLDINGS LIMITED

Opinion

We have audited the financial statements of Bespak Holdings Limited ("the company") for the year ended 30 April 2019 which comprise the Income Statement, Statement of Comprehensive income, Balance Sheet, Statement of Changes in Equity and related notes, including the accounting policies in note 1.

In our opinion the financial statements:

- give a true and fair view of the state of the company's affairs as at 30 April 2019 and of its loss for the year then ended;
- have been properly prepared in accordance with UK accounting standards, including FRS 101 Reduced Disclosure Framework; and
- have been prepared in accordance with the requirements of the Companies Act 2006.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (UK) ("ISAs (UK)") and applicable law. Our responsibilities are described below. We have fulfilled our ethical responsibilities under, and are independent of the company in accordance with, UK ethical requirements including the FRC Ethical Standard. We believe that the audit evidence we have obtained is a sufficient and appropriate basis for our opinion.

The impact of uncertainties due to the UK exiting the European Union on our audit

Uncertainties related to the effects of Brexit are relevant to understanding our audit of the financial statements. All audits assess and challenge the reasonableness of estimates made by the directors, and the appropriateness of the going concern basis of preparation of the financial statements. All of these depend on assessments of the future economic environment and the company's future prospects and performance.

Brexit is one of the most significant economic events for the UK, and at the date of this report its effects are subject to unprecedented levels of uncertainty of outcomes, with the full range of possible effects unknown. We applied a standardised firm-wide approach in response to that uncertainty when assessing the company's future prospects and performance. However, no audit should be expected to predict the unknowable factors.

Going concern

The directors have prepared the financial statements on the going concern basis as they do not intend to liquidate the company or to cease its operations, and as they have concluded that the company's financial position means that this is realistic. They have also concluded that there are no material uncertainties that could have cast significant doubt over its ability to continue as a going concern for at least a year from the date of approval of the financial statements ("the going concern period").

We are required to report to you if we have concluded that the use of the going concern basis of accounting is inappropriate or there is an undisclosed material uncertainty that may cast significant doubt over the use of that basis for a period of at least a year from the date of approval of the financial statements. In our evaluation of the directors' conclusions, we considered the inherent risks to the company's business model, including the impact of Brexit, and analysed how those risks might affect the company's financial resources or ability to continue operations over the going concern period. We have nothing to report in these respects.

However, as we cannot predict all future events or conditions and as subsequent events may result in outcomes that are inconsistent with judgements that were reasonable at the time they were made, the absence of reference to a material uncertainty in this auditor's report is not a guarantee that the company will continue in operation.

NOTES TO THE FINANCIAL STATEMENTS

General information

Bespak Holdings Limited is a wholly owned subsidiary of Consort Medical plc, a public limited company listed on the London Stock Exchange. Bespak Holdings Limited is incorporated in England and Wales, registered number 03973457. The nature of the Company's operations and its principal activities are set out in the Strategic report on page 3.

Consolidation exemption

The Company is a wholly-owned subsidiary of Consort Medical plc and is included in the consolidated financial statements of Consort Medical plc which are publicly available. Consequently, the Company has taken advantage of the exemption from preparing consolidated financial statements under the terms of section 400 of the Companies Act 2006.

1. Presentation of the financial statements and accounting policies

Basis of preparation

These financial statements have been prepared in accordance with Financial Reporting Standard 101 "Reduced Disclosure Framework" ('FRS101') and the Companies Act 2006.

The following exemptions from the requirements of IFRS have been applied in the preparation of these financial statements, in accordance with FRS 101:

- IFRS 7, 'Financial Instruments: Disclosures'
- Paragraphs 91 to 99 of IFRS 13, 'Fair value measurement' (disclosure of valuation techniques and inputs used for fair value measurement of assets and liabilities)

Accounting convention

The financial statements have been prepared using the historic cost convention, as modified by certain financial assets and financial liabilities (including derivative financial instruments) at fair value. The specific accounting policies adopted, which have been approved by the Board, are described within this note and have been applied consistently in all years presented.

NOTES TO THE FINANCIAL STATEMENTS (continued)

1. Presentation of the financial statements and accounting policies (continued)

Going concern basis

The Company made a loss for the financial year of £687,000 (FY2018: loss of £2,546,000) and at the balance sheet date its current liabilities exceeded its current assets by £40,205,000 (30 April 2018: current assets exceeded current liabilities by £8,140,000). The directors have, at the time of approving the financial statements, a reasonable expectation that the Company has adequate resources to continue in operational existence for the foreseeable future. The directors have received confirmation that Consort Medical plc intends to enable the Company to meet third party liabilities for at least one year after these financial statements are signed.

Investments

Investments are shown at cost less provision in respect of impairments. Impairment write-downs are determined by reference to the higher of the post-tax realisable value of the investment and its ongoing value in use.

Taxation

The charge for current taxation is based on the results for the year as adjusted for items that are non-assessable or disallowed. It is calculated using rates that have been enacted, or substantively enacted, by the balance sheet date.

Non-derivative financial instruments

Non-derivative financial instruments comprise investments in equity and debt securities, trade and other receivables, cash and cash equivalents, loans and borrowings and trade and other payables.

Foreign currencies

Items included in the financial statements of the Company are measured using that entity's functional currency, which is the currency of the primary economic environment in which the Company operates ('functional currency'). The financial statements are presented in 'Pound Sterling' (£) which is also the company's functional currency. Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at period-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the income statement.

Critical accounting estimates and judgements

The Company makes estimates and assumptions that affect the application of policies and reported amounts. Estimates and judgements are continually evaluated and are based on historical experience and other factors including expectations of future events that are believed to be reasonable under the circumstances. Actual results may differ from these estimates. The estimates and assumptions which have a significant risk of causing a material adjustment to the carrying amount of assets and liabilities are discussed below.

A) Going concern

In assessing the going concern assumption, the directors take into account the net assets and net current assets of the Company. The directors have, at the time of approving the financial statements, a reasonable expectation that the Company has adequate resources to continue in operational existence for the foreseeable future. The directors have received confirmation that Consort Medical plc intends to enable the Company to meet third party liabilities for at least one year after these financial statements are signed.

B) Carrying value of intercompany balances

In assessing the carrying value of the Company's intercompany balances, the directors take into account the net assets of the corresponding companies and the trading forecasts of those companies. The trading forecasts contain estimates and assumptions around future profitability and cash generation.

Adoption of new and revised standards

The following new standards and amendments have been applied for the first time during the year commencing 1 May 2018 but are not expected to have a material impact on the Company:

It is not practically possible to make an accurate apportionment of their emoluments in respect of each of the subsidiaries however management do not deem the time spent on this subsidiary to be material.
