UPON THE APPLICATION by a Claim Form dated the 15th June 2006 of the Enron Europe Limited a member of the above named Enron Europe Trading Limited (hereinafter called "the Company")

AND UPON READING the evidence



AND IT APPEARING that there is no opposition on behalf of Her Majesty to the relief sought by this Claim as appears from the Witness Statement of Catherine Sara Walsh and the exhibit thereto

AND the Claimant by its *liquidator* undertaking that:

- (A) the Claimant will take no action regarding the realisation or disposal of the assets of the Company until a liquidator has been appointed
- (B) the Claimant will immediately upon restoration of the name of the Company to the Register of Companies take all steps necessary for procuring that the Company be placed in voluntary liquidation.

- (C) immediately the company is placed in Creditors' Voluntary Liquidation the company will take all necessary steps to place Enron Europe Xchange Trading Limited in Creditors' Voluntary Liquidation as referred to in paragraph 8 of the Witness Statement of Anthony Victor Lomas dated the 12th June 2006

AND UPON the solicitors for the Claimant and for the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT:

- (1) the name of the above named Enron Europe Trading Limited be restored to the Register of Companies
- (2) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (3) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"
- (4) the hearing fixed for the 15th September 2006 be vacated
