
**DIRECTORS**

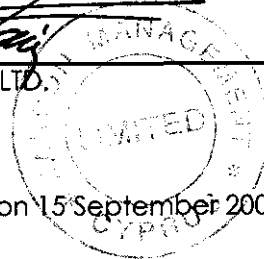

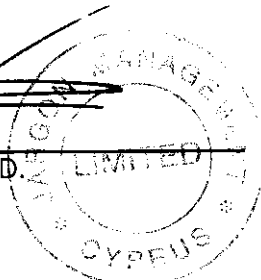
