IT IS ORDERED THAT:

1. Brendan Hogan be removed from office as Trustee in Bankruptcy of the bankruptcies listed in Schedule 1 attached hereto pursuant to Section 298(1) of the Insolvency Act 1986, with effect from the date of this Order and Alan David Fallows and Peter James Anderson be appointed as Joint Trustees in Bankruptcy in substitution in respect of the said bankruptcies with effect from the same date pursuant to Section 303(2) of the Insolvency Act 1986
2. Brendan Hogan be removed from office as Supervisor of the voluntary arrangement listed in Schedule 2 attached hereto pursuant to Section 263(5) of the Insolvency Act 1986, with effect from the date of this Order and Alan David Fallows and Peter James Anderson be appointed as Joint Supervisors in substitution in respect of the said voluntary arrangements with effect from the same date

- 3 Brendan Hogan be removed from office as Liquidator of the companies in voluntary liquidation listed in Schedule 3 attached hereto pursuant to Section 108 of the Insolvency Act 1986 with effect from the date of this Order and Alan David Fallows and Peter James Anderson be appointed as Joint Liquidators in substitution in respect of said companies with effect from the same date pursuant to Section 108 of the Insolvency Act 1986
- 4 Brendan Hogan be removed from office as Liquidator of the companies in compulsory liquidation listed in Schedule 4 attached hereto pursuant to Section 172(2) of the Insolvency Act 1986, with effect from the date of this Order and Alan David Fallows and Peter James Anderson be appointed as Supervisor in substitution in respect of the said company with effect from the same date pursuant to Section 172 of the Insolvency Act 1986
- 5 Brendan Hogan be removed from office as Supervisor of the company in voluntary arrangement listed in Schedule 5 attached hereto pursuant to Section 7(5) of the Insolvency Act 1986, with effect from the date of this Order and Alan David Fallows and Peter James Anderson be appointed as Supervisor in substitution in respect of the said company with effect from the same date pursuant to Section 168(3) of the Insolvency Act 1986
- 6 Brendan Hogan be removed from office as Administrator of the companies in administration listed in Schedule 6 attached hereto pursuant to paragraph 88 of Schedule B1 to the Insolvency Act 1986, with effect from the date of this Order and Alan David Fallows and Peter James Anderson be appointed as

Joint Administrators in substitution in respect thereof with effect from the same date

- 7 The bankruptcies referred to in Schedule 1 and the compulsory liquidation referred to in Schedule 4 be transferred to the High Court for the purpose of this order only
8. The Applicant shall file in Court by close of business on 15 March 2016 a list of the relevant Courts or hearing centres as referred to in r 7 10C(8)(b) of the Insolvency Rules 1986
- 9 The Respondents shall, when the next routine report is due to the creditors/members of each Bankruptcy, Voluntary Arrangement, Creditors' Voluntary Liquidation, Compulsory Liquidation and Administration, give written notice of the making of this order to each such creditor/member, such notice to include the following matters
 - (a) An explanation as to the effect of the order, and
 - (b) Express reference to the liberty to apply as set out in the order
- 10 Liberty to each creditor/member of each Bankruptcy, Voluntary Arrangement, Creditors' Voluntary Liquidation and Administration to apply to vary or discharge this order within 28 days of receipt of the notices directed to be sent under paragraph 9 above

- 11 The costs of this application be borne as an expense of the case as referred to in the schedules attached Costs allocated to each case will not exceed 10% of the realisations in that case
