Structure, Governance and Management

Governing Document

The organisation is a charitable company limited by guarantee, incorporated on 26 May 2000 and registered as a charity on 31 March 2003. The company was established under a Memorandum of Association which established the

objects and powers of the charitable company and is governed under its Articles of Association. In the event of the company being wound up members are required to contribute an amount not exceeding £10.

Management

Whilst the Directors are responsible for the Company, day to day management of the Recreation Ground and the Village Hall is delegated to two Management Committees. These consists of members nominated by various organisations in the village, and a number of individual members. In addition the committees have the power to co-opt members.

Review of 2011-2012

This last twelve months has been another busy year. The village hall is always in high demand, we have regular bookings most days and evenings in the week and most weekends host a variety of events. The work on the recreation ground is complete. This outdoor space has been used for a number of events as well as hosting our village cricket team and local village girl's football team.

I would personally like to thank my fellow committee members, who continue to give a tremendous amount of their time in all aspects of the day to day running and up keep of the hall and recreation ground, as well as all the events we organise. I personally believe both committees and close affiliated others offer a great deal to this village and something we all should be proud of

Alan Danbury does an excellent job as treasurer Alan continues to manage all our finances

I would also like to thank Fiona Hart who as booking secretary has done a great job promoting the hall and spending a lot of her time showing people around the hall and managing the daily booking diary

A special mention and thank you is needed to Jim and Faith, Mark and Pauline for managing the bar, all the trips to Makro and the whole coordination of all bar rotas. This takes a huge amount of time and effort

Dan Jones continues to help on all outdoor maintenance and we are very fortunate for all his time. We are very grateful for his time.

We have also sadly lost Terry Bailey and Lavinia Pick this year. Both did a huge amount for the village hall and recreation ground. We will treasure great and fond memories of both.

Our sincere thanks to Long Clawson Dairy who continue to provide on-going support, they kindly donated the main Village Hall sign to us this year. They also allowed us an extension to our loan by a further 12 months to enable us to install solar panels for electricity generation here at the hall.

This last year has seen all our traditional events such as monthly bingo, the produce show, conker day, food fayre, 10k challenge and our village Christmas meal. We also have a monthly film and either music or drama from Centre Stage. We also celebrated Olympic Year by hosting a Village Relay with Stathern, Hose and Harby Village Halls. We have also hosted 11 weddings.

Our Village Pre School is here 3 days a week providing early learning for up to 30 children per session. Soon to be 3.5 days per week.

The Village Primary School has used the hall two afternoons a week for PE The Long Clawson Scouting Group is using the whole hall on a Wednesday evening

Village Hall

We had solar panels installed in January 2012. These are producing all our electricity as well as enabling us to sell all unused electricity back to the National Grid generating an income to our funds of approximately £1200 per annum.

We are licensed premises for all types of entertainment and the supply and sale of alcohol. We have strict licensing laws to follow but believe these are right for the hall and all that use it

We are able to offer professional kitchen facilities as well as the main hall and lounge for private and commercial functions

We now have fixed screens in the lounge and main hall as well as broadband, ceiling mounted projectors, lighting and sound enabling us to offer professional audio visual output

We have extended the re-cycling facilities for a wide range of materials

Recreation Ground and Committee

The outside facilities are all being used and available for hire

The MUGA lights have now been installed so this can be used during the autumn and winter evenings

Fields in Trust

As part of Queens Diamond Jubilee both committees agreed to commit the recreation ground to the Fields in Trust a UK charity dedicated to protecting playing fields and outdoor space. Our commitment is to protect the recreation ground so it can only be used for recreation purposes for many generations to come.

Limited Company Legal Obligations

As a legal requirement of being a limited company 'Long Clawson Village Hall and Recreation Ground Ltd', we have now established a new board of directors Both committees have agreed that two members from each group will join the board, plus a company secretary and two others (7 in total) The current board is Jonathan Bignell, Alan Danbury, Andrew King, Roy Tandy and Wayne Kay The others will be villagers with a keen interest in the Hall and Recreation ground who want to nominate themselves forward to these positions. This board will meet twice a year to review the accounts, on-going projects and activity. The board will approve any significant expenditure. The day to day running of the Village Hall and Recreation Ground will continue to be carried out by both management committees.

Finally I would like to that all trustees again for all your hard work and support for all events. I am very proud to have chaired two committees of dedicated volunteers. Time and time again you all agree to help in a wide variety of events. Thank you to you all

Both committees are always looking for new members. Tonight is the ideal time to put yourself forward or spread the word to family and friends to join either committee.
