1. Accounting policies

(a) Basis of preparation

The company has ceased trading. As required by FRS18 Accounting Policies, the directors have prepared the financial statements on the basis that the company is no longer a going concern. No adjustments arise as a result of adopting the non-going concern basis.

(b) Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with applicable United Kingdom Accounting Standards.

(c) Group accounts

The company is a wholly owned subsidiary of Bond International software Plc which prepares consolidated accounts, and in accordance with the exemption in the Companies Act 2006, no consolidated accounts for Gowi Group Limited and its subsidiary companies have been prepared.
