(c) To pay into the Company's account with Headstart (or such other account as Headstart may specify from time to time) all money which the Company may receive in respect of the Company's book debts and other debts and not to deal with the Company's book debts and other debts otherwise than by collecting them in the ordinary course of the Company's business and in particular not to realise the Company's book debts and other debts by means of block discounting, factoring or the like.

4. the Debenture gives Headstart the power to appoint an Administrative Receiver.
