## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MARCH 2017

## 1. ACCOUNTING POLICIES

## 1.1 Basis of preparation of financial statements

· The financial statements have been prepared under the historical cost convention.

## 1.2 Company status

The company is a company limited by guarantee. In the event of the company being wound up, the liability in respect of the guarantee is limited to £1 per member of the company.

## 2. SHARE CAPITAL

Groundwork South East London is a company limited by guarantee and has no share capital. Each member is liable to contribute a sum not exceeding £1 in the event of the company being wound up. The members are the London Boroughs of Greenwich, Lewisham and Bexley and Groundwork UK.
