


This Agreement is governed by the laws of Germany. Court of jurisdiction is Munich, Germany. The contractual language shall be English.

#### Article 10 - Order of priority

In the case of any inconsistency or conflict between the specific provisions of this Agreement and the General Terms and Conditions of the subsidiaries of BUYER, the provisions of this Agreement shall prevail.

### Article 11 - Information about legal amendments

AGENT undertakes to inform BUYER of all changes or amendments concerning official rules, regulations and official tees in the IPO's official currency in connection with IP payment services as soon as they occur.

### Article 12 - Termination for insolvency and change of control

12.1 If AGENT becomes insolvent, bankrupt, or enters receivership, dissolution, or liquidation, BUYER may terminate this Agreement with immediate effect.

12.2 BUYER may terminate this Agreement with immediate effect, by giving written notice to AGENT, in the event of a change of control of AGENT.

# Article 13 - Severability Clause

If any one of the provisions of this Agreement is or becomes entirely or partly invalid, the remaining part of the Agreement shall not be affected thereby. In such case the invalid provision(s) shall be anicably replaced by a provision which meets best the legal and economic aim of the invalid provision, in connection with the aim of the Agreement, the parties shall neither bribe someone nor accept a bribe. Changes and amendments to this Agreement have to be in written form. This also invalids the cancellation of the requirement of the written form itself.
