Prescribed particulars On a show of hands every ordinary shareholder who (being an individual) is present or (being a corporation) is present by a duly authorised representative, not being himself a member entitled to vote, shall have one vote and on a poll every ordinary shareholder shall have one vote for every share of which he is the holder.
