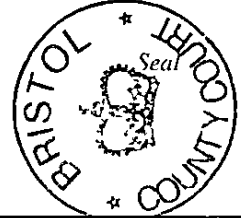

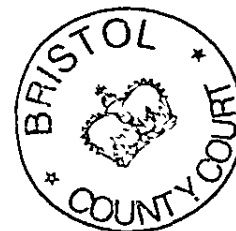

- (B) inform the Registrar of Companies immediately on the conclusion of the said litigation or any appeal therefrom or the conclusion of the claim by any other means


AND UPON the solicitors for the Claimant and the Registrar of Companies (the Defendant) both consenting to this Order

- (4) the Claimant do pay to the Registrar of Companies his costs of the said Application in the agreed sum of £300-00


