Non-Executive Chairman's Statement For the Year Ended 31 May 2021

Non-Executive Chairman's statement

Season 2020/21

We entered season 2020/21 with the realistic possibility that we were likely to go the entire season with matches being played behind closed doors.

Unfortunately for ourselves and football this proved to be case with the pandemic continuing to cause havoc in the world of professional sport for the best part of 15-16 months.

Throughout this time, we continued to take all the steps we could to ensure that costs within the Club are reduced wherever possible and took advantage of such Government financial assistance as was available and we successfully applied for a share of the £200m EFL Loan facility that was made available to all Championships clubs earlier in 2021.

I would reiterate however that the EFL loan is not a grant and has to be repaid over the next 2-3 years from our guaranteed solidarity receivables with repayments commencing in August 2021.

It remains our opinion that the level of support that we as a sport have received from national and devolved governments since the start of and throughout the pandemic has been extremely disappointing and professional and amateur football itself has been left very much to sort out its own problems.

The cost of the pandemic through to the end of the 2020/21 season has included but is not restricted to:

- Season ticket refunds of £945,000;
- Loss of match day revenue and associated income over the entire period;
- Refunds payable by the EPL on their overseas broadcast revenue of near £300m of which we as a Club in receipt of parachute income for 2019/20 had to bear our share, which resulted in a charge against our 2021 results of £0.4m (2020: £2.1m);
- The loss of commercial revenue and sponsorship opportunities as the pandemic hit all businesses;
- The increased costs of working with the necessary "return to play" protocols put in place by the Club following the guidelines set by the league.

From an income recognition view point the cessation of matches in March 2020 and the consequent deferment of the remaining 9 games of the 19/20 season until after the end of the 2020 year has resulted in the income recognition from the parachute income and basic award relating to these games, amounting to £8.8m, being deferred into the year ended 31 May 2021 and included in these accounts.

On the playing side following our challenge for the play offs at the end of season 2019/20 we were confident that we could maintain that drive into the 2020/21 season and be consistently challenging for the top 6 places.

However, our on-field results did not turn out as expected and as a result as reported in my Chairman's statement in last year's financial statements the Club quickly acted to appoint Mick McCarthy as the 1st team manager along with Terry Connor as Assistant Manager in January 2021 for the remainder of the 2020/21 season.

Our immediate challenge was to move away from the imminent danger of being dragged into a relegation struggle at the bottom of the Championship. Not only was this challenge achieved very quickly following the appointment of Mick and Terry we were at one point challenging for a place in the end of season play offs.

Such was the impact made by Mick and Terry the Board moved quickly to secure their services for the futures and were pleased that they both agreed to make their stay at the Club permanent in March 2021.

While we eventually fell short of the play offs the advances made in such a brief period set us up, we believed, to be in position to challenge once again at the top end of the division with a realistic chance of promotion back to the Premier League.

Season 2021/22

The start of season 2021/22 coincided with the removal of the pandemic restrictions and the ending of matches behind closed doors and the return of spectators from the first game of the season.

While this was a major positive change for the wellbeing of everyone, the Club, our employees, and our fans there were no guarantees as to how long this situation would remain in place and would be dependent upon how the pandemic reacted to the opening of society with the removal of the accompanying restrictions.

Despite the return of restrictions in December 2021 and January 2022 we sincerely hope that this return to normality is here to stay.

On the playing side while the new season started positively, performance and results soon became disappointing with the Club moving further down the league table and flirting with being dragged into a relegation battle.

The Board retained confidence in Mick McCarthy and his support team for as long as possible but ultimately as the slide down the table continued the board made the decision to part company with Mick McCarthy and his team.

The Board moved quickly to promote Steve Morrison to 1st team manager supported by Tom Ramasut and the recruitment of Mark Hudson to complete the management team and spearhead our fight for survival and our climb away from the relegation places.

While the climb has been slow results in the past 5 or 6 games has moved the Club some 15 points above the relegation places.

The Board are confident that a continuation of our recent form will accelerate our climb up the table and safety away from any thought of relegation.

At the same time, we are planning for Season 2022/23 with a transformation in our 1st team squad as a number of our playing staff come to the end of their playing contracts married with the emergence of a number of players from our Academy who are fast becoming integral members of our 1st team squad.

We are continuing to build the infrastructure of the Club to ensure that we achieve our aim of promotion back to the Premier League then we must then ensure that we retain our status for the foreseeable future and break away from the viscous cycle of promotion and relegation.



The board consider the key performance indicators for the Group to be turnover, result from player trading and player salary costs.

The results show increased turnover from that reported in the prior year accounts directly as a result of the deferral of parachute income and basic award of £8.8m from 2019/20 into 2020/21 to match the actual game profile on the return to play and completion of the season. Without the deferral of income, turnover for 2021 would have been £46,415,000, compared with an adjusted 2020 turnover of £54,802,000.

The Group is reporting an operating loss for the year ended 31 May 2021 of £12,130,000 decreased by £11,675,000 from the £23,805,000 reported loss for the prior year ended 31 May 2020.

While the Group has significant net liabilities, the principal indebtedness at the year end was to the controlling shareholder.

Principal risks and uncertainties

The principal risks are associated with the performance of the team and the league in which the football club operates, as turnover and costs, particularly those from broadcasting and player costs respectively, vary substantially between the English Premier League and the Championship. The Group manages the impact of that risk through close control of its direct costs, relative to its forecast income.

Credit risk relates primarily to trade debtors from its commercial activities. The Group monitors credit risk closely and its exposure to rate risk is minimal given any borrowings are financed by ultimate owner loans.

Outlook

Our aim remains to regain our status in the English Premier League and maintain this for the foreseeable future.

Engagement with stakeholders

Section 172 of the Companies Act 2006 requires the club's board of directors to take into consideration the interests of stakeholders and other matters in their decision making. The club's board continues to ensure the interests of all employees, supporters, partners, local community and other stakeholders are always given the fullest of consideration, and as a club and charity we have a number of initiatives aimed at regularly engaging with each of these groups.

Directors' Report For the Year Ended 31 May 2021

The directors present their report and the financial statements for the year ended 31 May 2021.

Principal activity

The principal activity of the Group is that of a professional football club incorporating the operation of a multi-use stadium, whilst the principal activity of the Company is that of a holding company.

Going concern

The Company's business activities, together with the factors likely to affect its future development, performance and position are set out in the Directors' report & Strategic report.

The Company and Group meets its day-to-day working capital requirements through use of operating cash flows, and loans provided by the ultimate shareholder of the group and other related parties.

The Company is a direct parent of Cardiff City Football Club Limited. As at 31 May 2021, the Group reported net liabilities of £36m (2020: £24m). The Group, and therefore the Company, continues to rely principally on the ultimate shareholder as well as other loan holders for equity and non-recall of these loans and for further funding as required as the group transitions back to a fully operating position subsequent to Covid-19 related restrictions.

In assessing the appropriateness of the going concern assumption, the directors have prepared detailed cash flow forecasts for the Company, and Group, extending beyond 12 months from the date of approval of these financial statements. However, it is acknowledged that Covid-19 has had a profound impact on the business and will continue to do so for some time. Projecting how the UK economy emerges from Covid-19 restrictions remains challenging and this continues to have an impact on the Company's forecasts.

In order to mitigate Covid-19 impacts on revenue since the UK became impacted by the pandemic, and in order to protect the longer term interests of the Company and its employees, the Company and wider group has taken measures to reduce and mitigate its cost base. During the year, the Company's majority shareholder has provided additional funds in order to meet the Company's and Group's working capital requirements during the period when football ceased and then subsequently was played behind closed doors.

The Company's trading subsidiaries rely on non-recall intergroup loans and further funds as required, and as such remain reliant on the ongoing support of the ultimate shareholder. The directors of Cardiff City Football Club (Holdings) Limited, have received a non-legally binding confirmation that this support will be forthcoming for no less than 12 months from the date of approval of the financial statements and therefore have concluded that is appropriate to prepare the financial statements on a going concern basis.

Insofar as this support not being legally binding, the directors have identified a material uncertainty that may cast significant doubt over the Company's and Group's ability to continue as a going concern for no less than 12 months from the date of approval of the financial statements.

Policy on payment of creditors

The Group values its relationship with its many suppliers. As part of meeting its obligations under each purchase transaction, the Group's policy is to pay amounts due for settlement in accordance with the negotiated terms of trade.

Trade payables at 31 May 2021 represented 22 days of annual purchases (2020: 25). This figure excludes creditors in respect of player purchases, which are paid on the date when payment is contractually due.

Professional indemnity

The Group maintains Directors and Officers liability insurance, which gives appropriate cover against any legal action that may be brought against them.

Internal control and risk management

The directors are responsible for the Group's system of internal financial control. Although no system of internal financial control can provide absolute assurance against material misstatement or loss, the Group's system is designed to provide reasonable assurance that problems are identified on a timely basis and dealt with appropriately.

In carrying out their responsibilities the directors have put in place a framework of controls to ensure as far as possible that ongoing financial performance is monitored in a timely manner, that corrective action is taken and that risk is identified as early as practically possible, and they have reviewed the effectiveness of internal financial control.

The Board, subject to delegated authority, review capital investment, player transactions, additional borrowing facilities, guarantees and insurance arrangements.

A review of the business and summary of risks and uncertainties is included in the Strategic Report.

Quantification and reporting methodology

We have followed the 2019 HM Government Environmental Reporting Guidelines. We have also used the GHG Reporting Protocol – Corporate Standard and have used the 2021 UK Government's Conversion Factors for Company Reporting.

Intensity measurement

The chosen intensity measurement ratio is total gross emissions in metric tonnes CO₂e per full time employee.

Measures taken to improve energy efficiency

We have taken the following measures to improve our energy efficiency:-

Continued from prior year

- Continued to implement a change programme where LED lighting has been installed throughout the Stadium
- Night security continue to perform a lock down programme where all lighting and air conditioning units are turned off and powered down

Implemented

- Switch from petrol to electric mowers
- Introduced the Sharing of Energy use Tracker and locally held information with resultant reduction in energy use
- Reduction in flights for first team away match travel

Planned

- Ongoing - investigating the viability of installing electric vehicle charging points
- Imminent - introduction of recycling bins (paper, cardboard and plastic)
- Installation of plumbed in water fountains to reduce single use plastic – planned for 2022/23
- All department heads have been tasked with developing initiatives to reduce the Club's carbon footprint
- Working with the EFL to meet the "Green Clubs Scheme" that will hopefully help to reduce the club's Carbon Footprint
- Other future initiatives will include the design of the facilities at the new Academy site

In conjunction with our Stadium catering partners, Levy UK, introducing our joint "climate promise roadmap" including initiatives around:-

- E-crackers for guests to reduce waste
- Flawsome canned drinks have been introduced in hospitality (Wonky fruit & vegetable drinks)
- Partnering with Fare-Share Cymru to reduce food waste
- Commitment to buy locally and seasonally
- Sustainability project to look at phasing out of the use of single-use plastics
- Complete Stadium review of all areas in accordance with the carbon reduction roadmap to make improvements in areas such as packaging, disposable items, drinking water availability, recycling

Results and dividends

The loss for the year, after taxation, amounted to £11,151,000 (2020: loss £12,260,000).

No dividends were declared or paid during the year (2020: £nil).

We draw attention to note 2.3 to the financial statements which describes how the ability of the Company and Group to continue as a going concern is affected by ongoing losses and the potential impacts of the COVID-19 pandemic. The Group is funded by its principal shareholder and various forecast scenarios indicate that the Company and Group will be required to secure additional funding that is not guaranteed. These events indicate that a material uncertainty exists that may cast significant doubt on the Company's and Group's ability to continue as a going concern.

In auditing the financial statements, we have concluded that the Directors' use of the going concern basis of accounting in the preparation of the financial statements is appropriate.

Our responsibilities and the responsibilities of the directors with respect to going concern are described in the relevant sections of this report.

1. General information

The Company is a United Kingdom private company limited by shares. It is both incorporated and domiciled in England and Wales. The registered office address is Cardiff City Stadium, Leckwith Road, Cardiff, CF11 8AZ.

These financial statements are presented in Pounds Sterling (GBP), as that is the currency in which the majority of the Group's transactions are denominated. They comprise the financial statements of the Company and Group for the year ended 31 May 2021 and are presented to the nearest thousand pound (£'000).

The Group has determined that GBP is its functional currency, as this is the currency of the economic environment in which the Group predominantly operates.

The principal activity of the Group during the year was that of a professional football club incorporating the operation of a multi-use sports stadium.

2. Accounting policies

2.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention unless otherwise specified within these accounting policies and in accordance with Financial Reporting Standard 102, the Financial Reporting Standard applicable in the UK and the Republic of Ireland and the Companies Act 2006.

The preparation of financial statements in compliance with FRS 102 requires the use of certain critical accounting estimates. It also requires Group management to exercise judgement in applying the Group's accounting policies (see note 3).

2.2 Basis of consolidation

The consolidated financial statements present the results of the Company and its own subsidiaries ("the Group") as if they form a single entity. Intercompany transactions and balances between group companies are therefore eliminated in full.

The consolidated financial statements incorporate the results of business combinations using the purchase method. In the Statement of Financial Position, the acquiree's identifiable assets, liabilities and contingent liabilities are initially recognised at their fair values at the acquisition date. The results of acquired operations are included in the Consolidated Statement of Comprehensive Income from the date on which control is obtained. They are deconsolidated from the date control ceases.

In accordance with the transitional exemption available in FRS 102, the group has chosen not to retrospectively apply the standard to business combinations that occurred before the date of transition to FRS 102, being 01 June 2017.

2.3 Going concern

The Company's business activities, together with the factors likely to affect its future development, performance and position are set out in the Directors' report & Strategic report.

The Company and Group meets its day-to-day working capital requirements through use of operating cash flows, and loans provided by the ultimate shareholder of the group and other related parties.

The Company is a direct parent of Cardiff City Football Club Limited. As at 31 May 2021, the Group reported net liabilities of £36m (2020: £24m). The Group, and therefore the Company, continues to rely principally on the ultimate shareholder as well as other loan holders for non-recall of these loans and for further funding as required as the group transitions back to a fully operating position

subsequent to Covid-19 related restrictions.

In assessing the appropriateness of the going concern assumption, the directors have prepared detailed cash flow forecasts for the Company, and Group, extending beyond 12 months from the date of approval of these financial statements. However, it is acknowledged that Covid-19 has had a profound impact on the business and will continue to do so for some time. Projecting how the UK economy emerges from Covid-19 restrictions remains challenging and this continues to have an impact on the Company's forecasts.

In order to mitigate Covid-19 impacts on revenue since the UK became impacted by the pandemic, and in order to protect the longer term interests of the Company and its employees, the Company and wider group has taken measures to reduce and mitigate its cost base. During the year, the Company's majority shareholder has provided additional funds in order to meet working capital requirements during the period when football ceased and then subsequently was played behind closed doors.

The Company's trading subsidiaries rely on non-recall intergroup loans and further funds as required, and as such remain reliant on the ongoing support of the ultimate shareholder. The directors of Cardiff City Football Club (Holdings) Limited have received a non-legally binding confirmation that this support will be forthcoming for no less than 12 months from the date of approval of the financial statements and therefore have concluded that is appropriate to prepare the financial statements on a going concern basis.

Insofar as this support not being legally binding, the directors have identified a material uncertainty that may cast significant doubt over the Company's and Group's ability to continue as a going concern for no less than 12 months from the date of approval of the financial statements.

2.4 Foreign currency translation

Functional and presentation currency

The Company and Group's functional and presentational currency is GBP.

Transactions and balances

Foreign currency transactions are translated into the functional currency using the spot exchange rates at the dates of the transactions.

At each period end foreign currency monetary items are translated using the closing rate. Non-monetary items measured at historical cost are translated using the exchange rate at the date of the transaction and non-monetary items measured at fair value are measured using the exchange rate when fair value was determined.

Foreign exchange gains and losses resulting from the settlement of transactions and from the translation at period-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in profit or loss except when deferred in other comprehensive income as qualifying cash flow hedges.

Foreign exchange gains and losses that relate to borrowings and cash and cash equivalents are presented in the Consolidated Statement of Comprehensive Income within 'finance income or costs'. All other foreign exchange gains and losses are presented in profit or loss within 'other operating income'.

2.5 Revenue

Revenue is measured at the fair value of the consideration received or receivable and represents amounts receivable in the normal course of business, net of discounts, VAT and other sales-related tax.

Gate receipts, other match day revenue and prize money in respect of cup competitions are recognised as the games are played. Sponsorship and similar commercial income is recognised over the duration of the respective contracts where it is probable that the income will be received. The fixed element of broadcasting revenues is recognised over the duration of the football season, based on matches played, whilst facility fees received for live coverage or highlights are taken when earned. Merit awards in excess of the minimum receivable are accounted for only when known at the end of the football season.

Merchandising revenue is recognised when goods are delivered and title has passed.

2.6 Operating leases: the Group as lessee

Rentals paid under operating leases are charged to the Consolidated Statement of Comprehensive Income on a straight line basis over the lease term.

Benefits received and receivable as an incentive to sign an operating lease are recognised on a straight line basis over the lease term, unless another systematic basis is representative of the time pattern of the lessee's benefit from the use of the leased asset.

2.7 Government grants

Grants are accounted under the accruals model as permitted by FRS 102. Grants relating to expenditure on tangible fixed assets are credited to profit or loss at the same rate as the depreciation on the assets to which the grant relates. The deferred element of grants is included in creditors as deferred income.

Grants of a revenue nature are recognised in the Consolidated Statement of Comprehensive Income in the same period as the related expenditure.

The Group recognises government grants related to the Coronavirus Job Retention Scheme as other income when the grant becomes receivable.

2.8 Interest income

Interest income is recognised in the Consolidated Statement of Comprehensive Income using the effective interest method.

2.9 Finance costs

Finance costs of borrowings are recognised in the Consolidated Statement of Comprehensive Income using the effective interest method. The effective interest rate is the rate that exactly discounts estimated future cash flows through the expected life of the borrowing.

Any non-current assets acquired on deferred terms are recorded at the discounted present value at the date of acquisition. The associated payable is then increased to the settlement value over the period of deferral, with this value being charged as a notional finance cost through the Consolidated Statement of Comprehensive Income.

2.10 Borrowing costs

All borrowing costs are recognised in the Consolidated Statement of Comprehensive Income in the year in which they are incurred.

2.11 Pensions

Defined contribution pension plan

The Group operates a defined contribution plan for its employees. A defined contribution plan is a pension plan under which the Group pays fixed contributions into a separate entity. Once the contributions have been paid the Group has no further payment obligations.

The contributions are recognised as an expense in profit or loss when they fall due. Amounts not paid are shown in accruals as a liability in the Statement of Financial Position. The assets of the plan are held separately from the Group in independently administered funds.

2.12 Current and deferred taxation

The tax expense for the year comprises current and deferred tax. Tax is recognised in profit or loss except that a charge attributable to an item of income and expense recognised as other comprehensive income or to an item recognised directly in equity is also recognised in other comprehensive income or directly in equity respectively.

The current income tax charge is calculated on the basis of tax rates and laws that have been enacted or substantively enacted by the reporting date in the countries where the Company and the Group operate and generate income.

Deferred tax balances are recognised in respect of all timing differences that have originated but not reversed by the Statement of Financial Position date, except that:

- The recognition of deferred tax assets is limited to the extent that it is probable that they will be recovered against the reversal of deferred tax liabilities or other future taxable profits;
- Any deferred tax balances are reversed if and when all conditions for retaining associated tax allowances have been met; and
- Where they relate to timing differences in respect of interests in subsidiaries, associates, branches and joint ventures and the Group can control the reversal of the timing differences and such reversal is not considered probable in the foreseeable future.

Deferred tax balances are not recognised in respect of permanent differences except in respect of business combinations, when deferred tax is recognised on the differences between the fair values of assets acquired and the future tax deductions available for them and the differences between the fair values of liabilities acquired and the amount that will be assessed for tax. Deferred tax is determined using tax rates and laws that have been enacted or substantively enacted by the reporting date.

2.13 Player costs and transactions

(i) Initial capitalisation

The costs associated with the acquisition of player registrations are capitalised as intangible fixed assets. Any intangible assets acquired on deferred terms are recorded at the fair value at the date of acquisition. The fair value represents the net present value of the costs of acquiring players.

(ii) Amortisation

These costs are fully amortised on a straight-line basis over their useful economic lives, being the period of the respective contracts. Where a contract life is renegotiated, the unamortised costs, together with the new costs relating to the contract extension, are amortised over the term of the new contract.

(iii) Contingent consideration

Under the conditions of certain transfer agreements, further fees will be payable to the vendors in the event of the players concerned making a number of certain number of First Team appearances or on the occurrence of certain other specified future events. Liabilities in respect of these additional transfer related costs not recognised at date of acquisition are accounted for when they become probable, which is typically when they are confirmed and taken directly to the Statement of Comprehensive Income at that point in time.

(iv) Impairment

The Group will perform an impairment review on the intangible assets if events or changes in circumstances give cause for a player to be taken out of the football club cash generating unit ("CGU") and that indicate that the carrying amount of the player may not be fully recoverable. The Group compares the carrying amount of the player's registration with its recoverable amount. Impairment losses are recognised in profit or loss during the period and are included within administrative expenses in the Statement of Comprehensive Income.

The Group considers the recoverable amounts of individual player registrations, being the higher of their fair value less costs to sell and their value in use. The Group estimates fair value less costs to sell using one of the following sources:

- in the case of a player who has permanently fallen out with the Group's senior football management and directors, either the agreed selling price in the event that there is an agreement to transfer the player subsequent to the year end; or if there have not been any bids for the player, management's best estimation of the disposal proceeds (less costs) of the player on an arm's length basis. This is determined by the Group's senior football management in conjunction with the directors who will use the outcome of recent player disposals (by both the Group and other football clubs) as a basis for their estimation. Any costs to sell, such as agency costs are deducted from the fair value; or
- in the case of a player who has suffered a career-threatening injury or condition, the value attributed to the player by the Group's insurers.

2.12 Player costs and transactions (continued)

(v) Disposals

Profits or losses on the disposal of these player registrations represent the fair value of the consideration receivable, net of any transaction costs, less the unamortised cost of the original registration.

(vi) Remuneration

Remuneration of players is charged in accordance with the terms of the applicable contractual agreements and any discretionary bonus when there is a legal or contractual obligation. Liabilities in respect of player signing-on or loyalty fees are capitalised and then amortised over the term of the contract.

Discretionary bonuses, e.g. appearance fees, win/draw bonuses, are provided for, as part of operating expenses, when payment becomes probable or due contractually.

2.14 Goodwill

Goodwill represents the excess of the cost of a business combination over the fair value of the group's share of the net identifiable assets of the acquired subsidiary at the date of acquisition. Goodwill on acquisitions of subsidiaries is included in 'intangible assets'.

For business combinations occurring after 1 January 2019, intangible assets acquired are recognised separately from goodwill only when they are separable from the acquired entity and give rise to other contractual/legal rights. Prior to 1 January 2019 intangible assets acquired were recognised separately from goodwill when they were separable from the acquired entity or gave rise to other contractual/legal rights.

Gains and losses on the disposal of an entity include the carrying amount of goodwill relating to the entity sold. Goodwill is carried at cost less accumulated amortisation and accumulated impairment losses. Goodwill amortisation is calculated by applying the straight-line method to its estimated useful life. If a reliable estimate cannot be made, the useful life of goodwill is presumed to be 10 years.

Estimates of the useful economic life of goodwill are based on a variety of factors such as the expected use of the acquired business, the expected useful life of the cash generating units to which the goodwill is attributed, any legal, regulatory or contractual provisions that can limit useful life and assumptions that market participants would consider in respect of similar businesses.

2.15 Tangible fixed assets

Tangible fixed assets under the cost model are stated at historical cost less accumulated depreciation and any accumulated impairment losses. Historical cost includes expenditure that is directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management.

The Group adds to the carrying amount of an item of fixed assets the cost of replacing part of such an item when that cost is incurred, if the replacement part is expected to provide incremental future benefits to the Group. The carrying amount of the replaced part is derecognised. Repairs and maintenance are charged to profit or loss during the period in which they are incurred.

Depreciation is charged so as to allocate the cost of assets less their residual value over their estimated useful lives, using the straight-line method.

The assets' residual values, useful lives and depreciation methods are reviewed, and adjusted prospectively if appropriate, or if there is an indication of a significant change since the last reporting date.

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount and are recognised in profit or loss.

2.16 Revaluation of tangible fixed assets

Individual leasehold properties are carried at current year value or fair value at the date of the revaluation less any subsequent accumulated depreciation and subsequent accumulated impairment losses. Revaluations are undertaken with sufficient regularity to ensure the carrying amount does not differ materially from that which would be determined using fair value at the Statement of Financial Position date.

Fair values are determined from market based evidence normally undertaken by professionally qualified valuers.

Revaluation gains and losses are recognised in other comprehensive income unless losses exceed the previously recognised gains or reflect a clear consumption of economic benefits, in which case the excess losses are recognised in profit or loss.

2.17 Impairment of fixed assets and goodwill

Assets that are subject to depreciation or amortisation are assessed at each reporting date to determine whether there is any indication that the assets are impaired. Where there is any indication that an asset may be impaired, the carrying value of the asset (or cash-generating unit to which the asset has been allocated) is tested for impairment. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's (or CGU's) fair value less costs to sell and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash flows (CGUs). Non-financial assets that have been previously impaired are reviewed at each reporting date to assess whether there is any indication that the impairment losses recognised in prior periods may no longer exist or may have decreased.

2.18 Valuation of investments

Investments in subsidiaries are measured at cost less accumulated impairment.

2.19 Stocks

Stocks are stated at the lower of cost and net realisable value, being the estimated selling price less costs to complete and sell. Cost is based on the cost of purchase on a first in, first out basis. Work in progress and finished goods include labour and attributable overheads.

At each reporting date, stocks are assessed for impairment. If stock is impaired, the carrying amount is reduced to its selling price less costs to complete and sell. The impairment loss is recognised immediately in profit or loss.

2.20 Debtors

Short term debtors are measured at transaction price, less any impairment. Loans receivable are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method, less any impairment.

2.21 Cash and cash equivalents

Cash is represented by cash in hand and deposits with financial institutions repayable without penalty on notice of not more than 24 hours.

Cash equivalents are highly liquid investments that mature in no more than three months from the date of acquisition and that are readily convertible to known amounts of cash with insignificant risk of change in value.

2.22 Creditors

Short term creditors are measured at the transaction price. Other financial liabilities, including bank loans, are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method.

2.23 Provisions for liabilities

Provisions are made where an event has taken place that gives the Group a legal or constructive obligation that probably requires settlement by a transfer of economic benefit, and a reliable estimate can be made of the amount of the obligation.

Provisions are charged as an expense to profit or loss in the year that the Group becomes aware of the obligation, and are measured at the best estimate at the Statement of Financial Position date of the expenditure required to settle the obligation, taking into account relevant risks and uncertainties.

When payments are eventually made, they are charged to the provision carried in the Statement of Financial Position.

2.24 Financial instruments

The Group only enters into basic financial instrument transactions that result in the recognition of financial assets and liabilities like trade and other debtors and creditors, loans from banks and other third parties, loans to related parties and investments in ordinary shares.

Debt instruments (other than those wholly repayable or receivable within one year), including loans and other accounts receivable and payable, are initially measured at present value of the future cash flows and subsequently at amortised cost using the effective interest method. Debt instruments that are payable or receivable within one year, typically trade debtors and creditors, are measured, initially and subsequently, at the undiscounted amount of the cash or other consideration expected to be paid or received. However, if the arrangements of a short-term instrument constitute a financing transaction, like the payment of a trade debt deferred beyond normal business terms or in case of an out-right short-term loan that is not at market rate, the financial asset or liability is measured, initially at the present value of future cash flows discounted at a market rate of interest for a similar debt instrument and subsequently at amortised cost, unless it qualifies as a loan from a director in the case of a small company, or a public benefit entity concessionary loan.

Financial assets that are measured at cost and amortised cost are assessed at the end of each reporting period for objective evidence of impairment. If objective evidence of impairment is found, an impairment loss is recognised in the Consolidated Statement of Comprehensive Income.

For financial assets measured at amortised cost, the impairment loss is measured as the difference between an asset's carrying amount and the present value of estimated cash flows discounted at the asset's original effective interest rate. If a financial asset has a variable interest rate, the discount rate for measuring any impairment loss is the current effective interest rate determined under the contract.

For financial assets measured at cost less impairment, the impairment loss is measured as the difference between an asset's carrying amount and best estimate of the recoverable amount, which is an approximation of the amount that the Group would receive for the asset if it were to be sold at the reporting date.

Financial assets and liabilities are offset and the net amount reported in the Statement of Financial Position when there is an enforceable right to set off the recognised amounts and there is an intention to settle on a net basis or to realise the asset and settle the liability simultaneously.

3. Judgements in applying accounting policies and key sources of estimation uncertainty

In preparing the financial statements, management is required to make estimates and assumptions which affect reported income, expenses, assets, liabilities and disclosure of contingent assets and liabilities. Use of available information and application of judgement are inherent in the formation of estimates, together with past experience and expectations of future events that are believed to be reasonable under the circumstances. Actual results in the future could differ from such estimates.

The directors consider the following areas to involve considerable degree of estimation uncertainty:

Recoverable amount of non-current assets

All non-current assets, including property, plant and equipment and intangible assets, are reviewed for potential impairment using estimates of the future economic benefits attributable to them. Such estimates involve assumptions in relation to future ticket income, media and sponsorship revenue and on-pitch performance. Any estimates of future economic benefits made in relation to non-current assets may differ from the benefits that ultimately arise, and materially affect the recoverable value of the asset.

In respect of an ongoing contractual dispute with another football club that arose in January 2019, the Club has lodged an appeal with the Court of Arbitration for Sport ("CAS") against an earlier ruling by FIFA.

Although the Directors, after taking legal advice, are of the opinion that the appeal has good prospects of success and will achieve a favourable outcome, no decision has yet been made by CAS. Due to the uncertainty involved, the Directors have included adequate provision in these accounts should their appeal be unsuccessful.

26. Pension commitments

The Group operates a defined contributions pension scheme. The assets of the scheme are held separately from those of the Group in an independently administered fund. The pension cost charge represents contributions payable by the Group to the fund and amounted to £169,000 (2020: £151,000). In addition to the remuneration detailed in note 9, a further £1,340,000 (2020: £1,578,000) was paid to other key management personnel in respect of short term employee benefits.

29. Post balance sheet events

Subsequent to the year end and prior to the signing of these financial statements, the Group has acquired player registrations totalling £893,000 of which £Nil is contingent upon one or more future events. These have been funded by additional shareholder loans.

Subsequent to the year end and at the time of the signing of these financial statements, the Group has received funding of £22,100,000 on interest rates of up to 9% per annum. Loans of £3,100,000 have been repaid.

Subsequent to the year end and following approval by the shareholders of the requisite written resolutions, the Company created a new class of shares being A Ordinary Shares of £0.01 nominal value. The new shares rank pari passu in all respects with and having the same rights attaching to them as the existing class as Ordinary shares of £0.10p nominal value.

On 31 January 2022, the Company issued an open offer to qualifying shareholders, being those holding more than 100,000 10p Ordinary Shares, to apply for 5 new A Ordinary Shares for every 7 existing Ordinary 10p shares held.

The majority shareholder, Tan Sri Vincent Tan, subsequently subscribed to the offer and the Company has issued 664,152,867 A Ordinary Shares 1p shares under the open offer. Tan Sri Vincent Tan having converted £6,641,528 of his existing shareholder loans into Equity in payment for such shares as have been issued.

At the date of signing of these accounts the Open Offer has closed and no other qualifying shareholders have exercised their right to subscribe for the new shares.

30. Controlling party

The ultimate controlling party is considered to be Tan Sri Dato' Seri Vincent Tan Chee Yioun due to his majority shareholding in Cardiff City Football Club (Holdings) Limited.
