Supplemental Debenture (the "2009-1 Supplemental Debenture") dated 8 September 2009 and made between (1) Unique Pub Properties Limited ("UPP"), (2) Unique Pub Properties Alpha Limited, Unique Pub Properties Beta Limited, Unique Pub Properties Gamma Limited, Unique Pub Properties Theta Limited (each an "Additional Chargor", and together the "Additional Chargors"), (3) The Unique Pub Finance Company Plc (the "Issuer"), (4) HSBC Bank Plc (the "Class A1/A2 Hedge Provider"), (5) Citibank N.A. London Branch and Goldman Sachs International (each a "Class A2R Hedge Provider" and together the "Class A2R Hedge Providers"), (6) Enterprise Inns Plc (the "Cash Manager"), (7) Enterprise Inns Plc (the "Asset Manager"), (8) Enterprise Inns Plc (the "Supply Manager"), (9) National Westminster Bank Plc (the "Financial Guarantor"), (10) Unique Pubs Limited ("Unique"), and The Law Debenture Trust Corporation p.l.c. (the "Trustee").

NB: definitions relevant to this Form M395 are contained in Schedule 2 below.

SCHEDULE 1: Short particulars of all the property mortgaged or charged

1. Fixed Security

1.1 UPP, as security for the payment of all the Secured Liabilities, has charged in favour of the Trustee, on trust for itself and the other Unique Secured Parties:

- (i) by way of first legal mortgage all its estate or interest in the property specified in Part 1 of Schedule 3 below;
- (ii) by way of a first equitable mortgage, such right, title and interest as it may have in the beneficial interest in the property specified in Part 2 of Schedule 3 below;
- (iii) by way of a first fixed charge, all plant and machinery owned by UPP and its interest in any plant or machinery in its possession.

1.2 On the instruction of UPP given in the 2009-1 Supplemental Debenture, each Additional Chargor, as security for the payment of all the Secured Liabilities, has charged in favour of the Trustee, on trust for itself and the other Unique Secured Parties, by way of first legal mortgage all its estate or interest in the property specified in the table beneath its name in Part 2 of Schedule 3 below.

2. Assignment

2.1 UPP, as security for the payment of all the Secured Liabilities, has assigned to the Trustee, on trust for itself and the other Unique Secured Parties, by way of first ranking security all of its right, title, benefit and interest, present and future, in, to and under:

- (i) all Rental Income;
- (ii) any guarantee of Rental Income contained in or relating to any Lease;
- (iii) all moneys derived from the supply of Beer and Non-Beer Products to Tenants of any property specified in Schedule 3 below; and
- (iv) all Coin Income derived from the property specified in Schedule 3 below.

3. Security created under the Original Debenture, Supplemental Debenture, Second Supplemental Debenture, Third Supplemental Debenture, Fourth Supplemental Debenture and Fifth Supplemental Debenture and Fourth Issue Supplemental Debenture

3.1 The parties to the 2009-1 Supplemental Debenture have agreed, subject to Clause 4.2 of the 2009-1 Supplemental Debenture (as set out in paragraph 3.2 below), that all of the obligations, undertakings, covenants, rights and powers specified and contained in the Original Debenture, the Supplemental Debenture, the Second Supplemental Debenture, the Third Supplemental Debenture, the Fourth Supplemental Debenture, the Fifth Supplemental Debenture and the Fourth Issue Supplemental Debenture other than:

- (i) the covenants of, and the creation of security by, UPP contained in clauses 2 and 3 of the Original Debenture, clause 2 of the Supplemental Debenture, clause 3 of the Second Supplemental Debenture, clause 3 of the Third Supplemental Debenture, clause 3 of the Fourth Supplemental Debenture, clause 3 of the Fifth Supplemental Debenture and clause 3 of the Fourth Issue Supplemental Debenture;
- (ii) for the avoidance of doubt, any obligations, undertakings, covenants, rights and powers specified and contained in the Original Debenture, the Supplemental Debenture, the Second Supplemental Debenture, the Third Supplemental Debenture, the Fourth Supplemental Debenture, the Fifth Supplemental Debenture or the Fourth Issue Supplemental Debenture in favour of SupplyLine Services Limited as Beer Supplier;
- (iii) for the avoidance of doubt, any obligations, undertakings, covenants, rights and powers specified and contained in the Original Debenture, the Supplemental Debenture, the Second Supplemental Debenture, the Third Supplemental Debenture, the Fourth Supplemental Debenture, the Fifth Supplemental Debenture or the Fourth Issue Supplemental Debenture in favour of Thame Pub Management Limited as Cash Manager; and
- (iv) for the avoidance of doubt, any obligations, undertakings, covenants, rights and powers specified and contained in the Original Debenture, the Supplemental Debenture, the Second Supplemental Debenture, the Third Supplemental Debenture, the Fourth Supplemental Debenture, the Fifth Supplemental Debenture or the Fourth Issue Supplemental Debenture in favour of RetailLink Management Limited as Asset Manager,

are (as supplemented and amended by the 2009-1 Supplemental Debenture) deemed to be repeated in the 2009-1 Supplemental Debenture *mutatis mutandis* and apply *mutatis mutandis* to the obligation referred to in Clause 2 of the 2009-1 Supplemental Debenture and the security and other rights and powers created under and pursuant to the 2009-1 Supplemental Debenture (including, for the avoidance of doubt, the security created by the Additional Chargors) and the assets of UPP and the Additional Chargors which are subject to such security.

The parties to the 2009-1 Supplemental Debenture have further agreed that all of the remaining terms of the Original Debenture, the Supplemental Debenture, the Second Supplemental Debenture, the Third Supplemental Debenture, the Fourth Supplemental Debenture, the Fifth Supplemental Debenture and the Fourth Issue Supplemental Debenture shall, except in so far as they are inconsistent with the terms of the 2009-1 Supplemental Debenture, apply *mutatis mutandis* to the 2009-1 Supplemental Debenture and the security created under or pursuant to the 2009-1 Supplemental Debenture (including, for the avoidance of doubt, the security created by the Additional Chargors) and the assets of UPP and the Additional Chargors which are subject to such security provided always that the 2009-1 Supplemental Debenture shall be without prejudice to the Original Debenture, the Supplemental Debenture, the Second Supplemental Debenture, the Third Supplemental Debenture, the Fourth Supplemental Debenture, the Fifth Supplemental Debenture and the Fourth Issue Supplemental Debenture, the security and other rights and powers created under and pursuant to clauses 2 and 3 of the Original Debenture, clause 2 of the Supplemental Debenture, clauses 3 and 5.1(b) of the Second Supplemental Debenture, clause 3 of the Third Supplemental Debenture, clause 3 of the Fourth Supplemental Debenture, clause 3 of the Fifth Supplemental Debenture and clause 3 of the Fourth Issue Supplemental Debenture and all of the other rights, powers, obligations and immunities comprised therein and arising pursuant thereto, which shall remain in full force and effect notwithstanding the 2009-1 Supplemental Debenture.

3.2 No Effect on Existing Charges

For the avoidance of doubt, Clause 4.1 of the 2009-1 Supplemental Debenture (as set out in paragraph 3.1 above) shall not be construed as any release or memorandum of satisfaction in whole or in part of the security created pursuant to clauses 2 and 3 of the Original Debenture, clause 2 of the Supplemental Debenture, clauses 3 or 5.1(b) of the Second Supplemental Debenture, clause 3 of the Second

Supplemental Debenture, clause 3 of the Fourth Supplemental Debenture, clause 3 of the Fifth Supplemental Debenture or clause 3 of the Fourth Issue Supplemental Debenture.

3.3 Revised References

Any reference in the Original Debenture, the Supplemental Debenture, the Second Supplemental Debenture, the Third Supplemental Debenture, the Fourth Supplemental Debenture, the Fifth Supplemental Debenture and the Fourth Issue Supplemental Debenture to the "Master Definitions Agreement" shall be read as a reference to the Original Master Definitions Agreement as supplemented, amended and restated by the Supplemental Master Definitions Agreement, each as supplemented, amended and restated by the Second Supplemental Master Definitions Agreement and each as further supplemented amended and restated by the Third Supplemental Master Definitions Agreement.
