- 1 Pursuant to rule 7 10B(2) of the Insolvency Rules 1986 (**Rules**) Iain Townsend be removed from office in respect of each of the cases listed in the Schedule hereto from the date of this order
- 2 Pursuant to rule 7 10B(3) of the Rules Andrew Little be appointed as joint replacement office-holder in place of Iain Townsend in respect of each of the cases listed in the Schedule hereto from the date of this order
- 3 The cases listed in the Schedule hereto be transferred to the High Court for the purpose of this application only and forthwith after the making of this order be transferred back to the County Court from which they came

- 4 The provisions contained in rules 2 47(3A) and 4 49C-CVL(3)(a) of the Rules do not apply in this case and Iain Townsend shall not be required to produce any progress reports on ceasing to act as office holder pursuant to the block transfer order sought The period for the provision of progress reports remains the same as the original date in place prior to the block transfer taking effect
- 5 Where required any relevant notice required to be filed at Court be filed at the same time as the next notification as required pursuant to statute
- 6 The appointments made pursuant to this application shall be notified to creditors at the same time as the next report pursuant to statute is made to the creditors
- 7 The replacement office holder shall as soon as reasonably practicable and in any event within 14 days of receipt of the sealed Order
- 7 1 publish an advertisement in the London Gazette relating to all new appointments which are required by law to be published in the London Gazette,
- 7 2 file with the Registrar of Companies any notices in respect of Iain Townsend's removal and replacement which are required by law to be so filed,
- 7 3 notify the Secretary of State of the making of the Order
- 8 Iain Townsend be granted his release or discharge from all liability as appropriate 21 days after the publication in the London Gazette and/or the filing with the Registrar of Companies and/or notification to the Secretary of State as necessary as required by paragraph 7 above, without being required to apply for his/her release or file a receipts and payment account
- 9 Pursuant to rules 2 109B (Administrations) and 4 131B (Liquidations) any determination, resolution or court order in effect immediately before the former office holder ceases to hold office shall continue to apply in respect of the remuneration of the replacement office holder
- 10 The costs of making this application (not to exceed £200 per case) be apportioned equally amongst the cases listed in the Schedule hereto and that the pro rata share of the costs of this application be payable as an expense of the relevant insolvency proceedings
