



ORDER

UPON the Application of Colin Anthony Sefton ("the Applicant") by notice of
application dated 23rd February 2009.

AND UPON hearing counsel on behalf of the Applicant (the Respondents having neither
appeared nor been represented but having consented in writing to the relief hereinafter
granted)

AND UPON reading the documents recorded upon the court file as having been read

IT IS ORDERED that:

1. In respect of the compulsory liquidations, creditors' voluntary liquidations and bankruptcies identified in the schedule to the said notice of application and annexed hereto as being the subject of proceedings in any court other than the High Court, those proceedings be transferred to the Chancery Division of the High Court solely for the purpose of making the orders contained in paragraphs 2 to 6 below;
2. The Applicant be removed from office as liquidator or trustee in bankruptcy (as the case may be) of the compulsory liquidations, creditors' voluntary liquidations and bankruptcies listed in the said schedule;
3. The Respondents be appointed jointly as office holders in the Applicant's place in respect of the compulsory liquidations, creditors' voluntary liquidations and bankruptcies listed in the said schedule;
4. All appointments made herein be advertised in the London Gazette and such advertisements shall constitute sufficient notice to all creditors;
5. Liberty to each creditor of each compulsory and voluntary liquidation and bankruptcy to apply to vary or discharge this order within 21 days of receipt of the notice directed to be given under paragraph 4 above;
- 6 The costs of this application (including VAT) be aggregated and apportioned equally between each of the compulsory and creditors' voluntary liquidations and bankruptcies listed in the said schedule, provided that:
 - 6.1 if the costs which fall to be borne by any of the estates exceed 10% of the realisable assets within that estate
 - 6.2 that estate shall only bear part of those apportioned costs, that part being an amount equal to 10% of that estate's readily available assets; and
 - 6.3 the excess shall then be apportioned and borne equally between the other estates.
