

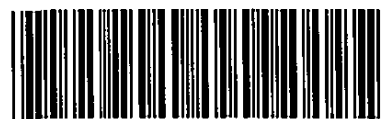


**Audit Exemption Statement**
