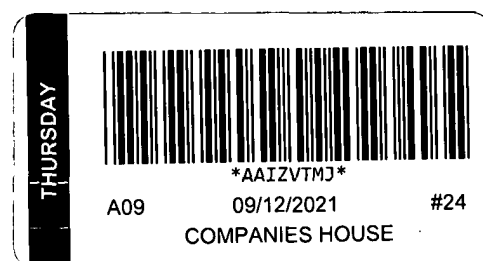

**Report of the Directors for the Year ended 31<sup>st</sup> March 2021**

The Directors, who are also the Charity Trustees, present their report with the financial statements of the company for the year ended 31<sup>st</sup> March 2021.

**Principal Activity**

The principal activity of the company in the year under review was the provision of a Collection of objects and records representing the history of the businesses and people of the London Borough of Harrow. The Collection is used to advance the education of the public about the London Borough of Harrow and the surrounding area.

The Collection is situated in Harrow at Headstone Manor and Museum. Parts of the Collection are on display from time to time in the Museum, which is open to the public during the year at published times.

In the year ended 31<sup>st</sup> March 2016, the Trust concluded an agreement with the Mayor and Burgesses of the London Borough of Harrow whereby the London Borough of Harrow will continue to care for and to manage the Collection owned by the Trust for a period of twenty-five years. A period of twenty years remained at 31<sup>st</sup> March 2021.

The Collection is not valued in the financial statements as there is no current intention to dispose of any of its contents. In the event of the Trust wishing to dispose of the Collection, or any part thereof, within the remaining period of the above agreement, it shall in the first instance be offered to Harrow Council by way of gift or sale.




