

**LIQUIDATORS' PROGRESS REPORT PURSUANT TO SECTION 92A OF THE INSOLVENCY ACT 1986 AND RULE 18.3 OF THE INSOLVENCY (ENGLAND AND WALES) RULES 2016**

Further to my appointment as Joint Liquidator on 19 December 2019 I report on the progress of the liquidation for the period 19 December 2019 to 18 December 2020 ("the period").

I attach:

- Appendix A – Receipts and payments account for the period and cumulative
- Appendix B – Liquidators disbursements incurred in the period
- Appendix C – Statement of expenses incurred in the period

**1. Progress of the Liquidation**

I summarise below details of work undertaken during the period of this report together with a summary of work still to be completed.

Work undertaken during the period:

- Filing notice of the Liquidators' appointment with the Registrar of Companies;
- Advertising notice of the Liquidators' appointment in the London Gazette, as required by statute;
- Obtaining a bond to cover the value of the assets in the estate;
- Liaising with the Company's former accountants to obtain information and assist with tax matters;
- Writing to HMRC to request formal tax clearance to close the liquidation;
- Obtaining final tax clearance from HMRC.

Attached at **Appendix A** is a receipts and payments account detailing both transactions for the period of this report and also cumulatively since my appointment as Liquidator.

A number of transactions have taken place, but which are not represented on the receipts and payment account and can be summarised as follows:

- Book debts totalling £15,791.92 due from an associated company, Alkane Energy UK Limited, have been assigned to the sole shareholder of the Company, Alkane Energy Limited.
- Liquidator's fees of £4,000 plus VAT have been settled by funds held by an associated company Blackborough End Energy Limited (In Liquidation) at the instructions of the Ultimate Beneficiary Owners of the group.

I can confirm the liquidation can now be closed and my draft final report will be issued to shareholders simultaneously with this report.

## **2. Dividends to Creditors**

### ***Preferential Creditors***

There are no preferential creditors in this matter.

### ***Unsecured creditors***

Notice for creditors to submit their claims in the liquidation was advertised in the London Gazette and no claims were received.

There are no unsecured creditors in this matter.

## **3. Distribution to Shareholders**

No funds have been distributed to the shareholder.

## **4. Liquidator's Remuneration, Disbursements and Expenses**

The members passed a resolution that the Joint Liquidators' remuneration should be calculated on a fixed fee basis of £4,000 plus VAT. The amount of fees drawn in this period is £4,000 exclusive of VAT, and the total remuneration drawn to date is £4,000. No further fees are to be drawn. As agreed with the shareholder, the fees have been settled by funds held in an associated Company, Blackborough End Energy Limited (In Liquidation).

The Joint Liquidators' time costs are based on computerised records of all time spent on the administration of this case. Matters dealt with during the assignment are dealt with by different members of staff depending on the level of complexity and experience required. Time is charged to the case in maximum of 6 minute units. Charge-out rates are based on individual expertise, qualification and grade. The costs of the firm's support staff are not directly charged to the estate unless dealing with directly identifiable case specific matters. Charge out rates are reviewed at least annually, details of FRP Advisory Trading Limited charge out rates are attached together with a breakdown of our time costs and disbursement incurred during the period of this report, in accordance with Statement of Insolvency Practice 9.

The Joint Liquidator's disbursements are a recharge of actual costs incurred by the Liquidator in dealing with this matter. Mileage payments made for expenses relating to the use of private vehicles for business travel, which is directly attributable to the insolvency estate, are paid by FRP Advisory Trading Limited at the HMRC approved mileage rate prevailing at the time the mileage was incurred. Details of disbursements incurred during the period of this report are set out in **Appendix B**.

I also attach at **Appendix C** a statement of expenses that have been incurred during the period covered by this report. It is currently expected that the expenses incurred or anticipated to be incurred are not likely to exceed the details provided prior to the determination of the basis of the Liquidators' remuneration.

When instructing third parties to provide specialist advice and services, or having the specialist services provided by the firm, the Joint Liquidator is obligated to ensure that such advice or work is warranted and that the advice or work contracted reflects the best value and service for the work being undertaken. This is reviewed by the Joint Liquidator periodically throughout the duration of the assignment. The specialists chosen may regularly be used by the Joint Liquidator and usually have knowledge specific to the insolvency industry and, where relevant, to matters specific to this insolvency appointment.

Shareholders have a right to request further information from the Liquidator and further have a right to challenge the Joint Liquidator's remuneration and other expenses, which are first disclosed in this report, under the Insolvency (England and Wales) Rules. (For ease of reference these are the expenses incurred in the reporting period as set out in **Appendix B** only). Further details of these rights can be found in the Creditors' Guide to Fees which you can access using the following link <https://creditors.frapadvisory.com/info.aspx> and select the one for liquidation. Alternatively, a hard copy of the relevant guide will be sent to you on request. Please note there is a time limit for requesting information being 21 days following the receipt of this progress report. There is a time limit of 8 weeks following the receipt of this report for a Court application that the remuneration or expenses are excessive.
